# From the President ATLA Board Responsibilities and Duties



In recent weeks, I have been talking with some of my colleagues at Columbia University and about what an ATLA board member does and does not do. In the course of my conversations, I first highlight the differences between strategic and operational thinking. On the one hand, strategic thinking is characterized by a longer time frame (e.g., five to ten years) than operational thinking (e.g., one to two years). In addition, strategic

thinking is driven by the vision of an association, whereas operational thinking is driven by the strategic plan and ongoing operations of an association. In general, leadership, including the board, is accountable for strategic thinking, whereas staff and volunteer groups (e.g., ATLA committees and interest groups) are accountable for operations.

ATLA board members play three key roles within our association: (1) setting organizational direction, (2) ensuring necessary resources, and (3) providing oversight. Setting organizational direction includes the following: engaging in strategic thinking and planning, setting the association's mission and vision for the future, and establishing organizational values. Ensuring resources includes the following: hiring capable executive leadership, ensuring adequate financial resources, promoting a positive public image, and ensuring the presence of a capable and responsible board. Providing oversight includes the following: overseeing financial management, minimizing exposure to risk, measuring progress on the strategic plan, providing legal and moral oversight, and evaluating the executive director and board.

In addition to these roles, the board has three main duties, which are on the Nominating Committee's webpage: (1) a duty of care, (2) a duty of loyalty, and (3) a duty of obedience. Our duty of care requires that we be reasonably informed about the organization's activities, participate in decision-making, and act in good faith and with the care of an ordinarily prudent person in comparable circumstances. Our duty of loyalty requires us to exercise our power in the interest of our association and not in our own personal interests or the interest of another entity. Our duty of obedience requires that we comply with applicable federal, state and local laws, adhere to our association's governing documents, and remain guardians of our association's mission.

As you can see, board members have a lot of duties and responsibilities. It is hard but rewarding work. We welcome <u>your feedback</u> on our performance. As Board President, I have taken these duties and responsibilities very seriously and have tried to act in the best interest of you, our members, and our association. Please rest assured; ATLA staff and members also have duties and responsibilities. I will talk more about those in next month's column and during our annual conference in Denver.

## **Professional Development**

The Professional Development Committee (PDC) works to determine and plan for professional development needs of members outside the annual conference. Most often our work involves providing Grants for Continuing Education programs. These can be grants to regional groups associated with ATLA like Florida Theological Library Association or Chicago Area Theological Library Association or to individual Institutional members who want to plan some type of continuing education programing. A number of regional groups ask for some funding from the PDC for their meetings.

Some of the programs in the past: Southeastern Pennsylvania Theological Library Association, "Library Excellence in Online Theological Education," and Minnesota Theological Library Association, "Serials Management in a Changing Environment."

The PDC asks those receiving grants to report on the program and this information is sometimes made available on the ATLA website. This year the committee worked on a new application and reporting form which include goals and learning objectives for the proposed sessions. Check out the website for details and the application. We encourage regional groups who have not requested funds in the past and institutional members to think about applying for grants to support their programs.

The PDC also works with the <u>Creating Leaders for Tomorrow program</u>. We evaluate the program as well as review the applications and select who participate in the program. This year Creating Leaders for Tomorrow is being offered for the second time. This cohort will finish their work at annual conference in June. PDC will again evaluate the program and make a recommendation as to when to start a new cohort.

PDC continues to look for new ways to provide other opportunities for professional development outside the conference. With this in mind, ATLA staff and the PDC are investigating and testing technologies to make sessions from the conference or other regional meetings available via live stream or video on demand in order to allow more members to be able to access this valuable content.

# ATLA / OCLC Consortium for WorldCat Discovery (formerly OCLC FirstSearch)

WorldCat Discovery Services will replace the OCLC FirstSearch service in December 2015. All libraries that provide access to the



WorldCat database on FirstSearch can use WorldCat Discovery now as a part of their existing subscriptions. FirstSearch and WorldCat Discovery will operate in parallel through December 2015, to provide time for library staffs to become familiar with the new service before access to FirstSearch ends December 31, 2015.

## Saint Charles Borromeo Seminary News



## From the Executive Director



# The 7th ForATL Workshop and Consultation

Earlier this month I had the privilege of attending the 7th Forum of Asian Theological Librarians (ForATL). This year's meeting was held in Bangkok, Thailand, May 1-4, and the theme was "Speed of Change: Asian Theological Librarians in Rapid Transition." Representatives from India, Indonesia, Myanmar, Philippines, and Thailand attended. Mrs. Elizabeth T. Pulanco convened the group.

The ForATL group was originally formed in 1991 following the consultation of Asian theological librarians held in Chiang Mai, Thailand, under the sponsorship of the Programme for Theology and Cultures in Asia (PTCA). Since then ForATL has met every several years in various cities. One of the primary goals of the group is to continually learn from and update each other regarding the new trends and changes going on in libraries and archives in Asia.

Dr. Wati Longchar from PTCA provided the keynote address, and representatives from each country gave an overview and update on their activities. Dr. Robert Batzinger, Director of IT and Communications Services at Payap University in Chiang Mai, Thailand, provided an overview of trends in technology that are impacting higher education.

One of the most exciting developments since the last ForATL meeting is the creation of a new Theological Librarianship Degree program hosted by the Central Philippine University, Iloilo City, Philippines. The first cohort of 12 students is enrolled in this two-year block program and several students were able to participate in the ForATL event.

The group took time out from discussing theological librarianship to tour the Thailand Knowledge Park Library (referred to "TKpark") housed in the CenterWorld Mall. This inviting state of the art library is located on the 8th floor of an enormous mall. Visitors from outside

Bangkok can obtain a day pass to browse materials, attend events in its theatre, and make use of the music library.

The group talked about various ways to encourage others to attend future meetings and how to raise funds to support participation. After the official adjournment, I met with several of the organizers to talk about potential collaboration between ForATL and ATLA. The next ForATL meeting is tentatively planned for Jakarta, Indonesia, in 2017.
