From the President Creating a Firm Foundation

Currently, a Board committee is working to refocus and update ATLA's Organizational Ends. This review process is necessary to keep the Organizational Ends in sync with ATLA's new core purpose and values. When the Board discusses these foundational

documents, each word is examined. In our current Organizational Ends, one statement contains the word advocacy. Here is the wording:

1.2.1 Librarians are effective advocates for their libraries and for the profession.

Advocacy is defined as the "the act or process of advocating or supporting a cause or proposal" according to the Merriam Webster Dictionary. As I looked at the definition and was not satisfied, I went to the student edition of the Merriam Webster Dictionary, which provides five different definitions. These five definitions helped me to relate to the concept within a theological librarian context and perspective.

One definition is "to endure bravely or quietly." Now I can relate to that definition. Sometimes I am brave when speaking up to support the library and my profession. At other times, my silence is a form of advocacy. The second definition contains three phrases "to promote the interests or cause of," "to uphold or defend as true or right," and "to provide evidence for." During much of my career as theological librarian, I knew that upholding and defending the library is true and right. Yet through the years, I have learned that I am a better advocate when I provide evidence or data to support the library and the profession. The third definition of advocacy, "to pay the costs of" dovetails into the second definition. Sometimes, we pay the costs of advocating for the library and for our profession. At other times, we

From Staff Leadership What It Means to Be a Hub

Last year the ATLA Board established a long term vision for the association: "ATLA is the hub of worldwide scholarly communication in theology and religion." Different people may have different understandings of what a "hub" really is. Because of this ambiguity, one of the strategic

priorities for the next several years is "Hub Capacity," and more specifically, "to create a shared understanding of what it means to be a hub."

Cambridge Dictionaries Online defines "hub" in various ways, including the central or main part of something where there is the most activity. Synonyms may include center, heart, focal point, or nerve center. In our technology-centric world, hub may automatically bring to mind the center of a physical communications network.

But in the context of ATLA's vision, a hub could support many different kinds of activities simultaneously such as:

- Provide resources like the *ATLA Religion Database*® and *ATLASerials*® that students and scholars use to identify relevant resources and get connected to them online.
- Connect people physically to the right resources, such as through member institutions' collections or through the ATLA Reciprocal Borrowing Program.
- Facilitate collaboration between multiple organizations with similar interests, both in North America and throughout the world.
- Connect members to one another as well as to others in related fields.
- Create a venue for the exchange of ideas through inperson conferences and symposia or virtual community centers.
- Connect people to jobs and help institutions find the right employees by posting open positions.
- Publish original scholarship from theological librarians, scholars, and others.
- Support a digital repository that contains metadata from ATLA member libraries and the archives and collections of other libraries and institutions.

are successful advocates when we promote the library's interests and provide evidence, and the institution pays the costs of having theological librarians and the library. The fourth definition is "to hold up or in position or serve as a foundation or prop for." I can definitely argue or advocate that theological librarians and libraries serve a foundational place within institutions and need to be supported. In making these statements in both brave and quiet ways, I am advocating for the library and for the profession. The final definition is "to keep something going or sustain." Theological libraries and libraries are masters at this definition of advocacy. Many times we keep going and going without sufficient funding or institutional support.

As you reflect about advocacy, I challenge you to consider how you are an advocate in many ways of which you might not have been aware.

An Introduction to BIBFRAME, Linked Data, RDF, or the Semantic Web

Have you heard of BIBFRAME, Linked Data, RDF, or the Semantic Web? The Linked Data and BIBFRAME Pre-Conference Workshop (<u>https://atla2016.sched.org/</u> <u>event/6ONz/bibframe-and-linked-data-50-per-person</u>) at the 2016 ATLA Annual Conference provides an in-depth introduction to the core concepts of the semantic web and library linked data focusing on the Library of Congress BIBFRAME 2.0 vocabulary for replacing MARC in future library systems.

Participants will first learn about the difference between MARC records and RDF graphs that are made up of statements called triples and how rich bibliographic relationships can be modeled between Works, Instances, and Items using the BIBFRAME 2.0 vocabulary. We also look at the changes between BIBFRAME 1.0 and 2.0 vocabularies and how BIBFRAME compares to other Library Linked Data standards like Schema.org's (http://schema.org/) bibex schema. Library and Linked Data in general offer libraries great opportunities to expand access and capture knowledge about their collections that is tailored to the scholarly, theological, and general communities served by ATLA libraries.

After acquiring a theoretical base in Library Linked Data, participants will then be offered a chance to convert a sample of their MARC records to BIBFRAME RDF graphs that can then be displayed and manipulated through cloudbased BIBCAT 2.0 instances. BIBCAT is one of the first native BIBFRAME Linked-Data library catalogs and began as the result of a collaboration between Jeremy Nelson and the Library of Congress and continues as an open-source offering from KnowledgeLinks.io (http://knowledgelinks.io/). Participants will then be able to create new BIBFRAME Linked-Data entities and see how to BIBFRAME could work for them. Participants will be issued an Open Badge (http:// openbadges.org/) for attending this workshop.

The Getty Museum

The Getty Museum is well known for its architecture, gardens, and views overlooking Los Angeles. The museum features pre-20th-century European paintings, drawings, illuminated manuscripts, sculpture, and decorative arts; and 19th- and 20th-century American, Asian, and European photographs.

A must-see exhibit is *Traversing the Globe through Illuminated Manuscripts*:

This exhibition features illuminated manuscripts and painted book arts from the 9th through the 17th century that bring to life in stunning ways the real and imagined places that one encounters on their pages. These highly prized objects allow us to glimpse, admire, and study a world gone by, as well as its peoples, different belief systems, and an interconnected global history of human thought and ideas about art.

Spend the day at the Getty Museum and enjoy art, architecture, and gardens. Participants will arrive in the morning and should plan on bringing food or eating at one of the cafes for lunch.

The Getty Research Institute Library

This excursion includes a 60-90 minute tour of the Getty Research Institute Library. The library collections include over one million books, periodicals, study photographs, and auction catalogs as well as extensive special collections of rare and unique materials.

A must-see exhibit is the Cave Temples of Dunhuang: Buddhist Art on China's Silk Road:

The Mogao caves, located near the town of Dunhuang in the Gobi Desert of northwest China, comprise some 500 decorated Buddhist cave temples dating from the 4th to the 14th century. Filled with exquisite wall paintings and sculptures, the caves bear witness to the intense religious, artistic, and cultural exchanges along the Silk Road, the trade routes linking East and West. Cave Temples of Dunhuang: Buddhist Art on China's Silk Road features numerous objects originally from the site — such as paintings and manuscripts that have rarely, if ever, traveled to the United States, as well as three spectacular full-size cave replicas.

After the tour, participants are free to have lunch and explore the rest of the Getty facilities (including the museum) and grounds.

Bobby Smiley is the Digital Scholarship and American History Librarian at the Michigan State University Libraries. He received his library science degree and a certificate in digital humanities from the Pratt Institute, his M.A. in Religion from Yale, and an undergraduate degree from the University of Wisconsin—Madison. At MSUL, Bobby collaborates on grant funded digital projects (such as the Mellon funded Religious Soundmap of the Global Midwest project), works with campus partners to coordinate training and instruction for digital humanities workshops and symposia, helps build the library's collection of humanities Data, liaises with the History department, and teaches in the Religious Studies department. Philippine Theological Library Association Holds 20th Consultation and Workshop

The Philippine Theological Library Association held its 20th Workshop and Consultation at the Adventist International Institute of Advanced Studies (AIIAS) in Cavite, Philippines, on April 20-23. The theme of the meeting was "Speed of Change – Philippine Theological Librarians in Rapid Transition."

This event was designed to strengthen participation among Philippine theological librarians, develop their technical knowledge, learn about their needs and experiences in the context of the changing economic, social, and technology landscape, and to look for areas of potential collaboration. Representatives from 15 different institutions attended.

ATLA Executive Director Brenda Bailey-Hainer participated in the meeting, providing information about academic and theological library trends in North America and leading a discussion about opportunities for collaboration between ATLA and PTLA. The first cohort of 12 students from the Central Philippine University's MLIS program with a specialization in Theological Librarianship graduated earlier in April. Two of the graduates, Arnel Faller and Elven Jude Cabalinan, gave presentations on the research they completed as part of the program. Raquel Cruz reported on the first Philippine Librarians Summit and the proposed changes to the national librarian licensure examination and standards. Other presenters provided information on KOHA, RDA, and library security systems.

On the final day, new officers were elected: President, Arnel Faller (Siliman University); Vice-President, Megumi Flores (AIIAS); and Secretary, Lourdes Sangil (Don Bosco Center of Studies).

Florida Theological Library Association (FTLA) Annual Meeting Submitted by Michael Farrell, Library Director

The annual meeting of the Florida Theological Library Association (FTLA) was held on Thursday, March 10, 2016. Attendees were hosted by Wes Custer at Asbury Theological Seminary in Orlando, FL. Six people were in attendance, representing four Florida libraries.

The conference began with a lecture by Dr. Jeffrey Frymire, Associate Professor of Homiletics at Asbury Theological Seminary. Dr. Frymire gave a fascinating presentation on "Halakhah vs. Haggadah How We Interpret Scripture: The Roots of Homiletics."

We then heard from Michael Farrell, the current president of FTLA, on "The Seminary Library and Community Outreach." Michael shared ideas and pictures from events that Reformed Theological Seminary Library is engaged in to develop community.

Philip O'Neill then gave a presentation of the "Blended Learning Program at Barry University." After a break for lunch, Gillian Harrison Cain, Director of Member Programs for ATLA, spoke to us about ATLA's strategic plan, including the core purpose and core values of the association. A discussion of ATLA's goals, and how FTLA might be involved as a test case for future plans, was an encouragement to the group.

The conference concluded with the business meeting, led by Michael Farrell. Wes Custer was announced as the VP nominee, and Reformed Theological Seminary in Orlando was suggested as the location of the next annual FTLA meeting. Others in attendance were Carol Hayes, Assistant Librarian at Gordon-Conwell (Jacksonville), and Lisa Oharek, Assistant Librarian at Reformed Theological Seminary (Orlando). The afternoon ended with a tour of the Asbury facilities and library.

Passover Exhibit at Pitts Theology

Library

In 2016 the Pitts Theology Library offered Emory's first major exhibit of Haggadot: "Reading the Telling: The Passover Haggadah Across Time and Place." Curated by Adam T. Strater and running March 7 – June 30 (http://pitts.emory.edu/ exhibits/haggadah2016/index.cfm), it is open to the public at no charge and during regular library hours (http://pitts.emory. edu/about/hours.cfm).

Exhibit materials date from 1695 to the present and draw on collections from other libraries, museums, and collectors. Expertise and financial support from the Tam Institute for Jewish Studies (Emory) was essential, and one of the original donors of Haggadot to Pitts advised the library on publicity, resulting in articles published in *The Atlanta Jewish Times* (http://atlantajewishtimes.com/2016/03/haggadot-come-home-emory/), *The Jewish Georgian* (page 9) (http://jewishgeorgian.com/JGAMarApr16.pdf), and *The Jerusalem Post Magazine* (April 22, 2016).

Rebekah Bedard led the effort at Pitts, involved many other library staff, and arranged for the training of docents. Library staff filmed and edited six brief, instructional videos by the curator and Emory faculty (<u>http://pitts.emory.edu/exhibits/</u> <u>haggadah2016/video.cfm</u>) and produced an online version of the exhibit catalogue (<u>http://pitts.emory.edu/exhibits/</u> <u>haggadah2016/exhibitcatalog.cfm</u>). More than a thousand toured the exhibit during the first month, about 60 attended the opening lecture and reception, and many have offered Haggadot of their own to the growing Pitts collections.

Loras College Library, also referred to as the Academic Resource Center, contains a collection of approximately 355,000 items and 11,000 magazine subscriptions. In addition to its broad general collection, the library contains a rich heritage in its special collections of rare books, as well as the photographs and manuscripts in the Center for Dubuque History located in the lower level of the library. The library is also an official document depository for both the United States government and the state of Iowa. The previous library, Wahlert Memorial Library, was remodeled into classroom space.

OCLC has provided ATLA with quotes for renewing members of the ATLA / OCLC Consortium for WorldCat Discovery / FirstSearch and the ATLA Group Catalog for the 2016-2017 subscription year that runs from July 1, 2016 to June 30, 2017. Renewal pricing was sent to current consortia members in early May. This program is open to new members who are not already subscribing to these services through another consortium and provides discounted consortium pricing for WorldCat Discovery / FirstSearch and the ATLA Group Catalog.

In March 2016 OCLC announced that OCLC will continue to enhance WorldCat Discovery as well as deliver the fullfeatured WorldCat searching valued in FirstSearch in a new version of FirstSearch separate from WorldCat Discovery. Access to the current FirstSearch service will not end in 2016, but will continue into 2017.

At this time, libraries do not have to choose between the new version of FirstSearch or WorldCat Discovery, they simply need to renew or subscribe and details will be provided to indicate service preference sometime in future. Developing a Mutually-Enriching Library Volunteer Program

Rebekah Bedard, Reference Librarian and Outreach Coordinator, Pitts Theology Library Tuesday, May 3, 2:00 p.m. ET

As we seek to improve access to collections and better serve our communities, we often find our time and resources limited. One promising solution is to call upon volunteers. But what resources are there to aid us in doing so? The literature on library volunteers includes a longstanding debate on costs and benefits, and a public-library centric discussion of volunteer programs. There is a need for further research on how academic, and particularly theological, libraries can develop volunteer programs that will benefit both libraries and volunteers.

This webinar will address that gap by exploring the growth of a volunteer and docent program at Pitts Theology Library. To enhance access to special collections, Pitts Theology Library has found an opportunity for further volunteer involvement. Using this example as a case study, Rebekah Bedard, Reference Librarian and Outreach Coordinator at Pitts Theology Library will outline the steps a theological library can take to develop a fruitful volunteer program: (1) planning, (2) recruiting, (3) training, (4) supervising, (5) motivating, and (6) evaluating. We will then analyze the benefits of a volunteer program. Finally, we will explore resources that theological libraries large and small can use to develop their own mutually enriching volunteer programs.

Preparing for a Linked Data Future – The Importance of ATLA's NACO and CONSER Funnel Projects

As linked data becomes a reality, authority records will increase in importance since they will be the source for the record identification numbers that will replace the text strings in bibliographic records. Record identification numbers are critical because they provide an unchanging link between the authority record and the bibliographic record. Moving forward, a minimal authority record, consisting of the entry and the bibliographic citation on which it is based, may be created for every entry on a bibliographic record. NACO funnel members will play a critical role in this process since they would be the ones primarily responsible for identifying and enhancing these bare-bones authority records.

Join Judy Knop Member Programs Librarian at ATLA to learn about the NACO (Name Authority Cooperative Program) (http://www.loc.gov/aba/pcc/naco/) and CONSER (International Cooperative Serials Cataloging Program) (http://www.loc.gov/aba/pcc/conser/), both component parts of the Program for Cooperative Cataloging (PCC), and how they function. She will share information about the ATLA NACO and CONSER Funnel Project (https://www. atla.com/Members/development/Pages/NACO-CONSER-Funnel-Projects.aspx) and the requirements for membership, opportunities for training, and describe the review process for participants in these projects to create and modify name authority records in the Library of Congress Name Authority File (NACO) or master serial records in the OCLC database (CONSER). Joining Judy will be a long-time participant in the ATLA NACO Funnel, Richard Lammert, Technical Services and Systems Librarian, Concordia Theological Seminary, as well as Anna Appleman, Cataloger, Columbia Theological Seminary, a new participant, who will share their unique perspectives on the benefits for technical services professionals, their institutions, and the greater cataloging community of the funnel projects. Metadata librarians and catalogers interested in joining one of the projects as well as administrators looking to learn more about an important professional development opportunity for their technical services staff as well as a benefit to their institution are encouraged to attend.
