# From the President Takeaways from ACRL 2015



Last month I attended the biennial ACRL conference in Portland, OR. I saw many familiar faces and met many interesting new colleagues; it was great to see ATLA staff and members in the exhibit halls, during sessions, and at ATLA's reception. The conference was jam packed with content. If you are on Twitter, check out the following hashtags for some ACRL 2015 highlights: #acrl2015newroles,

#acrlprocess, #thresholdplan, #critlib15, #acrlframework, and #acrlresearchfutures.

Among the highpoints for me were a session on the 75th anniversary publication New Roles for the Road Ahead: Essays Commissioned for ACRL's 75th Anniversary, several informative sessions on the ACRL Information Literacy Framework, and a keynote by Lawrence Lessig, which I could not attend, but read about via Storify. The New Roles report is important because it describes (1) ways that we as librarians can frame the road ahead in terms of education, technology and scholarly publishing and (2) ways that we can reposition ourselves as catalysts for collaboration and change. The ACRL Information Literacy Framework continues to spark meaningful ongoing conversations much like the Value of Academic Libraries report did in 2010. I hope there will be further conversation of the Framework within the ATLA community. Threshold concepts were discussed in several sessions on the Framework. During a related webinar on the Framework, Sharon Mader described a threshold as "a pathway or portal to enlarge understandings of ways of thinking and practicing within a discipline" (http://www.acrl. ala.org/acrlinsider/archives/category/information-literacy). Drawing on the 2003 work of Jan Meyer and Ray Land, Mader went on to describe five characteristics of threshold concepts; they are transformative, irreversible, integrative, bounded, and troublesome in that they take us into a "liminal" state, which made me think about how to apply this to our contexts. What are some threshold concepts within theological education? Within courses on research in theological and religious studies? How do we as librarians and information professionals assist students into and through liminal states? At the end of the conference, keynote speaker Lawrence Lessig fired up the audience with his provocative talk on election campaign financing reform, open access, and net neutrality.

If you would like to read more about ACRL 2015 conference, the <u>proceedings</u> are available online. I welcome your ideas and questions. Also, I encourage you, especially those who live on the East Coast, to attend ACRL 2017 in Baltimore.

# Individual and Student Dues Increase Approved

More than 40% of eligible voters returned ballots in the 2015 election and a majority of voters (85%) approved passage of the proposal to increase individual and student member dues. Member dues supplied by ATLA Institutional, Affiliate, Individual, and Student members provide just 15% of the total amount expended to provide a wide range of services throughout the Association. Institutional member dues were last raised in 2006 and the last time individual and student dues were adjusted was 1998. The approved adjustments to individual and student members include:

- Increase dues for student members from \$15.00 to \$35.00
- Combine all individual member dues categories for salaries under \$20,000 and create a single category ("under \$20,000") with a dues rate of \$35.00
- Increase all individual member dues by 10%, except for those referenced in the above two points
- Create two new upper salary categories (\$100,000 - \$105,000 and \$105,001 +) with applicable dues

The new dues will go into effect for the 2015-16 membership year. Membership renewal notices with the new rates will be sent summer 2015.

### **Conference and Meetings Reports**

#### **Summit for Indiana Theological Librarians**

On Wednesday, March 26, eleven Indiana theological librarians gathered at Christian Theological Seminary to get acquainted and to consider ways to improve services through collaboration. Alan Krieger, Theology and Philosophy Librarian at the University of Notre Dame, described practices used to develop the library's theological collections. He identified subject areas where the resources of other libraries in the state complement university holdings. Gillian Harrison Cain, ATLA Director of Member Programs, highlighted ATLA member initiatives such as the <u>ATLA Reciprocal Borrowing Program</u> and the <u>E-Book Lending Project</u>.

The summit, which was sponsored by the Private Academic Library Network of Indiana, was followed on Thursday by a workday for PALNI seminary librarians. With PALShare direct borrowing reducing delivery times to about three days, seminary libraries want to coordinate collection development to reduce unnecessary duplication. They agreed to use OCLC local holdings records to generate a union list of print periodicals subscriptions. They will create a shared online list of standing orders.

In future meetings, PALNI librarians will explore customizing WorldCat Discovery for graduate theological research and ways to improve services to distance students. PALNI members that support graduate theological education are Anabaptist Mennonite Biblical Seminary, Anderson University, Christian Theological Seminary, Concordia Theological Seminary, Earlham College (Bethany Theological Seminary and Earlham School of Religion), Grace College and Seminary, Oakland City University, and St. Meinrad Seminary and School of Theology.

# ATLA Digital Projects - Member Information Gathering Survey

ATLA is developing a new program as a benefit for Institutional and Affiliate Member Libraries. As part of this program, we are seeking grant funding for collaborative projects relating to digitization and preservation.

We are actively researching grants to pursue and, in order to evaluate grant opportunities and create projects to propose, we need your assistance. We need information about the collections you hold and descriptions of the materials and information on the subjects covered in the collections. We need to know whether or not these materials are digitized, cataloged, microformed, etc. We want to know if you already have a digital asset management system or digitizing equipment on site. We're looking to better understand the state of your collections and what level of help you need.

We have created a survey to gather this information and kindly request you complete it to help us understand more about your collections in order to be able to create grant proposals or develop future programs to help members with digital projects.

We are still in the early stages of identifying grant opportunities and collections and so we cannot say with any certainty if your particular collection will be included in any specific proposal or project at this time. Each grant opportunity has certain parameters that must be met ("complete" collections, materials that advance scholarship, collections that already have metadata, collections that need cataloging, etc.), and so we are gathering information from you in order to create the strongest proposal that meets the requirements for a given grant.

Thank you in advance for your participation in responding to the survey. We appreciate that responding to these inquiries takes time and we hope that in return we'll be successful in securing grant funding and developing a robust digital program that will help you meet your goals.




#### **ATLA Members by the Numbers**

In January 2015, ATLA issued two brief demographic surveys in order to compare the characteristics of the 2015 membership against the results of earlier surveys conducted in 2009. This column will focus on responses from personal members (Individual, Student, and Lifetime). As of January 31, 2015, there were 336 Individual, 62 Student, and 89 Lifetime members. The results reported below reflect 208 respondents in 2015 (42.1% of ATLA personal members); 277 responded in

2009.

- 91.7% live in the U.S., another 5.3% in Canada, and 2.9% elsewhere, with every continent (except Antarctica) represented
- 89.8% are white, compared to 89.4% in 2009



- · 86% are currently employed in a library
- 83.2% hold a Masters in library/information science; 52.9% hold a Masters in theology
- 59% plan to retire in 10 or more years; 33.7% in less than 10; 7.2% are already enjoying retirement
- 54.8% are female, up from 46.2% in 2009
- 27.9% have been ATLA members for 20 years or more;
   21.2% have been members for 2 years or fewer
- 16% are over age 65 compared to 13% in 2009; respondents in all younger age groups declined
- · 14% are ordained


A wide range of denominational affiliations was reported for respondents' institutional employers just as it was in 2009, but some shifts have occurred. Those with 5% or more of the responses included:

- 12.2% Methodist down from 13.8%
- 10.7% Presbyterian down from 13%
- 10.2% Nondenominational up from 6.9%

- 9.6% Baptist down from 13.8%
- 9.6% Roman Catholic slightly up from 9.3%
- 7.1% Inter- or multi-denominational down from 11.8%
- 6.1% Lutheran down from 9.8%
- 5.7% None down from 14.2%
- 5.1% Anglican up from 4.9%

Many other denominations were represented by 1-3 respondents each. Two religions not represented in 2009 appeared in 2015: Jewish and Shambhala Buddhist.

In general, many of the trends established with the 2009 survey held true. ATLA membership remains well educated, is skewing older, and is still not very racially or ethnically diverse. The majority of members are



employed at mainline Protestant institutions, but many denomination affiliations for respondent's institutional employers showed a decline. "Nondenominational" increased the most while other slight increases were reported for Roman Catholic and Anglican. Other religious affiliations are beginning to appear, which adds to ATLA's overall religious diversity. In terms of membership longevity, the two groups at opposite ends of the spectrum represent the highest percentages -- 20+ years and 2 years or less. This may create some challenges for ATLA in the future since there could be significant differences in the aspects of membership that each group values most.
