

In Memoriam: Fr. Simeon Daly, O.S.B.

(ATLA) remembers the life of Fr. Simeon Daly, O.S.B., retired Director of Saint Meinrad Archabbey Library (1951 to 2000), past President of ATLA (1978-1981), and valued friend and colleague. Fr.

Daly passed away on Saturday, November 10, 2012.

Fr. Daly was a respected colleague who held many positions of trust and responsibility in the world of theological librarianship. Among his contributions to the leadership of ATLA were efforts to improve the administration and communications of the Association and to improve program elements of the annual conference.

The (Organizational) End is Near

The ATLA Board of Directors has been working on restating the ATLA Organizational Ends and other aspects of our governance policies. The organizational ends are central to defining the purpose and limitations of the work of ATLA. For instance, we could offer tanning bed service at ATLA headquarters but well-tanned members of staff are not one of



the organizational ends (the health benefits/costs of tanning not withstanding).

ATLA has had organizational ends for a number of years and the Board is now working to restate them as outcomes that can be more easily measured and evaluated. With these ends, we want to clearly identify the benefit, the beneficiary, and eventually, "at what cost." This will help the Board to better define the purpose of ATLA and monitor the health of the Association.

Also, longtime ATLA members might be surprised to see reports from a board meeting in October. The ATLA Board of Directors has added another meeting to our schedule so that we are now meeting in October, February, and at the June ATLA Annual Conference. Why add another meeting? Monitoring the performance of an organization as complex as ATLA is challenging with just two meetings a year. Also, the Board is tasked with looking to the future - a task that simply takes a lot of input, education, and conversation. We held our first October meeting just a few weeks ago and several commented on the sense of "breathing space" to carefully deliberate, plan, and focus on the work of the Association.

Finally, we want to hear from you. What are the trends in theological education that ATLA should be monitoring? What are the issues that you struggle with day-to-day? What are the information problems for which ATLA might work together to create a solution? These are exciting and challenging days for libraries and librarians. We invite you to find a board member and tell us your story.

Tammy Johnson to Fill Vacant Position on the ATLA Board of Directors

Tammy L. Johnson, Technical Services Librarian at Columbia Theological Seminary (Decatur, GA), will fill an open position on the ATLA Board of Directors following the passing of Andre Paris. Ms. Johnson's appointment took effect October 26, 2012 and her term will conclude June 30, 2014.

"The Board of Directors is thrilled that Tammy Johnson accepted our invitation," said Andy Keck, President of the ATLA Board of Directors. "Her service on the Executive Director search committee,

ongoing work in editing the Theology Cataloging Bulletin, and regular engagement at the ATLA Annual Conference make her an ideal addition to the Board."

Tammy is an active member of ATLA, serving on the Technical Services Interest Group Steering Committee, as editor of the Theology Cataloging Bulletin, and as a speaker on several panel presentations at the past three ATLA Annual Conferences. Tammy also served on the Executive Director search committee.

As stated in the Bylaws of the Association, in the instance of a vacancy on the Board, the Board of Directors shall appoint a qualified individual member of the Association to fill the unexpired term of a director. Ms. Johnson's selection was made at the recent Board of Directors' meeting, October 18-20, 2012, in Chicago, IL.

Summary of ATLA Board Meeting

The ATLA Board of Directors met in the offices of Quarles & Brady, LLP, on North LaSalle Street in Chicago, October 18-20, 2012, for the first of three meetings scheduled this fiscal year. Brenda Bailey-Hainer, Executive Director, and Miguel Figueroa, Director of Member Programs, shared research findings on historic and current ATLA membership as a basis for considering how the Association can serve more libraries and librarians. The Board approved new wording for the Organizational Ends rephrasing them as outcome statements. Several subcommittees brought revisions for portions of the Policy Manual that will enable the Board to operate more effectively. The annual evaluation of the Executive Director was completed three months early this year due to the change in the Board's meeting schedule (October, February, and June). The Board unanimously approved a motion affirming Brenda Bailey-Hainer's work, noting her accomplishments and future challenges facing the Association.

ATLA Proudly Announces Significant Product Developments and Accomplishments

ATLA Religion Database® (ATLA RDB®) now includes 1.8 million+ records, including indexing of more than 550 journals currently in publication, retrospective indexing for some journal issues back to the nineteenth century and increased coverage of electronic only and open access journals.

ATLASerials® (ATLAS®) now includes more than 220 titles with 380,000+ records, a 120% increase in titles since 2007. Thirty-five new titles were added in the past year, with increased international coverage, including the first three German language titles and broader coverage of world religions. ATLA now has agreements to include the influential journal Church and Society and significant content from the highly acclaimed Christianity and Crisis. ATLA also reached agreement with Oxford University Press to continue to include Journal of the American Academy of Religion and Sociology of Religion, and finalized agreements with SAGE Publications, Ltd., to continue to include Interpretation and Theology Today.

ATLA Catholic Periodical and Literature Index® (ATLA CPLI®), acquired by ATLA in 2011 from the Catholic Library Association, has exceeded 500,000 records. ATLA has concentrated efforts to further develop the scholarly content of the index, with increased coverage of international titles, including Revista Praxis & Pistis: Pastoral Theology and Cauriensia: Revista Annual de Ciencias Eclesiásticas, enhanced coverage of multi-author essay collections, extensive harmonization and enrichment of records across the entire database, and additional electronic-only journals, such as Digital Journal of Lasallian Research and Spiritan Horizons.

ATLA Professional Development Committee Meeting

The ATLA Professional Development Committee met October 22-23, 2012, in Chicago, IL. The meeting was chaired by Eric Stancliff and attended by committee members Lugene Schemper, Nicholas Weiss, and Jennifer Ulrich.

Among the topics discussed were the ATLA <u>Grants for Continuing Education Programs</u>, which provide funding to regional groups and institutional member libraries to support continuing education expenses, including speaker expenses, equipment rental, and room fees. A recently approved grant supported a speaker for the Southwest Area Theological Library Association's Fall Meeting.

The Professional Development Committee received a report from Judy Knop, ATLA Digitization Coordinator and coordinator of ATLA's NACO and CONSER Funnel Projects. The NACO/CONSER Funnel Projects provide opportunities for ATLA members to develop their skills in creating name authority records and master serial records as part of the Library of Congress Program for Cooperative Cataloging (PCC). Over the past year, there has been an emphasis on preparing for RDA (Resource Description & Access) cataloging. The Funnel projects continue to generate new headings and update existing records.

The Professional Development Committee also received a report from Carisse Berryhill, Special Collections Librarian at Abilene Christian University and instructor for the Theological Librarianship course offered through the University of Illinois. Offered for the past eight years, the course continues to receive interest—25 students in the most recent offering—from a broad array of individuals including ATLA members, librarians new to the theological field, MLIS students who are exploring this area of librarianship, and individuals not in library school or libraries but involved in theology or religion. The course will next be offered in the Spring 2013 semester.

Finally, the Professional Development Committee devoted a significant amount of time and energy to the <u>Creating Leaders of Tomorrow Program</u>. The inaugural class of participants will complete the program in December of 2012. The Professional Development Committee looked ahead to preparing a final assessment of the program and making recommendations for its future.

The Committee will continue discussions and work via e-mail and reconvene for meetings in the spring.

Theological Libraries Month was in full swing this October with institutions across North America celebrating theological libraries and their services.

Twelve institutions received TLM Mini-Grants to help fund their TLM activities. Among the success stories from funded projects include Methodist Theological School in Ohio, the third annual A.P. Mahoney Library Lecture at St. Peter's Seminary in London, Ontario, and The Pontifical College Josephinum in Ohio.

Methodist Theological School in Ohio Celebrates Mozart

On Thursday, October 4, 2012 Christopher Purdy, broadcast manager for Classical Music 101, WOSU-FM, played three excerpts from Wolfgang Amadeus Mozart's Requiem Mass. The program was publicized through the school's website and other media outlets.

Dr. Purdy played portions of three performances and discussed the vocal and orchestral differences between the recordings while weaving in the biographical details of Mozart's life.

The program was open to the public and publicized throughout central Ohio. Before Dr. Purdy was introduced, Paul Burnam and Ray Olson, directors of the libraries at MTSO and Trinity Lutheran Seminary, held up and described books and audio recordings about Mozart's life and his music held in both libraries.

Discoursing Spiritual Healing at St. Peter's Seminary in London, Ontario

The third annual A.P. Mahoney Library Lecture which took place on October 10, 2012 in the auditorium at St. Peter's Seminary was attended by over 100 people. Father Stevan Wlusek, the Rector, presented his talk titled "From Darkness into Transforming Light: Spirituality for the Healing Journey of Sexual Abuse Survivors." His talk was based on his Ph.D. thesis titled "The unique contribution of the Carmelite tradition of spirituality toward the care of sexual abuse survivors," awarded by the University of St. Michael's College, Toronto, in 2010 and published in book format in 2012.

At the close of his lecture, Fr. Wlusek presented his honorarium to Tom Wilken, Director of the Silence to Hope Centre. A launch of Fr. Wlusek's book and a wine and cheese reception in the library followed.

Experiencing Culture at Pontifical College Josephinum in Ohio

The Josephinum celebrated Theological Libraries Month with contests, lectures, and delicious treats. Beginning with a "Faculty Favorite Place in Rome" matching contest, twelve faculty descriptions of religious, cultural, and culinary sites in Rome were given throughout the month of October. This contest proved to be quite a challenge, but three students were awarded prizes nevertheless. In conjunction with this contest, the library resources highlighted Rome and faculty favorite places were on display.

Concluding the month of Octobe on a high note, Fr. John Rozembajgier shared his expertise on the Tomb of St. Peter and highlighted his experience as a tour guide for the Vatican Necropolis. Following the presentation, students enjoyed Italian themed refreshments of gelato and biscotti. According to the Josephinum, this was perhaps the largest crowd seen for a library presentation.

ATLA Launches Preservation and Digitization Survey

The American Theological Library Association is currently fielding a survey to identify Institutional and Affiliate members' preservation and digitization activities, plans, and future needs. The survey results will be used to inform and plan ATLA's preservation program.

Preservation figures prominently in ATLA's organizational ends, which state "Primary source material and scholarly resources for the study of religion and theology are organized, preserved, and made accessible at a reasonable expenditure of funds, time, and resources."

This extensive survey will help ATLA better understand libraries' staffing for preservation; the materials currently held by libraries, including items identified as the most significant; the extent of libraries' written preservation and emergency/

disaster plans; funding for preservation; availability of rare books and manuscript collections; formats for born-digital and digitized collections; preservation and digitization and training needs; and preferences for future ATLA-organized initiatives in preservation and digitization.

The survey was launched on October 19th with messages sent to Institutional and Affiliate Member Representatives. The survey will close on December 7, 2012. If you believe you should have received an invitation to the survey, but have not received it, please contact memberrep@atla.com.

To protect the confidentiality of responses, all questionnaires will be tabulated by an independent research firm, and findings will only be reported in the aggregate. A <u>PDF</u> of the survey is available for those interested.

From the Executive Director

Higher Education and Libraries: Joined by Technology



Clay Shirky was one of the keynote speakers at the EDUCAUSE 2012 Annual Conference in Denver last week. You may be familiar with him through his two books, *Here Comes Everybody: The Power of Organizing Without Organizations* and *Cognitive Surplus: Creativity and Generosity in a Connected Age.* His primary interest is in looking at the social and economic impact of the Internet.

Shirky, as have others, pointed out that new technology is changing people from being consumers to producers. But there is incremental change and then there's revolution. A revolution is when a change in information technology doesn't just accelerate things; it also changes the very concept of the task being performed. Many industries such as music, newspapers, and TV have already been transformed; new formats or technical capabilities completely changed the way they do business.

The time for revolution in higher education has arrived. In the music industry, the catalysts were the MP3 and Napster. In higher education, the disruption is coming through a new "format" – massive open online courses (MOOCs) – and technology startups like Udacity.

One of the other signs of a revolution is that old systems break faster than new systems can be put into place. Online learning, and particularly offering MOOCs at no cost to participants, is the equivalent of "unbundling" education. Courses can be taken in isolation, without enrollment at a traditional institution, or in a regular degree program. Instead of a "degree" students may collect "badges."

While it's unlikely that graduate religion and theology classes will attract the same huge numbers as undergraduate introductory courses, it is still intriguing to consider how this model might be applied in the ATLA environment.

In his article "The Future Has Arrived: Changing Theological Education in a Changed World," Daniel Aleshire refers to "a big tent of educational practices" that serves a broader range of ministry settings, congregational leaders, and settings outside of traditional churches. Diverse forms of theological education are needed to support this expanded range. Aleshire specifically mentions baccalaureate theological education and lay education, two areas that MOOCs could easily support. Perhaps it's time for some theological education revolution.
