Minutes of the Business Meeting and Association Update

Friday, 19 June 2015 1:30-3:00pm

Evergreen D-F, Denver Marriott Tech Center

Petition: Shanee Murrain, of Payne Theological Seminary, and Jessica Bellemer, of Hood Theological Seminary, rose to

"petition the Board to convene to discuss an appropriate ongoing response for ATLA as an organization which builds upon the lunchtime discussion organized and attended by ATLA members about the religious and racial terrorism act, a dialogue that was inspired by the recent act which victimized the congregation at Mother Emmanuel AME Church" in Charleston, SC, the victims of which "include alumni of ATLA member institutions and a professional librarian."

President Bidlack responded by asking the Board to reconvene after the business meeting.

Secretary's report: Steve Perisho read the following:

- Members of the 2015 Teller's Committee were Alan Krieger, chair (University of Notre Dame); James Darlack (Gordon-Conwell Theological Seminary); and Leslie Engelson (Murray State University).
- The Teller's Committee received the election results via e-mail from Survey & Ballot Systems and verified that 261 (or 40.22%) of the 649 individual and institutional members eligible cast valid ballots. The membership elected-as given here in alphabetical order-Ellen Frost, Tracy Powell Iwaskow, Timothy Lincoln, and David Stewart to the board class of 2015-2018.
- In addition, a majority (85% of those who voted on this issue) passed the proposal to increase individual and student member dues.
- Nominating Committee members for the current year are Carrie Hackney (board representative and Chair), Eileen Crawford, and Tammy Johnson. The slate for next year's election will be announced in mid-October and the election will be in January of 2016.
- Members are welcome to make nominations by petition to add to the slate presented by the Nominating Committee in October. Petition nominations should be signed by at least ten current individual members and submitted to the ATLA secretary no later than December 1, 2015.

Bidlack solicited a motion and a second, after which the report was approved unanimously. Bidlack then welcomed Frost, Powell, and Iwaskow to the Board. Acknowledgements of service: Bidlack spoke appreciatively of the contributions of outgoing Board members Sandy Aver, Carrie Hackney, and Melody Layton McMahon, and thanked them for their service. She also acknowledged the work of officers Kelly Campbell (vice president) and Steve Perisho (secretary), and introduced the leadership team for 2015-2016: Kelly Campbell (president), Timothy Lincoln (vice president), and Steve Perisho (secretary). She then passed the gavel to Kelly Campbell, who voiced the Board's appreciation for her outstanding leadership over not one but two very full and demanding terms of service as president.

Transitions, including Deaths and Retirements: President Bidlack read the names of those who died in 2014-2015: Carol P. Cummins, Rosalyn Lewis, and Grace E. Mullen. These three women were remembered during a memorial service earlier in the annual conference. Bidlack then read the names of those who retired: Tony Amodeo, Chris Brennan, Joe Coalter, Drew Kadel, Bob Krauss, and Jim Skypeck. Those retirees who are eligible will receive lifetime memberships.

2016 Annual Conference in Long Beach: Representatives of the 2016 local host committee showed a video promoting the Los Angeles, California area as the location for the 2016 Annual Conference.

Update on the Association: Brenda Bailey-Hainer provided an update on the state of the Association. For the full text of her report, see the Proceedings.

Presidential Address: President Bidlack closed the meeting with a presidential address entitled, "Tradition and Innovation, Or, Elijah at Horeb." The full text of this, too, will appear in the Proceedings.

The Meeting adjourned at 2:57 p.m.

An Overview of the Process for the Nomination of Candidates for Election to the ATLA Board

To help members understand the process by which candidates are nominated for election to the ATLA Board of Directors, the ATLA Nominating Committee has provided the following overview.

In the April ATLA Newsletter, the Nominating Committee provided information on how members may submit names for consideration to the committee and gave a June 1 deadline for receiving nominations.

Beginning in April, the committee identified potential nominees, including current Board members eligible for re-election. The committee has been contacting individuals to confirm their interest in running and to answer any questions they might have.

In addition to nominations put forth by the Nominating Committee, individuals may petition for inclusion on the ballot. Nominations other than those submitted by the Nominating Committee may be made by petition signed by no fewer than ten (10) Individual members of the Association and shall be filed with the Secretary of the Association no later than December 1. These nominations may be submitted by fax, email, or surface mail and shall be included on the ballot with the nominees presented by the Nominating Committee.

By October 1, the committee will have submitted to the Board Secretary and the Director of Member Programs, a slate of at least six candidates for the four places to be filled on the Board. The Director of Member Programs will ask each nominee to submit biographical information along with a statement concerning his or her view of the Association's needs and/or mission. These materials will be included with the ballot.

By October 15, the Director of Member Programs will send email or letters to all eligible ATLA voting members announcing the candidates presented by the Nominating Committee and including information about making petition nominations to the Secretary.

December 1 will be the deadline for submissions, by petition, of additional nominations by the membership.

Between December 1 and January 15, the Director of Member Programs will confirm the eligibility of all candidates and the Secretary will inform petition candidates of Board duties and verify their willingness to serve. All candidates will be asked to finalize and submit their biographical information and statements concerning their view of the Association's needs and/or mission.

By January 15, the Director of Member Programs will have prepared the ballots and distributed them to all eligible ATLA voting members.

ATLA Awards Diversity Scholarship to Kathryn Flynn

The ATLA Diversity Committee is pleased to announce the recipient of the 2015 ATLA Diversity Scholarship, Kathryn Flynn.

Kathryn is working toward her Masters of Library Science at UNC School of Information and Library Science in Chapel Hill, NC.

She plans to increase diversity in her immediate context by bringing a queer perspective into the classroom. According

to Kathryn, "Queer is by definition whatever is at odds with the normal, the legitimate, the dominant' (David Halperin, 1995, 62). Because by definition queerness is in opposition to what is, queerness always inhabits a space that is not. When I invoke my queerness in the classroom regarding libraries (in general and theological in particular), I complement the voices of tradition. As libraries increasingly live in the world where space is defined by the absence of physicality, queer voices like mine can help make sense out of this new reality and help create a new meaning for libraries."

She continued, "When other people see me, I remind them that the patrons of the libraries they serve also include people all along the gender spectrum. This in turn makes it easier for ATLA members to keep those patrons in mind while developing collections, writing policies, or publishing literature."

Flynn is a Student Member and will use her scholarship to support her enrollment at UNC School of Information and Library Science.

Held at the Marriott Denver Tech Center, the location allowed for extensive conference programming which provided our members with new, interesting, and some late breaking sessions. tighten up business practices and incorporate as a non-profit organization, a change in demographic due to long-time members leaving the association and new members coming on-board, and record keeping in the digital age. Perhaps the most challenging project, but also the most exciting, is the prospect of charting a new direction and purpose for NYATLA. In the past NYATLA had been devoted to resource sharing, but now with new consortia and computer networks, this has become less important. At this meeting NYATLA members began laying the groundwork for a new mission for NYATLA.

A meeting in the fall will be devoted to "brainstorming" the future of NYATLA. This meeting will be preceded by a survey to get a clearer idea of what types of programming would best serve the needs of member libraries. Gillian reassured the membership that many other regional groups are in a similar process of re-evaluation and reassessment.

Following the business meeting the group toured the Quinn Library at the Lincoln Center and enjoyed lunch and conversation at a nearby restaurant.



ATLA Birding Passion Group 20th Anniversary Outing Denver 2015

"I've got one of your target birds in the scope."

Thus began the 2015 "meeting" of the ATLA Birding Passion Group. It was a milestone of sorts. Twenty years ago, almost to the day-in fact, it was the last time that Denver hosted the ATLA conference-a local birder had taken Lynn Berg and me on a tour of Red Rocks Park. Lynn saw her first Black-billed Magpie, and I saw my first Virginia's Warbler.

The bird in the scope turned out to be a Western Scrub-Jay, and it was a "lifer" for most of us. The "us" being Lynn Berg, Karla Grafton, Ann Heinrichs, Myka Kennedy Stephens, Ondrea Murphy, Bethany O'Shea, and I. We were birding Castlewood Canyon State Park, which lies 28 miles south of Denver. Our hosts were Karen Metz a retired academic librarian and the owner of the telescope; Amy Cervene, a public librarian and the point person of the hosting group; and Norm Lewis, a retired real estate agent who leads birding tours throughout the state. I'd previously "met"-all of them through the "Cobirds" discussion list.

Next to show itself was a male Mountain Bluebird, resplendent in pale blue, that posed for us on a fence post. "Hear that? Wild Turkeys!" said Amy. Just then, a bird began to sing over the gobbling. It sounded like a robin on speed-Black-headed Grosbeak, and there it was, perched in the open on a bare branch. "Raptor! No, Great Blue Heron!" someone called, as the huge bird lumbered low over the parking lot. A Mourning Dove perched on a distant branch, Violetgreen Swallows circled overhead, and then a buzzzz announced the passage of a male Broad-tailed Hummingbird.

We were tempted just to stay in the parking lot, but the scrub oak and ponderosa pine habitat below us promised new species. And quickly delivered a Spotted Towhee perched in a treetop and singing its jingling song at full volume. A Common Raven and an American Crow flew past. "LEGO," said Karen, and then quickly explained that that was the four-letter banding code-a sort of bird-bander shorthand-for the tiny bright yellow black-backed bird perched low in a bush about 10 meters away: Lesser Goldfinch. Our hosts tossed around a few more banding codes: AMRO (American Robin), MODO

(Mourning Dove). "We also have the green-backed subspecies of Lesser Goldfinch here," said Norm. Prophetically, as it turned out, for we found one minutes later. Then another goldfinch displayed for us, this one had black wings and crown on an otherwise bright yellow body-the closely-related American Goldfinch.

"What's that bird?" Ann wondered aloud.

"I was trying to make it into something more exotic, but it's a female American Robin," said Norm. "Listen to the male sing," called Karen, "when I was in Jasper Park we heard one that had added Baltimore Oriole notes to its song-and it ended up beating out its rivals and breeding with the female!"

Soon we were being serenaded by at least two House Wrens. This was soon interrupted by a squeaky whistle from the tree-tops that disclosed a pair of Brown-headed Cowbirds. "White-throated Swifts!" It was Karen again, rejoicing that there were any swifts left after the late frost that had killed off many of them in May. "Some say they have a 'twinkling' flight," said Norm-and they certainly made the swallows they were flying with look lethargic.

"Pee-ur!" The bird had been calling mournfully for a while, and now it was perched on a dead branch right in front of us, right where we'd seen a Hairy Woodpecker minutes before. "See how it sallies after flies and then returns to its perch; that's typical behavior for the Western Wood-Pewee," said Norm. "And for most flycatchers," added Karen. Then came the two-note call of a Mountain Chickadee, the "yank" of a Pygmy Nuthatch, and the burry song of the Plumbeous Vireo; but no one got good looks at them.

What we did see, though, was a couple of dozen Turkey Vultures sunning themselves on the rocks below the escarpment about 150 meters away. "How pretty!" said Ann. "I think they'd be touched to hear you say that," Norm responded. The birds slowly began to lift off to take advantage of the updrafts along the cliff face. On







a nearby snag sat a Steller's Jay, looking black against the sun and with its crest clearly visible.

A Warbling Vireo began to sing, or rather to lecture, given the insistence of its tone, but there was no point in trying to find it: like most vireos it'll sing all day from a hidden perch. No matter, a delicate bird with a blue back and a rusty breast flew into a pine and then perched briefly on the ground-Western Bluebird, a species high on our list of target birds.

"Canyon Wren, but it's singing very softly," said Amy. Softly indeed. She had to point it out three times before I heard it. Too bad that its slow, descending, haunting song wasn't echoing loudly among the boulders below the cliff face, as it often does. "Cliff Swallows," called Karen, and we looked up and saw about 50 of them circling overhead. Also circling overhead were the vultures. "There's something else with them-Cooper's Hawk-no, look at the black primaries; it's a Karen pointed out a Rock Squirrel (a "life mammal" for me) sitting in front of its burrow. A Cordilleran Flycatcher vocalized briefly; it's a member of a family of flycatchers whose individual species can be reliably distinguished only by voice, so seeing it wasn't a big concern.

On our way back to the parking lot we heard another vireo singing-"Here I am, where are you?" Again, like most vireos, it was so well hidden that it was impossible to tell where "here" was. But the song gave it away: Red-eyed Vireo. A few more steps and we stopped in our tracks: there was a female Pine Siskin, a heavilystreaked drab little finch, gathering thistle down for its nest, wisp by wisp, until it had a puffy bill-full.

We decided that we had time for a brief walk down one last trail, for a final shot at Lazuli Bunting, one of

second-year Swainson's Hawk, looking very pale." Also among the soaring mix was a couple of Red-tailed Hawks hanging motionless against the wind-kiting, it's called-the better to survey the ground below them for prey.

Soon after, Karen, who regularly birds the park, found us a pair of Western Tanagers. We'd heard a number of them sing their robinwith-a-sore-throat song high in the pines, but this was the first glimpse we'd had of them. And glimpse it was, just two yellow and black streaks descending from a branch. No sign of the red crown, unfortunately.

I heard a sweet three-note call and called out "Black-capped Chickadee." "Oh, you mean that 'cheeseburger' song?" said Norm. This is one of the many mnemonics we birders have come up with to identify bird songs. I couldn't resist mentioning my favorite, the one for White-crowned Sparrow: "I gotta go wee-wee now."

We decided to head to Cherry Creek Falls, which we could hear in the ravine below. A Gray Catbird sang from cover as we made our way down the trail. This master mimic sings rapid, chattering "cover versions" of songs it's learned from its neighbors. In the sandy sides of the ravine we could see the nest holes of the Cliff Swallows. And then

our main targets. Amy quickly found, not the bunting, but a very uncooperative and skittish pair of Blue-Gray Gnatcatchers. Then a Belted Kingfisher (BEKI to a bird bander) flew over and gave its rattling call. By then it was almost 9:00, time to take some group photos so that we could return to the hotel by 10:00. "Lazuli Bunting!" cried Karen, and there it was, perched on a dead branch, singing its squeaky song and displaying its blue head, orange breast, and white belly for the world to see.

A fitting conclusion to a successful outing during which we'd covered 3.7 km., walked nearly 4,000 steps, and seen or heard 44 species. As we pulled into the hotel parking lot, Ann declared that she'd have just enough time to have a shower and put on her librarian clothes. "Don't tell anyone," said Myka, "but I'll probably be compiling my list during the first session."

Going Global



One of the major goals in ATLA's new strategic plan relates to global collaboration: ATLA is recognized globally as a strategic collaborator.

In many ways, ATLA already operates on an international basis. A number of ATLA's members have long had an interest in working with libraries outside North America. We have welcomed international attendees with free registration at the ATLA annual conference. In recent years, this has resulted

in the opportunity to learn from colleagues from around the world, including Australia, Belgium, Finland, France, Kenya, Mynamar, Trinidad and Tobago, and the United Kingdom.

Although ATLA does not actively recruit members from outside North America, some international organizations approach us about membership. Currently, 4.4% of the organizations that belong to ATLA are based outside the U.S. and 8.4% of personal members are from outside the U.S.

Our products have international reach and representation. A significant portion of libraries that subscribe to them are located outside the U.S. - 34% of them, to be exact, which are located in 59 countries. Of these, only 7% are based in Canada. As ATLA actively expands the subject matter and languages included in *ATLASerials®*, naturally more and more of the publishers represented come from outside the U.S. In fact, 27.8% of publishers included are based outside the U.S. and 42% of licensed titles are published outside the U.S.

ATLA takes global collaboration seriously and recently has increased its interaction with organizations outside North America. In recent years, staff have attended many meetings and conferences of organizations with a similar purpose, including ABTAPL (Association of British Theological and Philosophical Libraries), ANZTLA (Australia and New Zealand Theological Library Association), BETH

(Bibliothèques Européennes de Théologie), ForATL (Forum of Asian Theological Librarians), and VThB (Vereniging voor het Theologisch Bibliothecariaat) in the Netherlands. Last month, for the first time we sent representatives to the Society for Biblical Literature International Meeting - this year held in Buenos Aires, Argentina, and for several years we have been attending the Frankfurt Bookfair, an increasingly important place for us to meet with publishers. Our partnerships with other like-minded organizations that operate internationally, such as TBN (Theological Book Network), are important to us as well.

We learn more all the time about the environment for libraries internationally through participation in the IFLA (International Federation of Library Associations and Institutions) annual meeting. Next year, ATLA will provide funding to help sponsor a librarian from the majority world to attend the 2016 IFLA Conference, which will be held in Columbus, Ohio.

But the "global collaboration" goal calls for more than just attending meetings or giving grants. It means actively seeking ways that we can work together as equals with these other organizations on projects that help solve broad overarching problems or create new products and services that benefit all participants and their constituents.

Achieving this goal will take time and calls for involvement from everyone represented in ATLA - the board, the staff, and member volunteers. During the coming year there will be many opportunities for all to help further ATLA's global collaboration efforts.
