# The Comfort of Core Values Amidst Change

As the academic year begins I have been very intentional in my efforts to connect and create community at work. Several longtime faculty and support staff retired last year, resulting in new hires and reconfigurations of our staffing model. Every department has been adjusting to new people and new ways over the summer. We've had a formal staff day to discuss institutional changes and the direction of an emerging strategic plan, as well as informal opportunities during the day, and at lunch. These conversations and connections take time. All this is happening in the midst of revelations that are rocking the Catholic world. # Internet Trends and Opportunities and a Flashback to the 1990s

Last February, I woke up bleary-eyed and glanced at the business headlines: Ken Yoshida Named New President of SONY Corporation. Ken Yoshida was a familiar name to me twenty years ago as he was my boss when he was NYC-based Manager of Investor Relations. Since then, I've been reminiscing about those early days in my career.

In the mid-1990s, when I worked for Ken at SONY as an investor relations representative, one of my responsibilities was to demonstrate new products to industry analysts and institutional

investors. I attended various consumer electronic trade-shows and events, and I was one of the first staff members to test the MagicLINK, a personal communicator and PDA that attached to a phone line for AOL mail(!). It was revolutionary for the time. One of the analysts I was most impressed with at the time was an up-and-comer named Mary Meeker, who has since gone on to internet fame.

Every year Meeker, now affiliated with the venture capital firm Kleiner Perkins, presents a highly anticipated Internet trends report. Here is the link for slides and analysis for 2018: <u>https://www.recode.net/2018/5/30/17385116/mary-meeker-slides-internet-trends-code-conference-2018.</u>

## Two key takeaways of her most recent analysis include:

**Increase in online time.** People are increasing the amount of time that they spend online. U.S. adults spent 5.9 hours per day with digital media in 2017, up from 5.6 hours the year before. Some 3.3 of those hours were spent on mobile, which is responsible for the overall growth in digital media consumption.

For me and my family, I see this trend unfolding in real-time. My teenager has a Google Chromebook given to him by the high school and he has no physical textbooks. All of his assignments are to be completed online including completing math problems with a stylus. I've also informally studied commuters in my train car during the ride to and from downtown Chicago and 95% of the people are using a handheld device for more than 30 minutes during each ride.

Voice-controlled products like Amazon Echo are taking off. The Echo's installed base in

the U.S. grew from 20 million in the third quarter of 2017 to more than 30 million in the fourth quarter. In my professional role, I use voice-memo a few times a day. For example, I use my iPhone app after a meeting to quickly record some notes, and when I am at a conference and want to quickly capture some information and thoughts. We've installed Amazon Echo devices (and Spots) in our home for reminders and to stream music.

So what do you think these trends mean to you in work and life in general? I welcome comments below.

# The SCOOP: Who Knows the Way to Get to OA?

When open access was first introduced as a concept nearly twenty years ago, there were two common "roads" offered to open access: Gold and Green. Gold OA was defined then and still known now as open access that is available directly from publishers and free for

readers but commonly published at a cost for authors, known as Article Processing Charges or APCs. Green OA has been understood to mean open access through the action of authors, most commonly through author deposit in an open access repository. Variations on these two original modes of open access have emerged over the years; however, the growing concern among proponents and advocates has been not only the slow growth but also the sustainability of the current models. In recent months, two new roadways to open access have been proposed: the 2.5% Commitment and OA2020.

## The 2.5% Commitment

Proposed by former IUPUI University Library Dean (and 2018 ATLA Conference closing keynote speaker) David Lewis, the <u>2.5% Commitment</u> requests libraries to commit 2.5% of their total library budget to establish an "open scholarly commons that will be digital and distributed with colleges, universities, cultural heritage organizations, scholarly societies, foundations, and governments hosting the content created, funded, or of interest to them in repositories that would make the content openly available to the world." The "open scholarly commons" or common infrastructure is not a single instance but rather a network of interoperative and ideally community-owned solutions represented by open source software projects such as OJS and Hyku; open repositories such as ArXIV, Humanities Commons and HathiTrust; tools for discovering open access content; preservation organization; OER content developers and providers; and advocacy groups such as SPARC and the Library Publishing Coalition.

The proposition prompted numerous responses from the library community, both supportive and critical (see open access proponent Cameron Neylon's thoughtful but critical look at the 2.5% Commitment in this blog post). The immediate action was a <u>crowdsourced list</u> of the available investment opportunities for libraries to consider. This list of opportunities was used to develop <u>a tool</u> to allow institutions to measure their investments in the various components of the common infrastructure. This tool and other information on the 2.5% Commitment can be

found on the <u>initiative's website "Towards a Scholarly Commons.</u>" In a follow-up article, David Lewis and others <u>outline the next steps for the initiative</u> and renew the call to libraries consider building contributions to the development of the common infrastructure into their budgets.

# OA2020

Initially conceived in 2015, the European initiative OA2020 calls for a global collaboration "to transform the current publishing system, replacing the subscription business model with new models that ensure that outputs are open and re-usable and that the costs behind their dissemination are transparent and economically sustainable." As with the 2.5% Commitment, the suggestion of a complete discontinuance of the subscription system and reinvestment of subscription dollars in open access publishing services prompted both signatory support as well as vocal opposition. Notably, the Confederation of Open Access Repositories (COAR) and UNESCO issued a joint statement in 2016 denouncing any "one size fits all" solution to open access and criticizing the proposal to redirect subscription funds to APCs for bias against institutions with smaller budgets and developing countries, among other things. In the U.S., the criticism zeroed in on the suggestion that OA202 solely called for the flipping of subscription dollars to the payment of APCs. However, as University of California-Berkeley's scholarly communication officer Rachael Samberg explains, the goal of OA2020 can be realized through a multitude of strategies that may or may not rely upon redirection of subscription dollars to the payment of APCs. As proposed by the 2.5% Commitment, this may instead mean a reinvestment of subscription dollars into the development of infrastructures such as repositories or OA publishing mechanisms.

# Making Sense of the Map: Pathways to OA

As a signatory to the OA202 initiative and to aid libraries in their consideration of the various proposed routes to transform the scholarly communication system, the University of California system released <u>"Pathways to OA"</u> earlier this year. In this document, the authors consider the traditional Green and Gold approaches to OA as well as the universal strategies represented by initiatives like the 2.5% Commitment and OA2020. The report considers the challenges and opportunities posed by these approaches and strategies and recommends next steps for libraries to consider. For example, for libraries committed to the promotion of Green OA, the authors encourage libraries to engage in licensing negotiations to secure reuse and deposit rights for authors. Libraries seeking to engage further with Gold OA publishers should explore memberships that offset APC costs as well as identify and engage with journals that may consider flipping from a subscription to a Gold OA model. Finally, for libraries wanting to support universal strategies, investment in infrastructure and support of national and international initiatives are encouraged. As part of the report, the authors put together <u>a useful chart</u> that succinctly and clearly lays out the full report.

During ATLA's 2018 Annual Conference, the DEI Committee met to review the thirty-one applications received for the DEI scholarship. The significant increase from last year is due to the fact that the committee emailed all



sixty-one ALA-accredited programs informing them of the scholarship. The committee was impressed by the quality of applications received, and after reading through the exceptional essays, they arrived at their conclusion to recommend Lucy as the recipient of this year's award.

Lucy is currently pursuing dual Master's degrees in Information Science and in Middle Eastern Studies at the University of Texas at Austin with the hopes of working as a designated Islamic law librarian. #### On what diversity means to her, Ms. Flamm shared:

Difference presents an opportunity for comprehending dissimilar outlooks through dialogue and discussion. However, diversity does not equate inclusion. In the field of Middle East studies and the university academy generally where I seek to work as a specialized Middle East librarian, men dominate the workforce. In both of these ways I find myself excluded from established communities and find myself diversifying the arch-types of those currently in the profession and contributing my unique perspective as a result of my background.

In the fall of 2017, Lucy worked as a Teaching Assistant for an upper-division undergraduate Islamic Law course. In this role, she provided one-on-one support for fifty students in deconstructing primary source materials key to understanding religious law and jurisprudence. In the upcoming 2018-2019 school year, Lucy will be assisting an undergraduate course dealing with all religions in the Middle East. The Committee is thrilled to award Ms. Lucy Flamm ATLA's 2018 Diversity, Equity, and Inclusion scholarship, and we are looking forward to working with her in the upcoming months!

## TCB – Publication Schedule Shifts and Moves to Open Access

This August issue of *TCB* will be the last for 2018. As <u>mentioned previously</u>, TCB will be on ATLA's instance of Open Journal Systems (OJS), the same publishing platform used for <u>Theological Librarianship</u>. Beginning in January 2019, *TCB* will be openly available to all readers through the OJS site under a <u>Creative Commons Attribution-NonCommercial</u> <u>license</u> (CC-BY-NC). Back issues of *TCB* will eventually be moved from the membersonly Community area on the ATLA website to the new OJS site. Further, *TCB* will continue as a quarterly publication but will shift to a new publication schedule in January 2019. The next volume, volume 27, will start with the January 2019 issue and will be followed by issues in April, August, and October. This shift in publication schedule will allow *TCB* to more closely align with the releases from the Library of Congress, which are a vital component of *TCB*'s content.
