Report of the Secretary of the Board
ATLA Annual Conference, 2009, St. Louis, Missouri
Minutes of the Business Meeting

From the Executive Director

The business meeting was convened by Board President David Stewart at 2:00p.m., Thursday, June 18, 2009.

Eileen Crawford presented the Secretary's report. The Teller's Committee was composed of Don Meredith, Sheila

Owen, and Jane Williamson. They received the election results via email from Survey & Ballot Systems and verified that 306 ballots were received. The membership elected Sandy Ayers, Carrise Berryhill, Carrie Hackney, and Laura Wood to the Board of Directors for the 2009-2012 term of office. The Secretary's report was accepted.

Allen Mueller introduced the Board officers for 2009/2010: Eileen Crawford (Secretary), Roberta Schaafsma (Vice President) and David Stewart (President).

President Stewart recognized and thanked departing Board members Cait Kokolus and Allen Mueller. President Stewart awarded Dr. Martin E. Marty a Lifetime Membership to ATLA under the provisions of 1.7.b. in the Bylaws of the Association. Dr Marty was present to receive his plaque and grace the assembly with a brief address. President Stewart delivered his presidential address. The Business meeting adjourned at 2:35 p.m.

## **Board of Directors Meetings**

The Board discussions included a review of the charges written for the Policy Governance and Audit committees and a conversation about how new policy is written, vetted, and enacted. A revised draft of the Organizational Ends in the Board Policy Manual was reviewed and a timeline established to finalize the document in time to solicit input from the membership at the next conference. Reports were received on the work of the following committees: Audit, Endowment, Governance, and Special Committee of the Association for Diversity. A charge for a Task Force for Live History was approved and its members will be appointed by the ATLA President. The Board engaged in a review of the conference with the Education and Annual Conference Committees. The January Board meeting was set for January 15-17, 2010 at ATLA Headquarters.

# From the Executive Director The View From Here



The other day I read about an amateur astronomer discovering evidence of a large object colliding with Jupiter. The story told about astronomers booking time in all of the major observatories to study this event. One of them

commented on our good fortune that Jupiter, with its huge gravitational field, attracts these objects from outside the solar system, serving as our protector.

It made me think about the worldview of astronomers and what it must be like to focus, not on local, state, or national news and events, but on cosmological events. This observation made me reflect further that our view of how things are going is shaped by our field of vision.

At ATLA headquarters our field of vision differs markedly from the view shared by most of our members. We don't have patrons asking for materials or assistance; we aren't a department or unit of a larger administrative unit; we don't order our lives by the academic calendar; we aren't approached by vendors trying to sell us books and journals and subscriptions to electronic resources.

That's why it's so important for us to be in communication with our members, to hear the view from theological libraries, and to address the concerns that our members are facing. I think that our collective response to the current economic turmoil was evident at our annual conference in the programs and projects that addressed those concerns.



Every day when I come to work, I pass by our member wall, a large frame that holds the logos of each of our institutional members. It's a visual reminder to the staff and me that we work

for an incredibly rich and diverse collection of theological libraries of every stripe and size and denomination. At ATLA headquarters, we are keeping you in view.

# ATLA 2009 Annual Conference Summary



Congratulations to the Libraries of the St. Louis Theological Consortium. When they said "Meet me in St. Louis," they really meant "What a great meeting St. Louis will be!"

The 2009 ATLA Annual Conference held at the Millennium Hotel St. Louis was well planned and organized, creating an excellent conference experience for all members that attended. Once again, I was delighted to be a part of this international gathering for the premiere ecumenical library association. Our conference was well attended and attracted a very diverse group of divinity librarians who hailed from Africa, France, Belgium, Jamaica, and Taiwan. Allen Mueller and Jim Pakala, co-chairs of the Local Host Committee, did a great job implementing all of the host committee activities and made us all feel welcomed and very much at home in this venerable city, which serves as the country's "Gateway to the West." Volunteers at the Local Host Table ably filled in all of the blanks that surfaced at the conference, providing a wealth of information to us all. ATLA's annual conference attracted 300 members, exhibitors, and guests - no small feat in this economy.

In attendance this year we had 34 first time attendees, 35 new members, and 5 international members; 35 members received travel grants. All of the interest groups, panels, papers, and roundtables were well attended. # **Solving Problems the MacGyver Way**

In the 1995 film Apollo 13, there is a scene in which engineers try to figure out how to fix the carbon dioxide filters on the Apollo space craft using only materials already on the ship. The team leader dumps a bag of stuff on a table and announces that the problem is, essentially, how to make a square peg fit into a round hole using the odds and ends strewn on the table. The engineers solve the problem and save the astronauts' lives by using (among other things) a sock, the cover of the flight plan, and duct tape.

MacGyver, that great TV improviser, would be proud.

In theological librarianship, we face many problems that need to be solved with the materials at hand. Sometimes the problems are rather mundane (another paper jam in the copier), some are technical (the ones that your spouse pretends to be interested in when you talk about them at the dinner table), and some involve challenges in leadership (another fiscal year, another year of lobbying for the library budget). In some cases, we must respond to difficulties not of our own making. In other cases, we are trying to use emerging technology or implement a new service to make our libraries better contributors to teaching, learning, and research.

The argument for taking your professional development seriously is based on two premises. First, you did not learn everything that you need to know about librarianship in library school. Second, you participate in a community of professionals who willingly share their expertise. ATLA provides several options for professional development that may help you address thorny

problems that you face in your day-to-day work or prepare to take on more professional responsibility. Details of these professional development opportunities are available on the Member Page of the ATLA website.

Professional development makes us better MacGyvers, better problem solvers, better librarians.
