Vocational Horizons: Two Scenarios



An interesting case of "conceptual whiplash": this past Thursday evening I met for the semester's final session with my MLIS class of 18 students. As in previous years, those of us so inclined

reconvened afterwards to a nearby Irish pub. Our conversation turned at some point, as it often does, to job prospects, not only for these very gifted students, but for librarians more generally.

Segue with me to my regular coffee place, where I noticed the past day or two something markedly different in the clientele: as it happens, the annual state conference of the Future Farmers of America is convening nearby. These youthful delegates really do stand out, and I'm not referring only to their natty outfits. There's a contagious energy and optimism that (as I overhear their conversations) has at least something to do with their sense of the future, and their place in it. No vocation is completely secure from change and challenge, but I suppose the FFA delegates possess a high degree of confidence that one way or another there will continue to be a need for exactly what they bring to the table.

Here's what these two very different scenarios help remind me of: we can never separate our vocation and its prospects from the bigger context. What, exactly, are our services, products, and contributions to the world around us? In what unique sense do they fill a need? And how is that need changing? There is no better setting than the ATLA community to consider such intriguing questions as these.

On April 17th I had the opportunity to attend the meeting of the Chicago Area Theological Library Association (CATLA) on the campus of the

Associated Mennonite Biblical Seminary in Elkhart, Indiana. CATLA is one of 17 regional groups affiliated with ATLA, and the program was interesting and encouraging.

Ruth Gaba presented a report about her ongoing research about the environments and settings that theological students favor for scholarly reading and writing. This important project helps librarians learn the importance and impact of the physical environment they offer to students.

We also had the opportunity to learn about plans for the new library being built at Concordia Theological Seminary in Fort Wayne, Indiana (*see article in Member News section for details*). Director Robert Roethemeyer shared all of the factors that are involved in a successful library building project, just as Concordia was set to break ground (Tuesday, April 21, was the groundbreaking).

Eileen Saner, our host for the day, told us about all of the factors involved in building their new library (completed in 2007), the first LEED certified green building in northern Indiana. We even got to see the pipes from the geothermal heating system employed in the building.

It was a wonderful day, and it was encouraging to see the creativity, commitment, and energy that our members have for creating spaces, developing programs, and providing services that offer excellence to theological students and faculty.

The \$8 million dollar expansion is scheduled to begin this summer. "After many years of patient, prayerful planning, we are delighted to have a



concept for the expansion of the library that excites our donors, surpasses our programmatic dreams, honors our Saarinen village, and provides a shovelready, value engineered project as we seek to hold up a bright future in the midst of these dark times," commented Roethemeyer.

Diversity 101: Unpacking Our Suitcases and Our Briefcases--An Interactive Workshop for Front-Line Service Providers and Managers

Wednesday, June 17, 2009, 1-4:30pm

Tracie D. Hall, Consultant, ATLA Through engaging presentation, interactive exercises, open dialogue, and resource-sharing, this three-hour session guides participants through some of the concepts (bias, discrimination, privilege) subsumed under the construct of diversity (age, class, disability, ethnicity, gender, look, nationality, race, sex, skin color, sexual orientation, etc.) for a look at how some of our preconceived and often unconscious notions of difference and otherness can show up in our personal lives and workplaces. Intended for front-line service providers and managers, this workshop is designed to get participants thinking about ways to break down sometimes invisible barriers to effective service

inside and outside the library. Take-aways include a personal-action plan and and a diversity and inclusion implementation plan for your library or organization.

Some library directors may wonder if the effort it takes to build a racially diverse library staff is worth the benefits. Others may be convinced that a diverse staff is more representative of their institutions or faith commitments, but have no idea about how to integrate racially diverse staff into their libraries. Some directors may have experienced the challenges of hiring, integrating and retaining racially diverse staff members in their institutions. During this panel presentation, participants will focus on best practices to hire, retain, integrate, and promote a more racially diverse library staff. The issues to discuss will include, but are not limited to, the wording and placement of advertisements, the recognition and removal of obstacles in the institutional culture, and concrete ideas for the celebration of the differences among staff while maintaining a cohesive group.
