### From the President By Our Groups They Shall Know Us: The Nature of Voluntary Associations

In the eight months since I began serving as ATLA President, I have been thinking a lot about the nature of associations. Paul Meyer (a consult with Tecker International who has been working with our Board) and others have defined

an association as "a group of people who voluntarily come together to solve common problems, meet common needs and accomplish goals." In my December column, I talked about the metaphor of an association's DNA as a "triple helix" whereby members of associations are the owners, the customers, <u>and</u> the workforce of the organization. This month, I would like to explore in more detail the notion of members as the workforce of ATLA.

Our Association started as a volunteer association, a group of people who came together to solve common problems, meet common needs, and accomplish shared goals. *Index to Religious Periodical Literature, Religion Index One: Periodicals*, and *Religion Index Two: Multi-Author Works* are some of the fruits of our forebears' labors. We are very grateful for the volunteers who created these tools. While ATLA now employs professional staff, volunteers continue to be essential to its workforce. Leaders of our interest, denominational, and regional groups; members of our committees; and the Board of Directors are all volunteers. Our association is better because of everyone who volunteers. Thank you!

We serve the Association with no expectation of financial payment. What would motivate someone to do such a thing?! Many of us would say that we do get something in return for our efforts. For example, I love learning and working with great people, and my work on committees, interest groups, and the Board has provided me with many opportunities for learning and working with great people. I also value being part of something larger than myself such as an association that shares some of my values, such as collaboration in problem solving. These are intangible, but important rewards for my work. I suspect most of our members who have volunteered for ATLA have received some kind of similar reward for their work.

### **Letter from the President Continued**

Our Association always needs new volunteers. We need to keep a vital member workforce. The Board asks you to consider how you might volunteer to serve the Association. Will you volunteer to serve on a committee of the Association? Will you volunteer to lead an interest, denominational, or regional group? Will you write for *Theological Librarianship*, ATLA's journal? Will you consider running for the Board of Directors? It is part of our culture to be asked to serve, but we are asking you to discern how you might best serve our Association and step forward on your own accord. Contact ATLA staff, contact your interest, denominational or regional group, the editorial board of *TL*, and volunteer. You do not have to wait to be asked.

As I mentioned above, I have been reflecting a lot on associations lately, perhaps too much for my own good. My reflections led me to reread excerpts from James Luther Adams, a twentieth-century professor, minister, and influential theologian. Voluntary associations were very important to Adams: "The voluntary association at its best offers an institutional framework within which the give and take of discussion may be promoted, an institutional framework within which a given consensus or practice may be brought under criticism and be subjected to change. It offers a means for bringing a variety of perspectives into interplay. It offers the means of breaking through old social structures in order to meet new needs" (Beach, 185).

Drawing on Matthew 7:16 ("By their fruits you shall know them"), Adams goes on to say, "by their groups shall you know them" (194). While the context for Adams' remarks may differ from ours, I think they are still relevant. Won't you join me in being known by an important voluntary association - ATLA? I welcome your thoughts on this and other newsletter columns.

### Help ATLA Prepare Recommendations for Revisions to ATS Library Form

Are you interested in seeing the ATS Library Form revised to include relevant questions about collections, services, and staffing? Would you be interested in participating in a webinar to discuss your concerns and to consider some of the elements that will influence a revision to the ATS Library Form? Are you willing to serve on a member taskforce to help ATLA finalize recommendations for revisions to the ATS Library Form?

Each year The Association of Theological Schools (ATS) and the American Theological Library Association (ATLA) collaborate to collect and share library statistics from ATS member institutions and ATLA member libraries. Recently, ATLA members have expressed concerns over the usefulness of questions on the ATS Library Form and asked for a means of revising the questions.

On Thursday, April 3 from 2:00 p.m. - 3:30 p.m. (CST), ATLA staff will host a webinar for members to discuss their concerns about the current form and consider some of the elements that will influence a revision (the future of NCES's Academic Library Survey, time and cost considerations). The webinar will include opportunities for

members to share their insights and to respond to instant polls. Individuals unable to attend the webinar but interested in contributing may e-mail <a href="mailto:memberrep@atla.com">memberrep@atla.com</a> to share their feedback and offer any insights they may have.

Following the webinar, ATLA staff would welcome volunteers to serve on a taskforce to finalize recommendations for a revision to the ATS Library Form. The taskforce will prepare recommendations for delivery to ATS by June 1, 2014. With the recommendations received, ATS can provide a timeline for implementing the changes and making them part of future ATS Data Collections.

ATLA appreciates the willingness of members to support this effort and the cooperation of ATS in providing guidance on this revision effort.

### **ATLA Travel Grants Available**

ATLA is pleased to offer grants of up to \$600 each to support attendance at the 2014 ATLA Annual Conference in New Orleans, Louisiana, June 18-21. Any ATLA Student or Individual Member (as of January 1, 2014) who receives no financial assistance from their institution to attend the conference is eligible to apply. ### **Board of Directors Meet in Chicago**

The ATLA Board began its winter meeting on Thursday, February 20, with an afternoon session facilitated by Paul Meyer, a consultant for association leadership and strategic planning. Paul guided the Board's consideration of its responsibilities, the core values of ATLA, and the future of the Association in a changing environment. The Board will continue this work with Paul at its June meeting.

Executive Director Brenda Bailey-Hainer addressed questions that remained from her January 2014 monitoring report. The Board made minor adjustments to enhance the process for routinely monitoring the Executive Director's performance based on the ATLA's Organizational Ends and executive limitations.

Last fall, the Board decided to propose an increase in individual member dues. The rationale for the dues increase will be presented to the membership during the spring and at the Annual Conference. The ATLA staff will create a website with information and opportunities for member comment. The Board is planning to put the issue of an individual dues increase on the January 2015 e-mail ballot with the increase taking effect in September 2015.

The Board accepted the FY2013 audit completed by McGladrey and noted several adjustments made in the first year of this firm's service to ATLA. Four proposals from the Governance Committee to improve the accuracy and organization of the ATLA Board Policy Manual were all approved unanimously.

The Board continued its effort to articulate the skills and personal qualities of an effective member with the goal of producing a job description. The ATLA Nominating Committee (Armin Siedlecki, Carrie Hackney, and Eileen Crawford) has received a description of board tasks and responsibilities to be used in identifying and inviting members to be candidates. These documents are linked on the Nominating Committee page of the ATLA website.

The minutes of the February 20 - 22, 2014, meeting will be posted in ATLA SharePoint Communities by the end of March.

# ATLA Accepting Applications for Scholarships to Promote Diversity in Theological Librarianship

ATLA is pleased to offer two scholarships to help promote diversity in Theological Librarianship.

Scholarship for a Theological Librarianship Course The American Theological Library Association will provide one scholarship for \$1,200 to a student from an underrepresented population to attend a Theological Librarianship course at any ALA-accredited master's program in library and information studies, including the University of Illinois at Urbana-Champaign's LEEP course, Theological Librarianship (LIS 590TL).

- Applicant must be from an underrepresented population (religious, racial, ethnic, and gender).
- Applicant must be an ATLA member in good standing.

### ATLA Diversity Scholarship

The American Theological Library Association will provide one scholarship for \$2,400 to a student from an underrepresented population enrolled in an ALA-accredited master's program in library and information studies.

- Applicant must be from an underrepresented population (religious, racial, ethnic, and gender).
- Applicant must be an ATLA member in good standing.
- Applicant must secure a letter of recommendation from the director of an ATLA Institutional Member library.
- Applicant must enroll and complete at least 6 credit hours in the 12 months following notification.

Applications for both scholarships must be received by May 1 of each year. Applicants will be notified of results by July 1.

### In Good Faith Project Prepares Preservation Survey for Small Theological and Religious Studies Libraries

Through funding from the Institute of Museum and Library Services (IMLS), the American Theological Library Association (ATLA) and project partners the Catholic Library Association (CLA) and the Association of Jewish Libraries (AJL) are preparing a preservation survey for small theological and religious studies libraries, archives, and cultural institutions. The survey is the centerpiece of an IMLS National Leadership Grants for Libraries Planning Grant for the project, "In Good Faith: Collection Care, Preservation, and Access in Small Theological and Religious Studies Libraries."

The survey will help the project partners gain a better understanding of collection care, preservation, and access practices in small theological and religious studies libraries, archives, and cultural institutions and begin to identify valuable and vulnerable collections held in these institutions. The partners will use the results of the survey to explore collaborative initiatives to respond to identified long-term collection care, preservation, and access needs.

The survey is expected to be available March 12, 2014 through April 14, 2014. Participants should be part of a formal or established institution; have a library, archive, or other research collection which includes religious and/or theological materials; have religious and/or theological historical or rare materials as part of the library, archive, or research collection; and have at least one contact person (volunteer or salaried, full-time or part-time) responsible for the care/management of the research collection that can serve as the contact for the survey.

The partners will promote the project through their memberships as well as through discussion lists and forums that include religious and theological libraries, archives, and cultural institutions. # Final Reminder: The Future of Libraries in Theological Education: A Conversation with Chief Academic Officers, Information Technology Officers, and Library Directors

Deadline for applications is March 15, 2014.

ATLA and the Association of Theological Schools in the United States and Canada (ATS) are planning to convene a conversation of academic leaders, information technology officers, and librarians to be held as a one-day pre-conference event on Tuesday, June 24, 2014, ahead of the 2014 ATS/COA Biennial Meeting in Pittsburgh, PA.

This conversation will be a first step toward understanding the roles of libraries and librarians in theological education as perceived by diverse constituents, including academic leaders, information technology officers, and librarians. Participants will share their perceptions and create a shared vision for the future theological library - including its contribution to curriculum and to scholarly research - in the changing world of theological education. The results of the conversation will be reported out to a broader audience in a session held the following day during the COA Biennial Meeting as well as through official ATLA publication channels.

The conversation will seek to engage up to ten participating institutions, each contributing a team of three administration members - a library director, an information technology officer, and a chief academic officer. Based on the success of this initial conversation, ATLA and ATS may convene future conversations.

### **Member News**

In Memoriam - Daniel J. Harrington, S.J. Noted Scholar and Longtime Editor of *New Testament Abstracts* 

The American Theological Library Association remembers the life of Daniel J. Harrington, S.J., professor of New Testament at Boston College (and the Weston Jesuit School of Theology), and longtime editor of *New Testament Abstracts*. Fr. Harrington died on Friday, February 7, 2014.

Fr. Harrington received his BA in classics and philosophy in 1964 and an MA in philosophy in 1965 from Weston College/Boston College. He received his PhD in Near Eastern languages and literatures from Harvard University in 1970. His BD/MDiv is from Weston Jesuit School of Theology/Boston College, granted in 1971. After teaching for a year at St. Mary of the Lake Seminary in Mundelein, IL, in 1971-1972, he spent the remainder of his academic career as Professor of New Testament at Weston Jesuit School of Theology, which was re-affiliated with Boston College in 2008 as part of the Boston College School of Theology and Ministry. After briefly serving as Assistant Editor of New Testament Abstracts he became the general editor of the journal in 1972, and remained in that capacity until he was no longer able to continue in October 2013. New Testament Abstracts Online is produced by ATLA in partnership with Boston College.

He was the author of nearly 60 books, some 225 articles and essays, more than 250 book reviews, and over 150 essays on Sunday Scripture texts for America magazine (2005-2008), as well as the editor of (and contributor to) the Sacra Pagina commentary series on the New Testament (1988-2007), and, while doing all of this, also writing 50,000 abstracts and 25,000 book notices for *New Testament Abstracts*.

### **Paul Stuehrenberg Retires**

Paul Stuehrenberg will retire on June 30 after 32 years at the Yale Divinity Library, including 21 as the Director. During his tenure, Paul oversaw the complete renovation of the Divinity Library, which provided new space for instruction and patrons (with less space for books). As part of this process, Paul sent 100,000 books to Yale's Library Shelving Facility (high-density shelving) and 100,000 to the Seeley Mudd Library, moving the Divinity Library into permanent collection management mode. Paul also established the Kenneth Scott Latourette Initiative for the Documentation of World Christianity, which microfilmed and/or digitized collections in Edinburgh, Geneva, Uganda, India, Australia, Lesotho, and Cuba.

Paul was active in the ATLA, serving three terms on its Board of Directors and one term as President. He served on the Steering Committee of the Collection Development Interest Group, helped to found the World Christianity Interest Group, and served on the International Collaboration Committee.

He was also active in the Society of Biblical Literature, the American Academy of Religion, and the Pacific History Association. He contributed scholarly articles to numerous journals. In addition to serving as Divinity Librarian, Paul also held an appointment as Associate Professor (Adjunct) of Theological Literature at Yale Divinity School. He served for many years as the Director of the Lutheran Studies Program and the Visiting Fellows Program at Yale Divinity School.

# From the Executive Director Force 11: A Grassroots Effort to Transform Scholarly Communication

The traditional system of scholarly communication is increasingly described as being in a state of crisis. The rising cost of journal subscriptions coupled with the declining buying power of library budgets, lack of affordable public access to published

scholarship, and publishers holding restrictive rights preventing authors from freely disseminating their work are all factors that contribute to the problem. Technology and widespread availability of the Internet have further complicated the situation by creating new and low cost methods of disseminating research, which has disrupted the traditional business model for scholarly publishing for both commercial and nonprofit publishers. Scholarly communication is a complex issue involving many players and there is no simple solution. However, one organization is actively working to create change.

Force 11 is a nonprofit community open to anyone who has a stake in scholarly communication, including stakeholders associated with emerging technologies, policies, funding mechanisms, and business models. This grass roots effort crosses the boundaries of all disciplines and aspires to accelerate the pace and nature of scholarly communication and e-scholarship through technology, education, and community.

<u>The Force 11 Manifesto</u> outlines the basic tenets of the initiative. They categorize the problems and potential solutions into two groups, each containing three principal themes:

Themes 1-3 concern the format and technologies of scholarly publication:

- how scholarly data, information, and knowledge are (or could be) represented
- how readers, users, authors, editors, and computers can interact with these representations

 how different knowledge representations could be combined, queried, stored, and otherwise treated.

Themes 4-6 concern the enterprise of scholarly publishing, including business models and the attribution of credit, how scholarship is evaluated, accredited, and monetized:

- current and new models and modes of assigning copyright and intellectual property rights
- financial aspects of scholarly publishing
- mechanisms for assessing the quality and value of researchers and their research outputs, and of attributing credit and worth to them.

Some of the solutions Force 11 proposes are to rethink the form and unit of the scholarly publication, develop new tools and technologies that better support the scholarly lifecycle, create new financially sustainable models of open access, and derive new methods for evaluating the quality and impact of research.

I encourage you to review the Force 11 site and read their *Manifesto*. Does this resonate with you? Can their initiative assist ATLA in our efforts to transform scholarly communication? On Monday, April 21 at 11 a.m. CDT, I will be convening a virtual conversation about Force 11 and its potential for transforming scholarly communication in religion and theology. I hope you'll join me and share your thoughts.
