**MESSAGE FROM THE  
DIRECTOR OF MEMBER SERVICES**

When the February *Newsletter* was published I did not believe that we'd ever thaw out from the Chicago "winter of '94"! But here we are, sailing along with renewed energy and closing the gap on June and the 1994 Annual Conference in Pittsburgh. Of course, this office's being glutted with conference registrations might have something to do with our realizing how close the conference is. My special thanks goes to Mary Kirklin, our new administrative assistant in the Member Services division, for her untiring patience in processing the registration forms.

The Conference Committee, the Education Committee, and the host institutions have worked diligently to have a rich and diverse program and to take advantage of local talent including resources at the University of Pittsburgh and Carnegie Mellon University. There also will be a record number of exhibitors--close to 30--who will cover the gambit from publishers to antiquarian book dealers to automated systems vendors. Rare Books and Special Collections has a full program with a presentation by the proprietors of the Philadelphia Rare Books and Manuscript Co. as well as a short paper on the 16th century imprints in the PTS library. Naturally the Interest Group sessions will give members the opportunity to meet again and do the kind of networking that librarians look forward to at the Conference. And a new event this year will be the Roundtables with their informal discussion along topical lines. The Saturday morning Business Meeting will feature a user-friendly presentation on the electronic library environment led by Board Member Myron Chace.

Steve Crocco reports that the Oakland section of Pittsburgh around the Conference site at the University Club is greening up after the winter and will be a pleasant area to meet in and to enjoy on our daily walks. Steve points out that in addition to museums, libraries, and bookstores we also will be within easy walking distance of other interesting sites. The Biblical Gardens at Temple Rodef Shalom, the School of Information Science at Pitt, the Stephen Foster Memorial, and the Phipps Conservatory are a few sites you might enjoy. A special treat for Thursday when we meet at Pittsburgh Theological Seminary will be the various exhibits related to the Seminary's bicentennial. Also on exhibit in the Seminary Library is the desk where Karl Barth wrote his *Church Dogmatics*.

The Conference program and the site have much to offer, and I hope you will enjoy both to the fullest. I personally look forward to attending my first ATLA Annual Conference and meeting in person so many of you whom I have met over the phone!

## NEW ATLA PRODUCTS

### **Biblical Studies on CD-ROM**

ATLA will publish in June its first CD-ROM in the ATLA Religion Database Special Bibliographic Series on CD-ROM: *Biblical Studies*. The Special Bibliographic Series on CD-ROM has been developed to meet the research needs of individual scholars and libraries for electronic reference tools in special area/studies.

The *Biblical Studies* CD-ROM contains more than 90,000 journal and essay citations extracted from the *ATLA Religion Database* 1949 to current, with more than 60,000 journal article records from ATLA's premier *Religion Index One: Periodicals* 1949— and more than 30,000 essay and 6,000 book (collected works) records from *Religion Index Two: Multi-Author Works* 1960—. Each record in the *Biblical Studies* CD-ROM was selected because it represents an article relevant to the Bible, its history and criticism, or its use in religion and culture. The content on the *Biblical Studies* CD-ROM was designed to meet a broad range of diverse user needs and interests as well as specific subject areas, including:

- Interpretational use of Hebrew and Christian scriptures: the Apocrypha and Pseudepigrapha, by the major traditions of Christianity and Judaism and related sources;
- Comparison of the Bible with other sacred texts, such as rabbinic literature and Qur'an;
- Archaeology and antiquities by geographic location;
- Etymology and use of Hebrew, Aramaic, Greek, and other biblical cognate languages involved in textual criticism, such as Akkadian, Coptic, Syriac and others;
- Inscriptions and texts relevant to biblical study by language groups;
- Biblical world—the history and archaeology of the ancient Near East;
- Biblical critics—their lives and work;
- The use of the Bible in the church and the wider culture, such as biblical teaching on baptism, conversion, death, hope, justice, liturgy, marriage, salvation, sexuality, etc.;
- Biblical sources for theological interpretation and application, from the Dead Sea Scrolls to liberation theologies;
- Biblical exegesis: research and discussion on the history, methodology, and development of redaction, form, literary, rhetorical, and textual criticism.

*Biblical Studies* CD-ROM uses the same search software/interface as the one used for the *ATLA Religion Database on CD-ROM* (CD Answer by Dataware Technologies). *Biblical Studies* CD-ROM includes a *User's Manual* and "Quick Reference Guide" that provide detailed information and many examples for searching the database.

The cost of the 1994 *Biblical Studies* CD-ROM is \$165 for individuals and \$260 for institutions. Annual updates, begin with next issue in September, 1994. *Biblical Studies* is available only for IBM-compatible PCs using MS-DOS, RAM and minimum 20 Mb hard disk.

**Women and Religion on CD-ROM**

In June 1994 ATLA will issue another new CD-ROM in its ATLA Religion Database Special Bibliographic Series on CD-ROM: *Women and Religion*.

Last published in hard copy in 1984 (edited by Erica Treesh, editor of *Religion Index Two: Multi-Author Works* (RIT)), the new electronic version of *Women and Religion* contains more than 18,000 journal and essay citations on this topic. The articles and essays on this CD-ROM, extracted from the *ATLA Religion Database* 1949 to current, cover:

- The role and status of women in world religions (Christianity, Judaism, Islam, Hinduism, Buddhism, new religions, ancient religion);
- Mythical and divine women, women who have played a role in religious history, women saints;
- Feminist theology: its origins and development;
- Issues of women's roles and leadership in theological/pastoral/religious contexts.

The CD-ROM search engine (developed by ATLA) permits users to search for special subjects/topics or known items, review them, and either download or print them. The CD-ROM is available for only IBM-compatible PCs using MS-DOS.

**Ethics Index on CD-ROM**

The *Ethics Index* on CD-ROM will be issued in June, 1994. This unique new product is designed to provide electronic access to current journal and essay literature from collected works to the interdisciplinary field of ethics, including: agriculture, environment, international relations, public policy, criminal justice/corrections, social sciences, business and related professions; and on a secondary level: law, medicine, and philosophy.

The scope of the materials to be indexed includes journal and multi-author works (polygraphs) beginning in 1990.

The search engine used for the *Ethics Index* will be the same as that used for the *ATLA Religion Database on CD-ROM* (CD Answer by Dataware Technologies).

An annual subscription to the *Ethics Index* CD-ROM, which will include 3 CD-ROM issues/year, a *User's Manual*, and a *Quick Reference Guide*, is \$1200; for ATLA member libraries, \$900.

The first issue of the *Ethics Index* on CD-ROM, is scheduled for June, 1994. It will include more than 4,500 records, with total annual records anticipated to be more than 18,000. The CD-ROM is available only for IBM-compatible PCs using MS-DOS.

#### ***ORTHODOX LIBRARIANS TO HOST VESPERS AT ATLA CONFERENCE***

For the first time within recent memory there will be a worship service in the Orthodox tradition at an ATLA conference. On Saturday, June 18, 1994, at 4:30 P.M. there will be a vespers service at St. Nicholas Greek Orthodox Cathedral in Pittsburgh. Arrangements for the service have been made by Fr. George Papademetriou, Director of the library at Holy Cross Orthodox Seminary in Brookline, Massachusetts. Fr. George is also the coordinator of the Orthodox Librarians' Group, the newest of the denominational groups in ATLA.

The beautiful vespers service, which falls on the eve of the Feast of Pentecost in the Orthodox calendar, will feature the choir of St. Nicholas; and if his schedule permits, Bishop Maximos of the Greek Orthodox Archdiocese will be in attendance. It is especially appropriate to have this service at a meeting in Pittsburgh, a city with a large and diverse Orthodox population. Western Pennsylvania has even been called the "heart of Orthodoxy in America" resulting from the fact that so many of the immigrants who settled there and worked in that area's mines and mills came from Orthodox homelands.

Technical services librarians and catalogers will have several opportunities to sharpen their skills at the ATLA Annual Conference in Pittsburgh. All of the following events are listed in the ATLA Conference Program.

Technical Services Pre-Conference: Tuesday, June 14; 7:30 -9:00 P.M. Last year in Vancouver this session proved to be very popular. This year the Technical Services Interest Group will again provide an opportunity for ATLA members interested in technical services and cataloging to talk about issues of common concern before the conference begins. We have set aside the evening before the day of continuing education workshops. We will get to know each other a little better and break into small groups based on our major concerns. One issue that we may want to discuss is the recent

document issued by OCLC, *The Future Is Now: the Changing Face of Technical Services*. Please bring a copy of this document if you can. This meeting will be at the University Club. All conferees are invited to attend; there is no charge for this meeting.

Continuing Education Workshop: "Audiovisual Cataloging: The Basics"; Wednesday, June 15, 9:00 A.M. - 5:00 P.M. This is the opportunity to learn to catalog that backlog of audio/videocassettes. Mary S. Konkel, Head of Cataloging at the University of Akron and Vice-President/President-Elect of the Online Audiovisual Catalogers, will show us how. Please be sure to bring a copy of the OCLC/RLIN, etc. MARC format documentation for sound recordings and videocassettes. You should bring the actual manuals that you will be using, so that you can make notes in them: the OCLC AV formats, RLIN formats, or the USMARC Concise Format document published by the Library of Congress.

Roundtable Discussion Groups, Thursday, June 16, 4:30 - 5:30 P.M. Two of the Roundtable discussion groups pertain to catalogers and technical service librarians. "Technical Services Workflow" will be lead by John Thompson, Technical Services Librarian at United Library of Garrett-Evangelical & Seabury-Western Theological Seminaries. "Issues in Liturgical Uniform Titles" will be lead by Christine Schone, St. Charles Borromeo Seminary.

Technical Services Interest Group, Saturday, June 18, 11:00 A.M. - 12:30 P.M. This will be a business and planning session for the coming year's activities and the '95 conference.

## REPORT FROM THE ATLA LIAISON TO CC:DA

The ALA Committee on Cataloging: Description and Access (CC:DA) met on February 5 and 7, 1994 in Los Angeles. Sally Berlowitz attended as liaison from ATLA. The report includes committee highlights and follow-up from the Internet.

AACR2. Amendments. The availability of the 1993 Amendments to AACR2R was announced at CC:DA. The most sweeping change for me was the shift in placement of the general media designation (GMD). The GMD now immediately follows the first title in the 245 and precedes all other titles and subtitles. Placement of the MARC subfield delimiter "b" is also affected:

La mer \$h [sound recording] ; \$b Khamma ; Rhapsody for clarinet and orchestra / \$c Claude Debussy.

Clock symphony \$h [sound recording] : \$b no. 101 ; Surprise symphony : no. 04 / \$c Haydn.

Please note that the published amendments contain some spacing and typing errors. Corrections may be published in an updated paper edition or limited to the electronic version of AACR2.

Electronic AACR2. Work on the electronic version of AACR2 was progressing well. By mid-March only Chapter 24 and the Appendices remained unfinished, although some non-Roman (i.e. Arabic) characters loomed as problems in electronic conversion, and the completed text needed proofing for consistency in coding.

Future of AACR2. In response to a position paper presented at the Mid-Winter CC:DA meeting, a resolution was forwarded by CC:DA in March to the Joint Steering Committee for the Revision of the Anglo-American Cataloging Rules. The resolution "outlines specific areas of concern in the current cataloging code [and] suggests that the...Rules are in need of thorough reconsideration". The resolution stresses that "the rules are becoming dated and can be better adapted to the computerized environment, particularly given new technologies, which the present rules do not address...; [the resolution further suggests that] the Internet and other computerized networks can be made to play a major role in streamlining the process for rules formulation and updating."

Music Cataloging Proposal. The music cataloging community objected to the inconsistency in the establishment of uniform titles according to AACR2R rule 25.27A and rule 25.30D2. The Music Library Association, therefore, proposed that rule 25.30D2 be changed to say that the key is added to a uniform title only if the key is part of the composer's original title; major or minor mode is to be added to the uniform title only if the mode also is part of the composer's original title. CC:DA voted to forward this proposal for review by the Joint Steering Committee for the Revision of AACR2.

Cataloging Internet Resources. The CC:DA Task Force on the Cataloging of Internet Resources proposed changes in rules 9.0B1 and 9.7B1c to provide for cataloging of files on the Internet. Subject to its acceptance by the Joint Steering Committee, Rule 9.0B1 would read:

The chief source of information for computer files is the title screen(s). If there is no title screen, take the information from other formally presented internal evidence (e.g. main menus, program statements, first display of information, the header to the file including "Subject:" lines, [and] information at the end of the file).

If the computer file is unreadable without processing, e.g. it is compressed or printer-formatted, take the information from the file after it has been uncompressed, printed out, or otherwise processed for use.

The following example would be added to Rule 9.7B1c:

Mode of access: Internet, Host: <quake.think.com> (Electronic location and address of a file residing on a network).

Guidelines for Bibliographic Description of Reproductions. Although CC:DA did not believe it should recommend rule revisions at the present that would affect the cataloging of reproductions, CC:DA endorsed the Guidelines that were created by the CC:DA Task Force on Bibliographic Description of Reproductions; CC:DA will forward these Guidelines to ALA ALCTS for publication. The Guidelines are meant to be “illustrative” not “prescriptive”, and catalogers should determine when and how to implement use of the Guidelines in cataloging reproductions.

Interactive Multimedia Guidelines. Guidelines for cataloging interactive multimedia were drafted by a CC:DA Task Force to pull together everything that is related to cataloging interactive multimedia. Users were told to prefer the Guidelines, if they should encounter conflicts between the Guidelines and AACR2. The Guidelines propose creation of the new GMD (general media designation) “interactive media” and offer options for multiple physical descriptions. A distinction is also drawn between the use of the terms “disc” (for computer laser optical disc like CD-ROMS) and “disk” (for magnetic computer disks). CC:DA approved these Guidelines in principal, but allowed the Task Force to refine the Guidelines further before forwarding to ALA ALCTS for publication.

Cataloger’s Desktop. New software for catalogers was in Beta testing in February at thirty sites (including the Library of Congress) and was expected to be available in May. This software includes the LC Rule Interpretations, the LC Subject Cataloging manuals, the USMARC Authorities Format, the USMARC codes, all the USMARC Concise Formats, and later in 1994 the new edition of the USMARC Format for Bibliographic Data, and in 1995 the CONSER Editing Guide. It operates on DOS 5.0 or higher with Microsoft Windows 3.1 or OS/2.1 Cost was still unknown, but was reputed to be less than the cost of the hardcopy texts combined.

Report from the Library of Congress Representative (Sarah Thomas). The Library of Congress Cataloging Directorate has undertaken many changes in workflow and staffing patterns to cope with arrearages and budget pressures. One cost-cutting suggestion involved not tracing unnumbered series and, secondarily, not establishing unnumbered series (thus avoiding extra authority work). This proposal generated tremendous response on the Internet, most of which has been in opposition to the lack of authority records for such series. Subject subdivision practice is also under scrutiny at the Library of Congress, while electronic CIP promises to speed up processing of CIP galleys and avoid much rekeying. LC also hopes to make its manuals more user-friendly, less LC-centric, and thus easier for the broader cataloging community to use. Sarah Thomas stressed the importance of consulting in the future with the broader library community to see how the decisions of the Library of Congress might effect the library community at large.

### *STRAHOV ABBEY LIBRARY, PRAGUE*

ATLA member, Rev. Evermod Gojza Sidlovsky, O. Praem., is the chief librarian of the Strahov Library in Prague, Czech Republic. Rev. Sidlovsky has sent ATLA the following description of this historic abbey and the library's collection.

The Strahov Abbey, the oldest Premonstratensian monastery in Bohemia, was founded in 1140 by King Vladislav II for the Premonstratensian Canons. This order had been recently established by St. Norbert of Xantem (his relics were transferred to the Strahov Abbey in 1627). Although the monastery has undergone damage and several reconstructions during the centuries, the lay-out remains Romanesque. The contemporary Baroque appearance dates from the second half of the 18th century when the last reconstruction was completed.

The Strahov library can trace an unbroken history from its 12th century beginnings to the present day. There are two library halls: The Theological Hall and The Philosophical Hall. The construction of the Theological Hall was finished in 1671; the books collected there cover the entire field of theology. The Philosophical Hall was built in 1794 and houses a diverse book collection. Today the holdings of the Strahov Library total about 140,000 volumes, 2,600 incunabula, and 3,900 manuscripts. The oldest manuscript is the *Strahov Evangelistary* which dates back to ca. 860 AD.

1950 saw the dissolution of the monasteries in Czechoslovakia. The Strahov Abbey was taken over by the State, and a Museum of Czech Literature was placed there. The Museum was in charge of the Strahov Library and added books from other abolished monasteries as well as created a book collection of its own. In 1990 the Strahov Abbey was returned to the Premonstratensian Order with the Museum remaining in the monastery as a tenant. In 1991 the Strahov Library, with its original book collection, was transferred back into the possession of the Order, and since then it has been run entirely by the community. A professional staff has been hired, there are regular acquisitions again, and the library is gradually being equipped with relevant technology. Generally speaking, the aim is to convert the library into a properly functioning one that provides services to both the academic community and the general public. The current tasks are the restoration of the library halls, the conservation of the entire book collection, and the cataloging of the historic collections.

Rev. Sidlovsky invites visitors to Prague to stop by the library. He writes that the monastery, the Strahov Library, Strahov Art Gallery, and the gardens are worth at least a half-day visitation. Rev. ## GRANTS AWARDED TO ATLA LIBRARIES

### *Burke Library, Union Theological Seminary*

The Archives of the Union Theological Seminary's Burke Library has been awarded a 1994 Documentary Heritage Program (DHP) Grant by the New York State Archives and Records Administration. The grant will provide funds for a consultant to conduct a needs assessment survey for the archival collections. The work on that survey will be supported by guidance from an Advisory Board comprised of experts in theology and archives. The Project Director is Cyndie Frame, Preservation/Collection Management Librarian at the Burke Library.

### *Wesley Theological Seminary Library*

The Arthur Vining Davis Foundations awarded a grant of \$125,000 for library automation to the Wesley Theological Seminary Library, Washington, D.C.

### *Yale Divinity Library*

In 1993, Yale Divinity Library was awarded a 2-year grant by the National Endowment for the Humanities to participate in the Great Collections Microfilming Project, Phase 4, administered by the Research Libraries Groups. The grant is permitting the library to microfilm and catalog 3,000 deteriorating periodical volumes from the Day Missions Collection. These periodicals include official publications and statistics of mission agencies, and reports and anecdotes by and about missionaries. They also document Western contacts with non-Western cultures, and so serve as primary sources for the study of international relations, social and economic history, cultural anthropology, and comparative religion. All 3,000 volumes have now been cataloged in RLIN. The microfilming is well underway, and the project is expected to be completed by March 1995. Beatrice Luh, Preservation Librarian, and Rolfe Gjellstad are deeply grateful to all libraries who assisted by lending or donating periodical issues which the library lacked. They are especially appreciative of the library of Union Theological Seminary, New York, which lent generously from its Missionary Research Library.

## METHODIST PUBLICATIONS AVAILABLE ON MICROFILM

The Methodist Archives at Bridwell Library has microfilmed its holdings of three publications: *Texas Christian Advocate; Minutes of the Trinity/North Texas Annual Conference, 1867-1939; and North Texas Methodism: History of the North Texas Conference and the Dallas District*, Dallas, Texas, 1926 (201 p.). They are available for purchase from the Methodist Archives, Bridwell Library, Southern Methodist University, Dallas, Texas, 75275-0476.

The *Texas Christian Advocate* was a weekly newspaper published by the Texas conferences of the Methodist Episcopal Church, South. The copies that have been microfilmed came to Bridwell Library from the family of longtime TCA publisher, Louis Blaylock. The *Advocate* contains much information about local church and denominational activities, as well as reports on regional, national, and international events. The advertisements alone are fascinating. Anyone interested in genealogical research will want to study its columns of births, deaths, and marriages.

The *Minutes* are the official printed reports of the Annual Conference sessions of the North Texas Conference of the Methodist Episcopal Church, South.

*North Texas Methodism* was published in Dallas, Texas by the Southern Methodist

Historical Company in 1926. The book contains not only a history of the Dallas District but also brief individual histories of its churches. It includes the membership roles of churches, names of officers of Sunday schools and Epworth Leagues, and Missionary Societies' rosters. In describing the contents, the Preface concludes, "The work contains enough data of our great Methodism to make it historically of value and we believe it will merit your approval."

#### **ENVIRONMENTAL RESOURCE MANUAL PUBLISHED**

*Care of the Earth; An Environmental Resource Manual for Church Leaders* has been published by the Lutheran School of Theology at Chicago. This 98 page paperback manual is a practical resource offering theological perspectives and action steps for the congregation. #### **WALDENSIAN-METHODIST COLLECTION ESTABLISHED AT UNITED THEOLOGICAL SEMINARY**

In cooperation with the American Waldensian Society and its Executive Director, the Rev. Frank G. Gibson, Jr., the United Theological Seminary Library, Dayton, Ohio, has established a Waldensian-Methodist Collection consisting of periodicals, newsletters and related materials on the Waldensian-Methodist churches in Italy and Waldensian churches

in South America. These holdings include a complete set of the *Bollettino, Societa di Studi Valdesi*, 1884-present, one of the chief contemporary publications on the historic Waldensian experience in Europe, and *Confronti* an interfaith (Protestant, Catholic base community, Jewish, Muslim) journal on faith and contemporary issues in Italy and across the globe.

The Waldensians and Methodists operate a theological seminary in Rome, and have extensive social ministries and 130 congregations in Italy. The Waldensian Church in Argentina and Uruguay likewise runs a number of social ministries and has a constituency spread across 25 larger parishes. As the earliest continuing Protestant experience in the world, the Waldensians trace their story to Valdesius, an itinerant preacher in the late twelfth century. In the 1970s the Waldensian Church in Italy federated with the Methodist Church of Italy, which traces its establishment there to British and American missionary initiative in the 1860s. When the Waldensians began emigrating to the United States in significant numbers late in the last century, leadership in Italy encouraged its people not to establish churches here, but to integrate themselves into standing Reformed churches.

The formation of the Waldensian-Methodist Collection at United is intended to provide access to resources for scholars and interested persons concerning the work and mission of these two federated Italian Protestant churches.
