From the President

On the Move

As many of you know, I physically moved this past summer from North Carolina to Minnesota and so I've been thinking quite a bit about movement and transitions. A couple of weeks ago, the Common Lectionary took me to 2 Samuel 7 where King David is chatting with the Prophet Nathan and proposes a significant upgrade to



the tent holding the ark. King David himself is in a nice house made of cedar and it doesn't seem right that God's ark of the covenant resides in a flimsy tent. God's response is instructive - "no". As Gail Ricciuti comments about the passage, "It seems that this God values the flexibility--the divine capacity to strike camp and be on the move--that tented life affords. While human beings tend to calculate value by size and quality, God estimates a dwelling place according to agility and responsiveness.

This is helpful word for theological libraries and for ATLA. Libraries have long calculated a certain value by size and quality. Larger and well-developed libraries must be better and smaller, less-developed libraries must be...well...not as good. While size and quality metrics can be useful, they can be less relevant in an age where libraries have much less of a monopoly on information. Agility and responsiveness have indeed become the higher values as our institutions seek to respond to the changing needs of our students, faculty, and clients. In light of this change, how can libraries be more agile and responsive to the needs of our institutions? How can librarians be more agile and responsive to our users? How can ATLA become more agile and responsive to needs within religious and theological education? As we emerge from our well-built stacks and head towards what appears to be a flimsy tent, I look forward to learning from each other in our journey.

An Overview of the Process for the Nomination of Candidates for Election to the ATLA Board

- 1. February. The Nominating Committee for Board Candidates writes an article for the March ATLA Newsletter providing information on how members may submit names for consideration to the committee and giving April 1 as the deadline for the submission of nominations.
- 2. April. The Nominating Committee identifies potential nominees to be contacted, including current Board members who are eligible for re-election.
- 3. May. The Committee develops a short list and begins contacting potential nominees. Its goal is to have a slate of six candidates in place by the end of the month.
- 4. June. During the Annual Conference members of the committee meet with the six candidates to confirm their interest in running and to answer any questions they may have. If the slate is incomplete, or if any of the candidates withdraws, the committee continues seeking candidates.
- 5. July 1. By this date the Committee will have submitted an article for the August ATLA Newsletter outlining the nominating process, including information on the petition process once a slate has been announced.
- 6. October 1. The Committee will by now have submitted to the Board Secretary and the Director of Member Programs a slate of at least six candidates for the four places to be filled on the Board.
- 7. October 1. By this date the Director of Member Programs will have asked each nominee to submit biographical information, along with a statement concerning his or her view of the Association's needs and/or mission. These materials will be included with the ballot.
- 8. October 15. The Director of Member Programs will by now have sent a letter to ATLA members on behalf of the Secretary of the Board announcing the candidates and including information about making petition nominations to the Secretary.
- 9. December 1. Deadline for the submission, by petition, of additional nominations by the membership.
- 10. December 1- January 15. Nominees by petition. The Secretary asks the Director of Member Programs to confirm that the nominee and all the petitioners are individual members of ATLA. The Secretary informs the "petition" nominee of board member duties and verifies his/her willingness to serve. The Director of Member Programs requests the biographical information for the ballot.
- 11. January 15. By this date the Director of Member Programs will have prepared the ballots, including biographical data on nominees, and sent them to institutional and individual members.

Nominations by Petition

Nominations other than those submitted by the Nominating Committee may be made by petition signed by no fewer than ten (10) Individual members of the Association and shall be filed with the Secretary of the Association no later than the next following December 1. These nominations may be submitted by fax, email, or surface mail and shall be included on the ballot with the nominees presented by the Nominating Committee.

ATLA Adopts Revised Bylaws

As indicated in the Report of the Secretary of the Board for the 2012 ATLA Annual Conference (below), ATLA membership approved changes to the bylaws which went into effect June 29, 2012.

Changes to the bylaws were proposed by the ATLA Bylaws Committee, including Beth Bidlack (chair), Saundra Lipton, and Eileen K. Saner. The proposed changes were shared with members in Spring 2012 and again at the first business meeting of the ATLA 2012 Annual Conference, with no resultant changes or indications of amendment.

The newly revised bylaws are available on the ATLA web site on the <u>ATLA Community Page</u>.

Changes to the bylaws include:

- Editorial clarifications
 - Listing "United States and Canada" in the definition of Institutional Members to better clarify the distinctions between "Institutional" and "International Institutional" memberships.
 - Updating the names of regional accreditation agencies.
 - Moving Article 4, "Board of Directors" to become Article 3, allowing a greater logic within the Bylaws to describe the Board of Directors and then describe the Board Officers.
- Clearing a path towards voting for bylaws and changes outside the context of an annual meeting or special meeting, including the option for electronic voting for bylaws changes.
- Updating the grace period for membership renewal from 90 days to 60 days.
- Establishing Association Committees and Interest Groups under the creation and oversight of the Executive Director.

Report of the Secretary of the Board ATLA Annual Conference, 2012, Scottsdale, AZ

Minutes of the Business Meeting I: Thursday, June 28, 2012

The business meeting was convened by Board President John Weaver at 1:00 pm.

Carrie Hackney presented the Secretary's report. Members of the Teller's Committee were James Estes, William Faupel (chair), and Karen Madigan. The Committee received the election results via e-mail from Survey & Ballot Systems and verified that 271 valid ballots were received. The membership elected Sandy Ayer, Carrie Hackney, Timothy Lincoln, and Melody Layton McMahon to the Board of Directors for the 2012-2015 term of office. The Secretary's report was accepted.

Beth Bidlack, Chair, Bylaws Committee, along with committee members Saundra Lipton and Eileen K. Saner, presented the proposed revisions to the ATLA Bylaws. William Hook moved to accept the proposed revisions to the ATLA Bylaws. André Paris seconded. The proposed changes will be voted on at the Friday, June 29, 2012 business meeting. The membership was encouraged to attend the Friday business meeting and voting members were reminded to bring the balloting cards to the Friday meeting. Only those with balloting cards will be eligible to vote. Replacement balloting cards will not be available on site at the Friday meeting

President Weaver delivered the presidential address, "Library as Trust." The meeting was adjourned until Friday, June 29th at 1:00 p.m.

Minutes of the Business Meeting II: Friday, June 29, 2012

The business meeting was convened by Board President, John Weaver at 1:00 p.m.

President Weaver called for the establishment of a quorum for institutional and individual members. A quorum of 25 institutional members was established with tellers reporting a total of 51 institutional members present to vote. A quorum of 75 individual members was established with tellers reporting a total of 75 individual members present to vote. The president called for the motion. Beth Bidlack made the following motion:

"Mr. President, the committee appointed to revise the bylaws has agreed upon the draft distributed to the ATLA membership in spring 2012, and has directed me to move its adoption. This draft was offered to the entire membership in online forums for two months prior to the conference, and at yesterday's meeting for comment, with no resultant changes or indications of amendment. Mr. President, by direction of the committee, I move the adoption of this revision of the bylaws."

The President called for the vote. Among institutional representatives, 51 voted in the affirmative and zero in the negative. Among individual members, 112 voted in the affirmative with one abstention. The motion was adopted. The revised Bylaws will immediately go into effect.

Retirees, Sara Myers (Columbia Theological Seminary), Roger Loyd (Duke Divinity School), Norma Sutton (North Park University) and Russell Pollard (Harvard Divinity School) were recognized for their contributions to ATLA.

The new Board officers for 2012-2013 were introduced: Andrew Keck (President), Beth Bidlack (Vice President), and Eileen Saner (Secretary).

President Weaver recognized the outgoing Board members Carisse Berryhill and Laura Wood for their contributions and time served on the Board. Gifts were presented to each outgoing Board member.

President Weaver concluded the meeting by passing the "gravel" to the incoming Board President, Andrew Keck. The Business meeting adjourned at 1:55pm.

Board of Directors Meeting: Wednesday, June 27, 2012

The Board discussions included items and recommendations from the report of the Executive Director; the dates, locations, and annual cycle for Board meetings and agendas. The Board will hold three meetings per year: October, February and June. The October Board meeting was set for noon Thursday, October 18, 2012 to noon Saturday, October 20, 2012, in Chicago at the ATLA Headquarters. Suggested topics for the October meeting might include a discussion of preservation of products and a discussion of identity of the

association. Reports were received on the work of the Governance and Finance Committees. The Board also spent time working on the revision of the ATLA Ends 1.3 thru 2.2 of the Board Policy Manual.

The Board held a luncheon meeting with the participants in "The Creating Leaders of Tomorrow" program. The cohort consists of nine mid career theological or religious studies librarians and is designed to help develop the knowledge and skills necessary to become library directors. Miguel A. Figueroa, newly appointed Director of Member Programs, met with the Board to share how his background as the Director, Office for Diversity and Spectrum Scholarship program and Director, Office for Literacy and Outreach Services at the American Library Association (ALA) will benefit the American Theological Library Association. He hopes to create new programs and services for the members.

From the Executive Director

Preservation and ATLA



For over fifty years, ATLA was involved with the preservation of serials and monographs through the creation of microforms. Funding for these efforts was secured from member institutions, sales of the resulting material, and grants. The final microfilming project ended in April 2010 with the successful conclusion of the last project funded by NEH.

Grant funding for these types of preservation projects is no longer readily available as potential funders have shifted their focus to the creation and preservation of digital materials. Many experts still view microforms as the most reliable format for preservation, but scholars, faculty, and students continue to loathe using them. The newest generation of researchers, many of whom are digital natives, has come to expect materials to be available online anytime, anywhere. However, providing digital access to materials is not synonymous with preserving them.

The information environment in which ATLA members operate is quite different than it was fifty years ago. A number of other organizations that were not in existence at that time have begun to work on solutions for providing long term access to monographs, journals, and other scholarly material. Academic libraries around the world are concerned about the digitization of materials, but other organizations have made great strides in digitizing commercially produced materials. Libraries are now free to concern themselves with the preservation and digitization of local, unique materials that they hold.

As the result of the changing environment regarding long-term access to materials, the role of ATLA in assisting members with preservation efforts may need to change as well. During the coming year ATLA will step back to consider what its role in preservation should be in the future. The first step was to acknowledge the end of grant funded preservation projects at ATLA by eliminating a position that was created to manage these microfilming projects. The second step will be an assessment of member needs to provide current data that can be used for decision making. This effort will begin with a survey that will be sent to every institutional and affiliate member in September.

What should ATLA's future role be? A preservation institution? A training provider? A convener of meetings? A grant coordinator? A participant in a larger collaborative? Or, all of the above? With your input and help, ATLA can create future services that will benefit us all.
