2010 Teaching and Learning Colloquy



Jointly sponsored by the Wabash Center for Teaching and Learning in Theology and Religion and ATLA, the 2010 Teaching and Learning Colloguy on The Role of Theological School Librarians will take place at Wabash College from April 22-26, 2010. According to the course description, participants in the colloguy will "explore the vocation of theological librarianship and promote the development of strategies and skills for increasing the effectiveness of librarians in the teaching/learning/ research process in their own institutional and professional contexts."

The course will be led by Roger Loyd of Duke Divinity School, Amy Limpitlaw of Yale Divinity School, Cait Kokolus of St. Charles Borromeo Seminary, Dennis Norlin of ATLA, and Wabash Center's Paul Myhre.

Application is open for full-time professional librarians working in an accredited seminary or theological school in the United States or Canada. Participants must be members of ATLA who are within the first seven years of a librarian role. They will each receive a stipend of \$1,250 for full participation in the colloquy, plus local expenses and travel. Applications are due on October 12, 2009; participants will be announced on November 15, 2009. Exciting News from Azusa Pacific University

Congratulations to Azusa Pacific University (APU). It is now one of only three institutions of higher learning--Princeton Theological Seminary and the Oriental Institute are the other two--to own original Dead Sea Scroll fragments. The combination gift and acquisition of five Dead Sea Scroll fragments, five first edition King James Bibles, a collection of Bible leaves, two late 17th century Hebrew Sefer Torah scrolls and other rare materials means that APU is going to need to significantly expand its special collections area. A public exhibition is in the works for the summer of next year.

Liz Leahy, Professor of Theological Bibliography and Research and Special Assistant to the Dean at the University Libraries and CP Haggard Graduate School of Theology says, "As you might imagine, we are simultaneously delighted and (more than a little) amazed. I'm a member of our special collections team within the APU University Libraries and will be glad to let you know more details about the exhibition as things get underway--we have much to do before next summer!" From the Professional Development <u>Committee</u>



The Professional Development Committee (http://www.atla. com/prof_dev/prof_dev.html) has awarded two grants to ATLA regional groups for continuing education grants this fiscal year. These grants were used to support programs that examined a wide

variety of topics. The breadth of programming reflects two important mainstays of our work-its constants and the continually evolving ways in which they are achieved. This money helped ATLA librarians meet and think about:

Assessment and Theological Libraries - Issues relating to assessment have become much more urgent for theological schools and their libraries in recent years. This change has taken place partly (but not exclusively) through changes in accreditation standards, but presents new challenges and opportunities for ATLA libraries. This half-day workshop will explore key aspects of this topic.

A Fresh Look at Library Services - This program is a combination of workshops and roundtable discussions with four concurrent sessions: "Creative Use of Google Books for Religion and Theology"; "Copyright Issues and E-Reserves"; "Issues in Managing E-Resources"; "Library Administrators Roundtable". CATLA members served as presenters.

It's easier than ever to apply for a grant, and funds are still available for this year.
