PAUL HAMM RESIGNS ATLA PRESIDENCY

Dr. G. Paul Hamm, in a letter to the Board of Directors dated August 8, 1979, announced his resignation as President of the American Theological Library Association, effective August 31, 1979. In the same letter Dr. Hamm also announced his resignation as Librarian of the Golden Gate Baptist Theological Seminary in Mill Valley, California, effective the same date, and his acceptance of the call to become pastor of the Harvard Terrace Baptist Church in Fresno, California. His new address will be: 2518 North Cedar, Fresno, California 93703. The Reverend Simeon Daly, CSB, Librarian of Saint Meinrad College and School of Theology in St. Meinrad, Indiana, who was elected Vice-president of the ATLA in June of this year, will succeed Dr. Hamm in the presidency of the Association, effective September 1.

A LETTER FROM RETIRING PRESIDENT HAMM

An Open Letter to the Membership of the ATLA:

One of the greatest honors of my life has been to represent you as an officer of the ATLA, particularly as Vice-president and President. I feel a sense of sorrow as I relinquish my office. I have accepted the call of the Harvard Terrace Baptist Church in Fresno, California, as pastor. Our entire family feels a sense of call to the new field. We are overjoyed that we will be able to have a home of our own for the first time in twelve years. This move is not a rejection of the profession of librarianship at all. My library skills will be a valuable asset in the pastorate, and I hope to be involved in library work in the community. The church has the largest and best library-media-resource center that I have seen in a church anywhere.

My emotions are mixed. The history of the ATLA is bright, but the future looks even brighter. The work and scope of activities of our three Boards continue to grow. The Board of Directors continues to reorganize itself for more effective service. The Standing and Ad

Hoc Committees are becoming more efficient. The possibility of foundation funding for several of our projects is exciting. We should have, perhaps within a year, a corps of highly trained, skilled library consultants from within our own ranks. The ATLA will meet with the ATS in 1980 at a very propitious time and discuss some very crucial issues. Here at Golden Gate, plans have begun for a new \$3,000,000 library building, and there are other encouraging developments. We are leaving the ATLA and Golden Gate at an exciting time, and this is not easy. There is not space enough to tell you of the church, except to say that we are excited about it and eager to begin our work there.

My duties and responsibilities are being left in good hands. Simeon Daly will automatically succeed me as president. He is a knowledgeable and capable person, who is well liked and respected in our Association. He and I spent a good deal of time together following the annual conference in June, have been communicating by phone and letter, and will spend more time together. The Board of Directors represents the Association well, the members are capable, and it is well organized. There are some crucial, very important projects and activities under way, but they are well organized and in good shape.

Be assured of my continued interest, prayers, and concern. I will miss my friends in the ATLA. You are a great bunch! However, Fresno is not the end of the world! Come worship with us, or, better still, come to visit us. If you can't come, write. Please keep us informed of the developments of the Association. Shalom.

ATLA HOLDS THIRTY-THIRD ANNUAL CONFERENCE IN ST. PAUL, MINNESOTA

The American Theological Library Association held its thirty-third annual conference on the campus of Bethel Theological Seminary in St. Paul, Minnesota, June 11-15, 1979. Approximately 175 members and friends of the Association were in attendance. Norris Magnuson, Librarian, was host to the conference. Four other institutions in the area, and their librarians, also played host to one session each of the conference: United Theological Seminary of the Twin Cities, New Brighton, Holt Graham, Librarian; Saint John's University, Collegeville, Richard Oliver, Librarian; Saint Paul Seminary, St. Paul, Leo Tibesar, Librarian; and the Luther-Northwestern Theological Seminary Libraries, St. Paul, Norman Wente, Librarian. Elmer O'Brien, Librarian of the United Theological Seminary in Dayton, Ohio, and President

of the ATLA, presided. The conference program was prepared by G. Paul Hamm, Librarian of the Golden Gate Baptist Theological Seminary in Mill Valley, California, and Vice-president of the Association.

The theme of the conference, "The Role of the Library in Theological Education," was reflected in the four major addresses delivered during the program: "A Look at the Past," by G. Paul Hamm; "A Look at the Present," by David Schuller, Associate Director of the Association of Theological Schools in the United States and Canada; "A Look at the Future," by William Grady of the College of Education at Temple University in Philadelphia; and the presidential address by Elmer O'Brien. Eleven workshops were offered during the conference on "An Alternative to the Card Catalog, " "Budgeting, " "Bibliographical Instruction, " "The Library and the Classroom: Creative Interaction," "Theological Library Cooperation," "Storage and Preservation of 19th Century Theological Materials, "Library Space Exploration, " "Assertiveness Communication and the Librarian," "Educational Media on the International Scene," "Competency-based Education and Learning Resources," and "Library Networks: Minitex as an Example." The address following the banquet on Thursday evening was delivered by the Reverend Colman Barry, Director of the Institute for Spirituality at St. John's University. The annual Proceedings of the ATLA to be issued later in the year will include the reports, papers, and addresses delivered at the conference.

The Association named Simeon Daly, Librarian of St. Meinrad College and School of Theology in St. Meinrad, Indiana, as Vice-predident for 1979-80 and President-elect for the following year; but the resignation of G. Paul Hamm from the presidency subsequent to the meeting of the conference has elevated Father Daly to that office for 1979-80. Elected to three-year terms as Members-at-Large on the Board of Directors were Harriet V. Leonard, Reference Librarian of the Duke University Divinity School Library in Durham, North Carolina and Stephen Peterson, Librarian of the Beinecke Rare Book and Manuscript Library at Yale University in New Haven, Connecticut. The Association elected Peter N. VandenBerge, Director of Library Services at Colgate Rochester Divinity School/Bexley Hall/Crozer in Rochester, New York, to a three-year term on the Board of Periodical Indexing and re-elected Robert Dvorak, Director of the Library at Gordon-Conwell Theological Seminary in South Hamilton, Massachusetts, and Ernest W. Saunders, Professor Emeritus of New Testament Interpretation at Garrett-Evangelical Theological Seminary in Evanston, Illinois, to three-year terms on the Board of Microtext. A complete roster of the officials of the ATLA, the membership of the Board of Directors, the constituency of the various boards and committees, and the holders of several special appointments in the Association will be found elsewhere in this issue of the Newsletter.

The usual summary of the official actions taken by the Association and the Board of Directors at their June meetings is omitted from this issue of the Newsletter because the minutes of these meetings have not been made available to the Editor by the Recording Secretary.

PRINCETON INSTITUTE FOR THEOLOGICAL LIBRARIANSHIP HELD IN JULY

More than sixty ATLA librarians from throughout the United States and Canada participated in the first annual Princeton Institute for Theological Librarianship, July 16-26, 1979, at Princeton Theological Seminary in Princeton, New Jersey. Participants represented a wide spectrum of libraries and professional positions. The Institute, for which the instructional costs and travel subsidies were covered by a grant from the Rockefeller Brothers Fund, offered a management skills seminar for all participants the first week and a choice of three tracks the second week. A team from the Office of Management Studies of the Association of Research Libraries directed the management skills seminar, providing a variety of plenary, group, and individual experiences in organizational development, decision-making, interpersonal relationships, and management styles.

The three tracks during the second week focused on the impact of the Anglo-American Cataloguing Rules (second edition), research guides, and collection development. The leadership for these workshops was provided by Doralyn Hickey, Andrew Scrimgeour, and Stephen Peterson and Charles Willard. A plenary session at the conclusion of the second week provided an opportunity for reports and proposals for the second Institute. The AACR-2 workshop expressed a concern for concentrated study on the most effective strategies for introducing library staff, faculty, and students to the new rules; this would necessarily involve a cooperative seminar including both catalogers and reference librarians. The group that worked on the development of research guides proposed the development of a regularly updated, detailed guide to theological bibliography. The collection development workshop considered the potential usefulness of an extract of theological literature from the LC MARC tapes, to be pulled off every four weeks and distributed as a selection tool to subscribing libraries. Each of the three groups has provided the preliminary means for carrying its concern forward.

Each week was the subject of a separate evaluation process, and the results indicate that the Institute met many serious personal and professional needs. Almost without exception, the participants reported a high degree of satisfaction with both facets of the Institute.

SOME "STANDARD" WORDS

The Annual Conference of the American Library Association (ALA), held in Dallas, June 23-28, 1979, was preceded by an institute to provide about 385 attendees with basic information and skills relating to the second edition of the Anglo-American Cataloguing Rules (AACR 2) published in the fall of 1978. The institute began with a viewing of four videotapes prepared by a committee of the Resources & Technical Services Division (RTSD) of ALA. Each tape is approximately one half hour in length, offering comments and information about the (1) history and development of AACR 2, (2) its provisions for description of all types of materials, (3) its section on choice of access points, and (4) its treatment of forms of entry.

After viewing the tapes, the institute participants moved into small groups with discussion leaders who illustrated the three sections of AACR 2 (description, access points, form of entry) by showing and commenting on a series of transparencies (used with the overhead projector) designed to point up the major features of AACR 2. A general session with one of the three resource persons for the institute (John Byrum, Michael Gorman, and Paul Winkler) concluded the discussion of the transparencies. The final session was devoted to a review of attitudes and procedures related to the conducting of workshops on AACR 2 in regional and local settings.

The basic aim of the AACR 2 institute was to prepare a group of potential trainers. These persons were nominated by various library associations, networks, library schools, and regional groups to receive ALA's preparation, so that they in turn could convey the information to people in their own localities. Among the participants were several theological librarians and library educators interested in theological librarianship.

In 1967 when the first edition of AACR was issued, ALA-RTSD offered little help in educating catalogers to the provisions of the new code. A general program was held in conjunction with the next ALA conference, and a number of library schools hosted institutes. The Library of Congress (LC) announcement that it would adopt the rules under a plan of superimposition, however, muted the effect of AACR 1 and reduced the urgency of learning its provisions. Since LC has now announced its plans to introduce AACR 2 with minimal superimposition and to "freeze" its card catalog at the end of 1980, there is more pressure to learn the impact of AACR 2. The Dallas institute was, thus, a first step in making an "official" statement about AACR 2 and its intent.

The next step will be the development of regional and local programs to help all catalogers and, indeed, all library staff members understand the provisions of AACR 2 and some of the reasons behind them. It is also hoped that this process will encourage library staff members to review the status of the various bibliographic systems—

card files, lists, microform catalogs, etc.--in use in their institutions, to determine whether a new start is needed in 1981.

Information about the availability of the four videotapes, the overhead-projection transparencies (expected to be accompanied by an audiotape and/or a script), the names and addresses of participants in the ALA institute (who might help in local workshops), and scheduled workshops on AACR 2 may be obtained by writing to or telephoning the ALA-RTSD office in Chicago. The address is Resources & Technical Services Division, American Library Association, 50 East Huron Street, Chicago, Illinois 60611; telephone: 312/944-6780 (ask for RTSD Office). A new staff officer has been employed by RTSD to assist in the dissemination of such information.

The videotapes are expected to be available through ALA Publishing Services in September. The transparencies should be ready by mid-October if all goes as planned. Almost every state and region will be having some kind of educational program relating to AACR 2, as will the library schools. It is important for theological librarians to take advantage of these opportunities, for a second "round" of education experiences will emerge during 1980 and 1981. Under the aegis of LC, an intensive training program will be offered on a regional basis, to prepare catalogers for understanding LC's application of AACR 2. These programs have already been tentatively scheduled (see the RTSD Newsletter for a projected place/date list). It will be assumed that participants in the LC training sessions have had some sort of introduction to AACR 2 of the type that RTSD offered in Dallas. Theological librarians should take the initiative in making sure that appropriate staff members attend both one of the RTSD/regional/local sessions and one of those offered next year by LC. Waiting till 1981 to learn about and plan for the effects of AACR 2 is not a wise procedure even for the small or relatively isolated seminary library.

There were a number of other developments coming from the ALA conference which will bear noting in later columns. Theological librarians may, however, be interested to learn that RTSD has approved the formation of a new section: Section on Preservation. Complementing the work of the Cataloging and Classification Section, Reproduction of Library Materials Section, Resources Section, and Serials Section, the new group will focus specifically upon information and techniques related to conservation and preservation of library materials. In view of the exciting work being undertaken in this area by some of our theological librarians (particularly that under the direction of Andrew Scrimgeour at the Boston Theological Institute), ATLA will no doubt wish to monitor the activities of the new Preservation Section carefully.

In addition, the Board of Directors of ATLA approved at the June meeting the establishment of a Standing Committee on Bibliographic Systems to replace the one on Cataloging and Classification and expand its scope. In this context, "bibliographic systems" are assumed to include the organization, cataloging, classification, processing, and management of all types of library materials, both print

and nonprint, whether monographic or serial in form. The primary functions of the new committee will be (1) to keep ATLA members informed on developments in bibliographic systems which have implications for theological librarianship; (2) to assist members in solving problems related to the establishment, maintenance, interpretation, or change of bibliographic systems; (3) to make representations to or establish liaison with groups which make decisions concerning bibliographic systems that affect theological libraries; and (4) to identify and, as appropriate, initiate projects in the design and management of bibliographic systems for theological libraries.

This new ATLA committee will assume responsibility for liaison with LC Processing Services and for the issuing of special information relating to bibliographic systems and standards. It is also expected that this column will eventually become an outlet for information provided by the Bibliographic Systems Committee.

A final note: Some of the librarians attending the ATLA conference in June expressed concern about the report on "Corporate Names" to which this column referred earlier. In particular, there was some confusion as to whether the IFLA report is meant to supersede the provisions of AACR 2, especially as related to the use of the vernacular (rather than an established English form of name) in corporate headings. The Library of Congress has indicated no plan to use the provisions of the report where these provisions might lead to conflict with AACR 2. In such cases, however, it is expected that cross references from the vernacular ought to be established in English-language catalogs.

UNITED METHODIST BIBLIOGRAPHY SERIES INAUGURATED

The Commission on Archives and History of the United Methodist Church has published the first of five titles in a new United Methodist Bibliography Series highlighting the contributions of ethnic minorities and women - Native American Methodists, a Reading List, prepared by Thomas E. Lenhart and Frederick A. Norwood. Copies of the 22-page bibliography are available at \$2.00 postpaid (20 copies at 1.00 each) from: Commission on Archives and History, United Methodist Church, P. O. The series, which is edited by Dr. Kenneth E. Rowe, Methodist Librarian at Drew University in Madison, New Jersey, is designed to provide introductory guides to the literature for students and pastors. Projected titles in the series include guides to the experience of Asian-Americans, Blacks, Hispanics and women in the Methodist tradition.

NATIONAL CONFERENCE ON WOMEN'S HISTORY TO CONVENE IN FEBRUARY

A national conference on women's history entitled "Women in New Worlds: Historical Perspectives on the United Methodist Tradition" will be convened by the Commission on Archives and History of The United Methodist Church under the auspices of its Women's History Project, on February 1-3, 1980, in Cincinnati, Ohio, at the Netherland Hilton Hotel. The scholarly public is cordially invited to attend. A published volume of articles is expected to result. Further information on the conference may be obtained from Ms. Hilah F. BOSTON THEOLOGICAL INSTITUTE RECEIVES GRANTS TO FURTHER SERIALS PROJECT

The Boston Theological Institute (BTI) has received grants totaling \$66,000 from the Lilly Endowment, the Council on Library Resources, and the Arthur Vining Davis Foundation. These grants will support the first half of a two-year project to complete the conversion of the BTI Union List of Serials to machine-readable form through the CONversion of SERials Project (CONSER). The journal holdings of the nine libraries of this ecumenical consortium represent one of the most extensive serial collections for the study of theology and religion in the world. It comprises over 7,000 unique titles (both current and ceased) spanning the spectrum of Western languages and international ecclesiastical bodies.

Some 2,000 titles have already been cataloged by BTI through CONSER. Completion of this project will make available to the international academic and library communities a core data base of religious journal information. Authoritative bibliographic information on many of these titles has heretofore been virtually nonexistent. BTI CONSER records are available through the MARC-Serial program upon authentication by the Library of Congress, may be purchased through the National Library of Canada and the Library of Congress, and all BTI records are on-line in the OCLC Union Catalog. BTI will shortly advertise its new Union List of Serials which is published on fiche and is a project of CONSER cataloging. It is updated semi-annually and includes detailed holding statements.

The member schools of the BTI are Andover Newton Theological School, Boston College Department of Theology, Boston University School of Theology, Episcopal Divinity School, Gordon-Conwell Theological Seminary, Harvard Divinity School, Holy Cross Greek Orthodox School of Theology, St. John's Seminary, and Weston School of Theology. The project is administered by Andrew D. Scrimgeour, Director of the BTI Library Development Program, 45 Francis Avenue, Cambridge, Massachusetts 02138.

WORK BEGINS ON GUIDE TO ARCHIVES OF RELIGIOUS ORDERS OF WOMEN

Compilation of data is currently in process for the publication of a guide to the holdings in the archives of religious orders of women in the United States. The project is made possible by a grant of \$98,956 from the National Endowment for the Humanities. The Leadership Conference of Women Religious in Salina, Kansas, is conducting a national survey of documentary materials to be found in approximately 900 religious congregations of women in the United States. Although the largest proportion is of Roman Catholic orders, the survey also includes Orthodox and Episcopal communities, and Lutheran and Mennonite Deaconesses. The collections contain materials which date back to the early nineteenth century, with a few congregations such as those in New Orleans, Georgetown, and Port Tobacco (Baltimore), Maryland, dating from eighteenth-century foundations. The results of the eighteen-month survey will provide a guide to hitherto unknown sources for the research scholar.

Director of the project is Sister Evangeline Thomas, CSJ, former Chairman of the Department of History at Marymount College, Salina, Kansas. Other members of the staff include Joyce L. White, formerly of the University of Pennsylvania Libraries, Assistant, and Mrs. Leo (Lois) Wachtel of Salina, Secretary.

The Survey is Phase III of an archival project on-going since 1976. Phases I and II, partially funded by the National Historical Publications and Records Commission, consisted in the determination of the scope of the project, planning for the training of sister archivists, and the conducting of six workshops at various locations in the country. EVANGELISCHE KOMMENTARE SEEKS WIDER CIRCULATION IN NORTH AMERICA

Although the non-denominational, ecumenical journal, Evangelische Kommentare, is in its twelfth year of publication, its Editors feel that perhaps it is still not widely known in North America. In an effort to bring the periodical to the attention of American theological libraries, the Editors will send each member library of the ATLA a sample issue before the end of the calendar year. They have also asked the Editor of the Newsletter to publish this brief descriptive paragraph concerning the monthly journal:

"There is no other journal in Europe that more consciously seeks to illuminate and analyze the interaction between religion and culture than does Evangelische Kommentare. It seeks to do this by means of 1) brief commentaries on the political, economic and cultural dynamics of the moment in Europe; 2) editorials keeping the reader up-to-date on the cutting edge of theology; 3) essays on politics, society, culture, and religion by leading thinkers from throughout the world; 4) interviews with significant figures in science, philosophy, and politics on current major issues in these fields; 5) reports and analyses of ecumenically important church events, political events, and cultural trends; 6) documentary texts from both church and society; 7) critiques similar to the "Reader's Response" in The Christian Century; 8) reviews of important books; 9) a monthly survey of events in the European churches and the world church; and 10) a column of personal news of European religious and cultural leaders."

GUIDE TO CURRENT CATHOLIC DIOCESAN NEWSPAPERS IN MICROFORM NOW AVAILABLE

At the 1978 ATLA conference in Latrobe, Pennsylvania, the Catholic Committee agreed to conduct a survey of Catholic diocesan newspapers in microform. The result of the first phase of that survey, a Guide to Current Catholic Diocesan Newspapers in Microform, compiled by Harry M. Culkin, was approved for publication by the Committee at its meeting during the 1979 ATLA conference in St. Paul, Minnesota.

The <u>Guide</u> contains data on the micrographic status of all of the <u>lho Catholic</u> diocesan newspapers currently being published in the <u>United States</u>. It also has an exhaustive directory on the availability of microforms: in-house, names and addresses of other locations, for purchase and/or loan. Limitation on access is noted; and indexes of titles and dioceses are included.

NINETY-NINE ATLA LIBRARIES PARTICIPATING IN PRESERVATION AND STORAGE STUDY

Ninety-nine ATLA libraries have begun participating in the preservation and storage study which is being conducted by the Ad Hoc Committee for the Storage and Preservation of Theological Library Material. Andrew Scrimgeour, Convenor of the Committee, reports that 107 of the 151 ATLA member libraries responded to the Committee's invitation, with only eight libraries declining.

A major concern of the study is to document the magnitude of the theological material of the nineteenth and early twentieth centuries that is in need of preservation in ATLA libraries, so that an appropriately aggressive microfilming operation can be developed. The envisioned program is seen as offering significant impact for the space needs and weeding decisions of member libraries. Funds for the study have been provided by a Rockefeller Brothers Fund award (see ATLA Newsletter, November 18, 1978, p. 30).
