From the President

Contemplating ATLA



What is the greatest information-related problem that our libraries share today? If you were to read James Gleick's recent history of information in the modern era, The Information: A History, A Theory, A Flood (Pantheon, 2011), you would that Gleick's answer is clear: information overload and "strategies"

for coping," including "contemplation." It is an answer repeated often in recent books about the Internet and its effects on our lives: from Nicholas Carr's The Shallows (Norton, 2010), which bemoans that on the Internet there is "no peaceful spot where contemplativeness can work its restorative magic" (p. 220), to Hamlet's Blackberry (Harper Collins, 2010), by the journalist William Powers, which looks at why, among the buzz of our digital gadgets, we need "contemplative time away from digital devices" (p. 239), to Alone Together (Basic Books, 2011), by the MIT psychologist Sherry Turkle, which examines the need to "contemplate online life," and the extent to which we are both isolated and overwhelmed by the Internet (p. 280). These authors' connection of information and contemplation might bring to mind past ATLA conferences, where theological and religious studies librarians have begun to describe, and even prescribe, contemplative practices that are potentially therapeutic to information overload: from lectio divina, to the Ignatian Exercises, to the Seeds of Thomas Merton, and others. There is likely need for theological librarians to work more in this area.

Within the past couple weeks I've had the pleasure of listening to different groups of ATLA members deliberate about the most important challenges and opportunities facing our profession and association. In a recent conference call, the ATLA Board of Directors sought to identify the most significant questions related to the future growth and effectiveness of our association. At the annual joint meeting of the Education and Annual Conference Committees, ATLA members, along with our Executive Director, Brenda Bailey-Hainer, discussed all of the many presentation proposals for the 2012 ATLA Annual Conference in Scottsdale, Arizona. Within many of the extraordinary proposals, and the conversations about them, I observed strong evidence that our association is deeply engaged in "meeting the needs of libraries, librarians, scholars, students . . .," and "collaborating to develop solutions to information-related problems common to [our] libraries and collections."
