It is jointly sponsored by the International Federation of Library Associations and Institutions (IFLA), the Online Computer Library Center (OCLC), and ATLA. Applicants are not required to be ATLA members. Please forward notice of this opportunity to colleagues. Complete applications, which include a cover sheet, a resume, an essay of 1,000 words or fewer, and three letters of recommendation, must be submitted by February 18, 2011. 

## From the International Collaboration Committee

### International Collaboration Grant Awarded



The International Collaboration Committee is pleased to announce that it has awarded an international collaboration grant of \$2,000 to the Missionary Church Archives & Historical Collections at Bethel College, Mishawaka, Indiana, to help support an internship for Cammaleta Harrison from the Zenas Gerig Library at Jamaica Theological Seminary &

Caribbean Graduate School of Theology, Kingston, Jamaica.

ATLA Member Timothy Erdel served with his family for six years (1987-1993) as theological librarian at the Jamaica Theological Seminary. When they arrived they found that the "librarians" held no degrees and were treated with minimal respect by senior administrators. When they left, the professional staff were all on

track to earn degrees in both theology and library science and were integrated into the heart of the campus. Since returning to the Missionary Church Archives, Tim has continued his involvement with the Jamaica Theological Seminary. Most recently, he was contacted by Dr. Cecelia Spencer, Director of Library Services at the Zenas Gerig Library, asking if Bethel College would be able to provide a place for Cammaleta Harrison, a promising young librarian, to do a library and archival internship this coming summer to fulfill requirements for her M.L.S. from the University of the West Indies.

During her time at Bethel, Ms. Harrison will be introduced to the range of library and archival operations at Bethel College and the Missionary Church Archives & Historical Collections, as well as to other area institutions with which they have consortium arrangements or other ongoing relationships. These institutions include not only Notre Dame, but also the Mennonite Historical Library and the Archives of the Mennonite Church at Goshen College. It is also hoped that Ms. Harrison will be able to attend the ATLA Annual Conference in June 2011.

### **Data Resource Repository and Conference on Information & Religion at Kent State**

Dr. Daniel Roland of The Center for the Study of Information and Religion (CSIR) at the School of Library and Information Science (SLIS), Kent State University invites scholars to visit a new data resource repository at <u>http://csir.slis.kent.edu/sermons/search</u>. "The repository is web based and keyword searchable. Currently, data records consist of less than one hundred sermons prepared by Christian clergy members, but the goal is to collect religious messages from all faiths. The small sample of records are available for demonstration purposes as CSIR is in the process of applying for grant funding to finance the development and expansion of the Religious Messages Repository," says Dr. Roland. After visiting the repository, scholars are asked to take a short online survey.
