BOARD OF DIRECTORS MEETS IN RICHMOND

The Board of Directors of the American Theological Library Association held its winter meeting January 5-7, 1983, at Union Theological Seminary in Richmond, Virginia. Martha B. Aycock, Reference Librarian at Union, was hostess to the group. Those in attendance were Robert Dvorak, President; Martha B. Aycock, Vice-president; Albert E. Hurd, Executive Secretary; Robert A. Olsen, Jr., Treasurer; Class A Members at Large, James Dunkly, Roberta Hamburger, Lawrence H. Hill, Betty A. O'Brien, Dorothy Parks, and Richard D. Spoor; Jerry D. Campbell, Past President; R. Grant Bracewell, Representative of the Index Board; Charles Willard, Representative of the Board of Microtext; Donn Michael Farris, Editor of the Newsletter; and Joyce L. Farris, Recording Secretary.

In a series of meetings which began on Wednesday afternoon and ended at noon on Friday, the Board:

- adopted a policy statement on the use of the ATLA membership list which requires that requests for the use of the list should ordinarily be accompanied by a copy of the material to be mailed,
- endorsed the appointment of Elvire Hilgert as representative from the Bibliographic Systems Section to the Committee on Cataloging: Description and Access, of the Resources and Technical Services Division of the American Library Association,
- ruled that the Sections should submit to the Board of Directors for endorsement the names of persons who are going to represent the Association or one of the Sections to external organizations,
- voted to pay the Editor of the Proceedings an honorarium of \$450 a year,
- received and discussed a lengthy progress report from Stephen Peterson on Project 2000,
- directed the President to appoint a committee to make recommendations to the Board at its June meeting with regard to the continuing relationship between the ATLA and the Association of Theological Schools,
- voted to recommend to the membership of the Association at its June conference that it amend Sections 12.5 and 13.5 of the ATLA By-Laws to read "No Board member shall serve more than two consecutive terms," applying to both Class A and Class B members of both the Board of Microtext and the Index Board,

- appointed members of the Board of Directors to serve as liaison persons between the Board and the Standing Committees: Dorothy Parks with Bibliographic Systems, Lawrence H. Hill with Reader Services, Roberta Hamburger with Collection Evaluation and Development, and Betty O'Brien with Publication,
- ruled that if a new member joins the Association within three months of the next fiscal year, that member will automatically be enrolled for the next fiscal year,
- accepted the invitation to hold the 1986 annual conference of the Association on the campus of William Jewell College in Liberty, Missouri, with the theological seminaries of the Kansas City area acting as hosts,
- instructed the Executive Secretary to proceed with the production of a new membership brochure,
- voted that the Editor of the Proceedings be an ex officio member of the Publication Committee,
- discussed at length with the Program Committee plans for the 1983 conference, which is to include a one-day program of Continuing Education,
- agreed that the Continuing Education element of the program be expanded to two days at the 1984 conference,
- voted that the Association will underwrite the costs of the Continuing Education segment of the 1983 conference in the amount that those costs exceed the amount derived from registration fees,
- directed the Executive Secretary to maintain records of continuing education credit earned by ATLA members at the annual conferences and empowered him to certify these on behalf of the Association,
- appointed a committee consisting of Betty A. O'Brien, Elmer O'Brien, and Lawrence H. Hill to work with John Howard, Librarian of New College, Edinburgh, Scotland, on plans for the proposed post-conference tour to Edinburgh in 1985,
- voted to extend to John Howard an invitation to visit the Board of Directors during its June meetings in order to discuss the proposed Edinburgh tour,
- received and discussed an extended report from Andrew Scrimgeour on the activities of the Task Force on Preservation, and
- appointed Donn Michael Farris to another five-year term (1983-1988) as Editor of the Association's quarterly Newsletter.

THREE SEMINARIES MERGE PERIODICAL COLLECTIONS

In 1970, De Sales Hall School of Theology, Dominican House of Studies, and Oblate College, all within four blocks of each other in Washington, D.C., formed the Cluster of Independent Theological Schools, a structure that enabled them to share their resources and yet to devise their own curricula, operate their own libraries, and grant their own degrees. In the summer of 1982 the three institutions agreed to form a Cluster Periodical Center in the Dominican College Library. The Center opened last October with one bound copy of every volume of every title that had been in any of the three libraries. In 1983 the three terminated their current subscriptions. The Center is receiving all issues, thus ending duplication.

Each school continues to pay for the subscriptions and to own the volumes it sends to the Center. The library that pays for the subscription pays for its binding. A book plate identifies the owner. A standard annual fee is charged each institution for the services provided. The director of the Center is responsible to a committee drawn from the three institutions. The faculty of each seminary can place any title in the collection; neither the director nor the faculty of another Cluster institution can veto their choice.

Since only one library checks in titles and prepares them for binding, staff should have more time for other projects. At the end of five years of operation, the Cluster Periodical Center will be subject to a review and evaluation to determine whether or not it does give better service than the three libraries functioning independently.

A LETTER FROM PRESIDENT DVORAK

Elsewhere in this issue of the Newsletter you will find a summary of actions and discussions undertaken by the ATLA Board of Directors at its midwinter meetings in Richmond, Virginia, early in January. I want to report to the membership several matters related to the work of the Board, underscoring four concerns and directions of the Association at the present time.

1. Please remember that the current year is one of transition for us in ATLA. We are now operating with the revised slate of standing committees, six in all, outlined on previous occasions both in written and oral reporting: Bibliographic Systems (Elizabeth Flynn, chair); Collection Evaluation and Development (Donald Vorp, chair); Publication (Betty O'Brien, chair); Reader Services (Norman Desmarais, chair); Nominating (John Sayre, chair); and Program (Erich Schultz, chair). A plan for relating general membership constituencies to each of the first four committees noted above will be implemented with the membership year 1983-84. These constituencies, called sections, were fully discussed at the last Annual Conference in Toronto and also in the August 1982 Newsletter. When you receive your next membership renewal form from the Office of the Executive Secretary, you will notice provision on the form for enrollment in one or more of the four sections. Each member of the Association should plan to join at least one section. At the Annual Conference in Richmond this coming June, the sections will meet under the leadership of the respective standing committee personnel for programming units as part of the larger Conference program design.

2. Let me emphasize the planning that is underway for a continuing education thrust within the Association. In Richmond next June, the Program Committee will present a one-day concentration of workshops in the continuing education mode. Elsewhere in this Newsletter is a description of the manner in which this component of the Annual Conference will work. It is elective; it precedes the regular Conference by a full day. The Board of Directors has committed funds for the subsidizing of this initial experiment in formal continuing education so that members can plan to participate at minimal personal cost. The Executive Secretary of the Association will record contact hours of instruction for registered persons wishing to maintain a continuing record from year to year of this educational participation. The Board of Directors and the Program Committee anticipate expansion of the continuing education aspect of the Annual Conference to as much as two full days in succeeding years.

3. Project 2000 and the Task Force on Preservation of Monographs project respectively are moving steadily forward. From Stephen Peterson and from Andrew Scrimgeour you can expect to receive questionnaires related to these two undertakings. Your information, projections, and opinions are crucially important to the research and planning of these projects. These surveys constitute an important opportunity for you to influence key aspects of the practice of theological librarianship over the next two decades. Please be sure to respond.

4. The Publication Committee met for two days prior to Board meetings in Richmond. This body oversees the production of the annual

Proceedings among other responsibilities. Betty O'Brien, Editor, reports that as of mid-February, one-third of the copy for the 1982 Proceedings is in her hands for proofing. A word processing company in Chicago is handling production. Conference papers are now being processed, and Ms. O'Brien estimates that by the end of March the entire copy of the Proceedings should be ready for final printing.

So very many people work together in the interests and mission of the ATLA that it would be difficult to offer appropriate credits. We are a collegial association, dependent on each other and mutually grateful for responsible participation evident throughout the body. I can report to you many evidences of a healthy organization because of strong professional involvement. That is a state of affairs for which I express sincere appreciation to the membership.

BETHEL SEMINARY LIBRARY ADDITION DEDICATED

Completion of the new addition to the Bethel Seminary Library in St. Paul, Minnesota, was celebrated at dedication ceremonies held Thursday afternoon, January 27, 1983. Denominational and school officials participated in ceremonies which included naming of the entire library complex the Carl H. Lundquist Library, in honor of Bethel's President Emeritus (1953-1982). The 10,200 square foot, three-story building will allow approximate doubling of the current holdings of 105,000 volumes. It provides 66 study carrels, and contains the Archival Center for Bethel College and Seminary and the Baptist General Conference. Dr. Norris A. Magnuson is the Librarian.

ARCHABBEY LIBRARY AT ST. MEINRAD
OCCUPIES NEW BUILDING

The Archabbey Library in St. Meinrad, Indiana, moved into its new building during the third and fourth weeks of December 1982. Staff and students moved the book collection during the first week under the supervision of a professional library mover. Furniture was transferred during the second of the two weeks, and the library is now open again and fully functioning. An academic convocation and celebration will be held on April 18. The blessing of the building took place last May. The 40,000 square-foot structure was built at a cost of approximately \$2,300,000 and serves the St. Meinrad School of Theology, the seminary college, and St. Meinrad Archabbey. Father Simeon Daly is the Librarian.

PROGRAM COMMITTEE REPORT

The 1983 ATLA conference will be held at Union Theological Seminary in Richmond, Virginia, June 20-24, with John B. Trotti as host librarian. In accordance with the new conference structure, the Association will offer several continuing education programs on Monday, June 20. The options will include: the establishment and operation of a data-base reference service; the principles and practices of evaluation in the library; and the development of library consulting skills.

The regular conference program will begin with a reception on Monday evening at Richmond Hall on the Union campus. Following an opening plenary session on Tuesday morning, the schedule will feature a paper on Martin Luther. The paper will commemorate the 500th anniversary of the birth of Luther, which will be celebrated this year. Tuesday afternoon, several workshops will be available: 1) discussion of the continuing effects of AACR 2 by Ben R. Tucker, Chief of the Office for Descriptive Cataloging Policy at the Library of Congress; 2) methods of planning and presenting a workshop by Larry Allen, School of Library Science, University of Kentucky; and 3) collection evaluation.

Wednesday morning, program participants will choose from among three papers that will be presented: "The Oxford Movement in the Church of England" by E. R. Fairweather, Keble Professor of Divinity, Trinity College, Toronto, Ontario; "The Movement toward Union in the Presbyterian Church" by E. T. Thompson and F. Wellford Hobbie, both of Union Theological Seminary; and "Retrospective Religious Indexing, Prospects and Models" by Albert E. Hurd, ATLA Executive Secretary.

In the afternoon, Stephen L. Peterson will discuss accrediting standards for theological libraries, in particular the revisions in the ATS standards in which he has been involved as a result of his work on Project 2000. Later Wednesday, the schedule will include three off-campus alternatives: visiting libraries with on-line catalogs; touring the Virginia State Library and Archives; and sightseeing in the city.

Thursday, Robert Dvorak will give the presidential address at the morning session. In the afternoon, there will again be a choice of three papers: "British Theological Librarianship" by John V. Howard, New College Library, Edinburgh, Scotland; "A Citation Study of Periodical Articles in Religion" by Julie M. Hurd, Graduate Library School, University of Chicago; and "Cognitive Structures of Theological Literature" by Andrew D. Scrimgeour, Director of the Taylor Library at the Iliff School of Theology. Also on Thursday afternoon, James Dunkly will preside over a theological roundtable discussion session. In addition, an opportunity to visit either the Reigner Recording Library or Radio Station WRFK-FM, a station owned and operated by Union, will be planned. After the traditional closing banquet, a local musical group will furnish entertainment.

The schedule will provide time for the business sessions, the denominational meetings, and the chapel services that complete the conference program each year. On Friday following the conference, tours to Colonial Williamsburg and to Washington, D.C., will be arranged.

POST-VATICAN II CATHOLIC LITURGICAL WORKS

In the ATLA Newsletter of May 16, 1981, I commented on the problems associated with uniform titles for post-Vatican II liturgical works. As one means of alleviating those problems, I undertook to assist in getting more of such titles established by the Library of Congress and for that purpose requested the International Commission on English in the Liturgy to send to the Library of Congress a complete set of post-Vatican II liturgical texts issued to date. Although ICEL had already sent many or all such texts to LC, John Page, the Executive Secretary of ICEL, graciously sent another set and prepared an accompanying list of titles along with some very useful notes. At the 1982 ATLA meeting in Toronto I agreed to furnish the list for circulation in the Newsletter.

For the convenience of readers of the Newsletter, and to save space, I have altered the list somewhat, arranging the titles in a classified order rather than by date of issue, and omitting two or three rather secondary works (e.g. Music for Rite of Funerals) and some of the notes.

Although ICEL does not publish the texts - this is done by regular publishers - the texts as issued to the publishers by ICEL are the official texts, approved by the member episcopal conferences of ICEL and by the Roman See, and the texts provide, as John Page rightly says, "most especially the full and correct title." It would seem generally preferable therefore to use this title as the uniform title - particularly in view of the frequent variation in title for the same work among different publishers, even in the same country.

While this list should be helpful, I have no illusion that it will come near solving all the problems of post-Vatican II liturgical titles. Aside from problems that remain for English language texts, there can be endless problems with titles for texts in other languages. These problems are largely related to the application of the new AACR 2 rule 25.20B, which results generally in different uniform titles for editions or "manifestations" in different languages of the same basic liturgical work - and sometimes even in different uniform titles (for different countries) of different manifestations of the same work in the same language.

At the Toronto meeting I suggested that it might be advisable to try to get 25.20B rescinded and to use a single uniform title for different manifestations of a particular post-Vatican II work, as is still done for pre-Vatican II works. I suggested further that it might be preferable to use as the uniform title the title of the basic text, which for post-Vatican II texts is still a Latin title. I mentioned that this would have the added advantage that the International Federation of Library Associations has published an official List of Uniform Titles for Liturgical Works of the Latin Rite of the Catholic Church (2nd ed., rev. -- London : International Office for UBC, 1981. -- xi, 17 p.). IFLA assumes that a single uniform title will be used for manifestations in

various languages and recommends that this be a Latin title, as given in the IFLA list.

For the sake of comparison I have included the Latin title, as approved by IFLA, along with the English title in the list provided by ICEL. I have designated the ICEL title as "a," the IFLA title as "b." "J.P." indicates John Page's notes, "T.P." my own.

I must admit, however, that there are valid arguments in favor of rule 25.20B and that an alternative approach of the kind suggested above is not without its own drawbacks. Although the main post-Vatican II vernacular texts are to a large extent very much the same as the editio typica, it is a fact that they do also tend to differ considerably more from the basic text than pre-Vatican II texts did. And as time goes on, given the greater latitude in post-Vatican II liturgical regulations, the differences will presumably become wider. There will also probably be more secondary or supplementary local texts that correspond even less closely to a basic Latin text.

It must also be taken into consideration that the use of a Latin uniform title for post-Vatican II works in various languages would go counter to the long-established policy, confirmed in AACR 2 25.19, of using an English uniform title, even for the Latin text, in the most common cases of pre-Vatican II works. The use of a Latin uniform title for works in varying languages also makes it more difficult to provide a specific subject heading for works about a liturgical text in a particular language, at least within current LC subject cataloging practice. (But this holds of course also for pre-Vatican II texts, and could easily be remedied by a simple and, I think, fully plausible change in that practice.) Finally, speaking of subject cataloging, it should also be acknowledged that the new provisions the Library of Congress has been working on for subject headings for liturgical works do promise to correlate such works in ways that will reduce the necessity or utility of a common uniform title for different manifestations of the same work.

With such considerations in mind, I for one am not ready to push for a change in 25.20B, at least not at this time. If others think that something should be done about it, I would be happy to hear from them, though I should warn in advance that I might not get around to a detailed reply. If there is enough interest, perhaps the matter could be discussed in Richmond in June.

BIBLIOGRAPHIC SYSTEMS COMMITTEE REPORT

Elvire Hilgert of the Jesuit-Krauss-McCormick Library in Chicago has been appointed as a non-voting representative of the ATLA on the Committee on Cataloging: Description and Access of the American Library Association. Her appointment was confirmed at the mid-winter meeting of the ATLA Board of Directors. All library associations who participated in code revision are eligible to have non-voting representatives to CC:DA. However, the ATLA has not had a representative since AACR 2 was published. Non-voting representatives receive copies of documents to be discussed from the Resources and Technical Services Division of ALA. CC:DA meets twice a year, at mid-winter ALA and at the annual ALA conference. Elvire has already attended her first meeting of CC:DA in Dallas this January. The ATLA assumes financial responsibility for her attendance at ALA meetings. The Bibliographic Systems Committee will coordinate distribution of documents to interested members of ATLA. The open meeting of the Bibliographic Systems Committee during the annual conference will provide a forum for ATLA members to give their comments to Elvire to take to the CC:DA at the ALA annual conference.

Several ATLA librarians have reported problems with Bible subject headings. The Committee is considering publishing a pamphlet on Bible subject headings. Please send further examples of difficulties with the LC list to the Committee.

Only a handful of libraries requested the list of Current LC Subject Headings in the field of religion offered in the last Newsletter. The Committee collected these headings because it takes many months for new headings to be published by LC in LCSH. We hope to reduce the frustration of librarians dealing with new subject headings on LC tapes and proofs when they do not know if these headings are errors or newly approved by LC. It is possible that this meager response reflects the time-delay in circulating the Newsletter to catalogers who are not personal members of the ATLA. Unfortunately, it is too expensive to publish these lists as a regular part of the Newsletter. The Committee is exploring the possibility of distributing these headings to all institutional members. An alternative is to distribute lists on a subscription basis. Let us know your preference. Significant changes from the last six months and a revision of the Classification BX6207-6470 appear below.

LC REPLIES

TITLE PROPER TRANSCRIPTION -- AND UNIFORM TITLES

This fall Matthew Rzczkowski of Dominican College Library in Washington, D.C., wrote Ben Tucker at LC to clarify what is included in title proper, specifically in Latin titles of pre-1800 imprints. Father Rzczkowski included the following title page example:

Divi Antonini Archiepiscopi Florentini, et Doctoris s.
Theologiae praestantisissimi Chronicorum opus... .

He noted that Chronicorum opus is the name of the work. The question of what is included in the title proper arises because the author's name appears in the genitive case at the head of the title page.

Ben Tucker replied that the intent of the rule is to transcribe genitives as they appear on the title page and to use a uniform title as an access point for the "real title." The body of the letter from Mr. Tucker follows:

"As the glossary definition of 'title proper' in our rare book rules implies, statements of responsibility are not excluded from the title proper when they are 'grammatically integral' with it. While it is true that the genitive can precede or follow, still we intended in these rules that genitives be given in the order in which they appear.

"Thus, in the sample you cite we would transcribe 'Diui (not Divi) Antonini' at the beginning. In such cases a uniform title should be used to achieve the paring down to the real title that you have in mind, and certainly I recognize the need for this shortening. Such modifications are frequently legitimate with access points (e.g., the uniform title I recommend), seldom with bibliographic transcription."

This use of uniform title is described in AACR 2 under 25.3, which concerns titles for works created after 1500. The uniform title is the form of title by which a work has become known either through use in manifestations of the work or in reference sources. 25.3B provides that if no one title is established, the uniform title can be constructed from the title proper of the original edition, omitting introductory phrases and statements of responsibility that are a part of the title proper.

AACR 2 Chapter 25 (Uniform titles) is receiving a lot of attention from ATLA librarians. Norman E. Anderson has submitted a lengthy discussion of problems with apocryphal books to the Library of Congress and to the Committee on Cataloging: Description and Access of the American Library Association. Father Thomas Pater discusses uniform titles for post-Vatican II Roman Catholic liturgical works elsewhere in this Newsletter.

Since Ben Tucker, Chief of the Office for Descriptive Cataloging Policy at LC, will be on the program for the ATLA annual conference in Richmond this summer, ATLA members will be able to pursue these problems face-to-face.

PITTS THEOLOGY LIBRARY OPENS SPECIAL COLLECTION

The Pitts Theology Library of Emory University in Atlanta, Georgia, announces the opening of The African Orthodox Church Archives (1880-1974). The collection contains approximately 5,000 items of manuscript and printed material documenting the history of an independent native South African church and the role of its archbishop, Daniel William Alexander (1882-1970). The material was shipped to the United States by the present head of the Church, who feared that the racial tension in South Africa would result in the extinction of this all-Black church and in the loss of its records. The Pitts Theology Library acquired the collection in 1981 and has since processed the material and created a finding aid for its use. The collection is open for research by serious scholars.
