Notes from the Field

It has been enlightening in the past year and a half to visit a number of ATLA libraries (I think there must be close to ten) for the very first time: "enlightening" in the general sense that visiting a new place never fails to be interesting, one way or another. But

more particularly in how it provides a close-up view of what good theological librarianship looks like in a given setting.

What I take away from this is a renewed appreciation of context - what makes a particular setting unique - and of opportunism - the capacity of ATLA colleagues in all these disparate situations to read their situation adroitly and work accordingly. What would be a great library collection for one setting would be of little use in another; the services that are effective and appropriate in my library would not be so well-received in yours, and so on.

We have, as ATLA colleagues, a great deal in common, and can benefit greatly from every "best practice" that has been developed. But the capacity to go further and apply that wisdom in a particular setting and culture, for a particular group of people, requires a mixture of insight, poise, and diligence that is absolutely invaluable.

From the Executive Director



Recently I had the opportunity to review the applications of 24 ATLA members who applied for the Colloquy for New Theological Librarians, to be held at the Wabash Center for Teaching and Learning in Theology and Religion in April 2010. Just reviewing the applications gave

me a great deal of confidence about the Association's future.

These new theological librarians (none in the field more than seven years) have already amassed a most impressive record. In addition to their library science degrees, the group has earned seven Masters of Theological Studies degrees; eight Master of Arts in various other fields, four Master of Divinity degrees, two Master of Philosophy degrees, one Master of Fine Arts degree, and two Ph.Ds. Four have published books or chapters in books; eight have published articles in refereed journals; seven have published book reviews, and four have published articles in professional proceedings.

The 2010 colloquy will be the third such gathering (the others two were in 2004 and 2007), all welcoming new theological librarians to the profession.

For five years we have also supported an Introduction to Theological Librarianship class through the University of Illinois LEEP Program, and to date there have been more than 100 graduates of that class.

The new energy, creativity, and commitment of all of these new theological librarians is evident in recent annual conferences. Each year we have had more proposals for papers, panels, presentations, roundtables, and workshops. When the Annual Conference Committee, Education Committee, and Local Host Committee met with ATLA staff last month, they had to evaluate more than 70 proposals for programs, the highest number of submissions ever.

I have no doubt that ATLA will continue to flourish as the primary professional association for theological librarians for a long, long while to come. Our future is in strong, capable, and talented hands.

Anthony Elia

Title: Associate Librarian for Reference and Instruction Institution: JKM Library, Lutheran School of Theology at Chicago

Years as a theological librarian: Almost four years.

Years as an ATLA mem-

ber: I've been a member of ATLA for almost four years, but have been affiliated with ATLA since 2004, when I took my first job as an Indexer-Analyst.

How did you become involved in the field?

As an undergraduate in the mid-1990s, I studied Religious Studies. After a semester living and studying in East Africa, I came back with a decision to pursue graduate work in Biblical Studies. I spent three years (1997-2000) living in Jerusalem, Israel, where I received an M.A. in Religious Studies with a concentration in Biblical and Jewish Studies. In the 2000-1 academic year, I went to Rome, Italy to study Latin with Father Reginald Foster, Pope John Paul II's chief English language Latinist. I finally made my way back to the states, and began work on a Ph.D. in Church History at the University of Chicago. While in this program, I worked in the University's main library on a project to digitize the major works of Italian women writers in history. I had a lot of fun on this project, and it made me think more about the library field as a career opportunity. I ended up not finishing my Ph.D., but in 2004 began working at ATLA. And in 2005, I enrolled at the University of Illinois-Urbana Champaign's GSLIS for the MSLIS degree. I took Carisse's Theological Librarianship course, which helped me focus on the profession more keenly. After almost two years at ATLA, I got a job at the Lutheran School of Theology at Chicago. The rest is history.

What do you love most about your profession? The most...that's a hard one. There are so many things: the students, the faculty, all of my colleagues. There are always many challenges, but in theological librarianship I often find a bit of a hidden world, which non-theological librarians or non-library folks don't know about. And that may be a question of vocation, which we like to speak of in our profession, but it may be something else, too. Nevertheless, I like the intellectual and theological engagement with people who are excited about what they are studying, reading, and writing about, and ultimately living out each day. It's refreshing to be part of that world on a daily basis.

What has been the biggest challenge you've experienced while working in theological libraries?

Financial cutbacks and learning how to deal with people who don't understand libraries, librarians, or what we do. But also, how to make these individuals (and institutions) more aware of our pedagogical and community-serving purposes.

Why did you join ATLA? I guess someone twisted my arm! It was a natural decision. "Everyone else was doin' it." Well, it was a no-brainer, as the kids say. If you're part of a community of theological librarians, why wouldn't you join?

What is the most rewarding benefit of your membership? The networks, the commeraderie, the conversations, the colleagues--both domestically and abroad--and the friends I've made.

How has ATLA assisted you as a writer? Greatly. From my work in Carisse's Theological Librarianship class, which was often writing-intensive (and I love to write!) to the bibliography grant which I received from ATLA a few years ago, which funded my work on a bibliography of Kabbalah, ATLA has afforded me tremendous opportunities to write and think in more ways than I can detail at this very moment. The bibliography grant was a great honor, and now, after some years of working on it, the product will be published in this December's Theological Librarianship journal. I'd also say that having participated several times in ATLA conferences as speaker and panelist has given me both a forum to think and talk with other people who share my interests, but it is and opportunity for sharing your writing and getting good, solid, and theological attuned feedback. And I cannot forget to mention the role of the Wabash Center Colloguy, which I had the privilege of attending back in 2007--that too had some influence on my writing.

Would you recommend ATLA membership to other theological librarians? Absolutely.
