A REPORT FROM PRESIDENT DVORAK

1983 CONFERENCE. The folks in Richmond are waiting. John Trotti and his staff at the library of Union Theological Seminary in Virginia have done magnificent planning and preparation for June 20th-24th. Conference registrants can anticipate very comfortable accommodation for the week and a most gracious welcome.

Members of the Association should have received mailing of conference registration forms in April. If delivery has not reached you, contact Dr. Trotti at once. The program is well settled at this time, as you no doubt observed from the contents of the registration packet. Further, a variety of area attractions offers unusually fine enrichment options.

An innovation this year will be the early dispatch of committee and other annual reports to persons who will be attending the conference. This is intended to provide adequate reading and study time in advance of floor reports at the business meetings. All appropriate reporting personnel in the Association have been notified of the early deadline date for submission of these reports. They will be mailed out later this month. Please be sure to bring them with you to the conference for reference purposes at strategic points.

Let me emphasize one more time the new continuing education thrust for the Association that has been in the planning stages for some time. Although this continuing education programming is not part of the traditional conference design, it is adjacent to the conference schedule and will be housed at conference facilities. The entire day, Monday, June 20, is devoted to this professional education experience. The cost is additional to conference registration, room and board, but it is so moderately set as to encourage the widest possible participation. If you are not able to attend, you should not feel in any way disadvantaged regarding the regular conference, however. As usual, there will be conference registration occurring all during the day Monday, and the traditional opening reception will be held that evening.

INDEX BOARD. I want to take this opportunity to report to the membership that Martha Aycock, vice-president and president-elect of ATLA, has resigned her position with the Index Board which she has so faithfully served for some period of time. The duties and demands of the presidency of the Association will require her full attention over the next months. Martha has played a central role with the Index Board. Her colleagues

LIBRARY RAZED IN BUSHFIRE

(The Editor of the Newsletter is indebted for the following story to the Reverend Trevor Zweck, Librarian of the Luther Seminary in North Adelaide, South Australia, and Chairman of the Association of Theological Libraries in South Australia.)

The devastating bushfires which raged through the Adelaide Hills in South Australia on Ash Wednesday, February 16, 1983, struck with disastrous effect on St. Michael's House, Crafers (on the Mt. Lofty Summit), including in its path of destruction one of the finest theological libraries in Australia. The library building was totally destroyed and not one of its 40,000 volumes was spared.

The historic and architecturally important buildings had been bought by the Bakewell family in 1879 and extensively added to in 1880, 1895 and 1902. It was taken over by the Society of the Sacred Mission in 1946 and further extended in 1959 and 1967. The latest of these additions, the refectory, was the only building which survived the disaster. Curiously, it was from this building that the residents had first fled when the fire initially descended upon the idyllic hills retreat. All seven residents (including two guests) escaped with nothing worse than minor burns, although their final dash to safety (after 40 minutes of being trapped inside the building) led them past a flaming staircase.

Among the books and periodicals destroyed were some of unique and priceless value. The library had contained an exceptional collection of rare books, including 243 volumes (140 titles) of pre-1801 imprints. (Records of these items have been preserved in the Early Imprints Project of South Australia.) In addition, there was a collection unique in Australia of books on the religious and monastic life, personal piety and prayer (some 2500 books, many of them irreplaceable), sermons (some 800 volumes), and some rare Australiana. The collection of 2000 biographies included the stories of Anglican and other church divines and missionaries, as well as many first edition works of early Australian colonists, missionaries, and explorers, and books of Australian songs and ballads. Politics and economics were also strongly represented.

The oldest books were a work of Erasmus (1512), a Roman missal (1512), a volume of Lucretius (1515), and a work of George Agricola (1533). There were two Geneva ("Breeches") Bibles (1600), one of which had come from Lord Nelson's Flagship.

Among the unique items relating to Anglican divines were early editions of John Jewel, Jeremy Taylor (1647), Richard Baxter (1652), Sir William Dugdale's Monasticon Anglicanum (1655-1673), illustrated with the author's own sketches, and the diaries of Archbishop William Laud, "written in the Tower" (1695). Other treasures included hymn writer John Mason Neale's altar book (an ornamental Gothic edition of the first Anglican communion order), and a magnificently illustrated colour glossary by A. W. Pugin (architect of Big Ben) on the Gothic revival (1846). There was an almost complete set of the classic collection of early church fathers, J. P. Migne's Patrologia. Among the periodicals collections destroyed

was a complete set of the Bible Christian Magazine (Primitive Methodist), believed to have been the only complete set in the world. The commercial value of the total collection would have been about a quarter of a million dollars. The real value, however, was in the information contained within the covers of the volumes destroyed. Since much of it was unique and is now irreplaceable, the world has lost many a priceless treasure.

The institution itself, established and administered by the Society of the Sacred Mission, is to be re-established on a site yet to be determined in the Melbourne area (a decision made already in 1982 but now hastened by this catastrophe). The person chiefly responsible for the establishment of the library and its building up into the fine collection it eventually became was Antony Snell. The present librarians, Joseph Kinsela and Jean Wilson, along with other members of the community, now have before them the arduous task of creating from nothing a new library collection to undergird the work of the new institution. The constant reminder of what has been lost will make that not only a slow but often, one suspects, a painful task. SAINT LEONARD COLLEGE LIBRARY HOLDINGS DISPERSED

Since the closing of Saint Leonard College in Dayton, Ohio, in 1981, negotiations have been underway for the disposal of the library collection. The 8,000 volumes in the Franciscan collection have now been transferred to the St. Francis Center, 10290 Mill Road, Cincinnati, Ohio 45231, to form the William Faber Franciscana Library. Betty A. O'Brien, Librarian at Saint Leonard, will serve as Librarian of the Faber Library. The remainder of the Saint Leonard College Library has been purchased by the University of Dayton, and the transfer of all materials is scheduled to be completed in June.

RELIGION INDEXES: THESAURUS IN SECOND EDITION

The American Theological Library Association Religion Indexes have published a second edition of their Thesaurus, available immediately. This 1983 edition reflects changes in subject headings and additions of new headings and cross-references in the two years since the publication of the first edition. In addition to the 268 pages of headings and references, the new edition includes lists of standard subheadings and of journal abbreviations, which appear in the Thesaurus for the first time. The completed work includes over 11,200 subjects and over 19,000 cross-references.

The Thesaurus has been made available publicly to provide assistance to online users of the ATLA Religion Database, which is available as "RELI" in the BRS system and is available on a subscription basis for \$15.00 per year from the Religion Indexes, 5600 South Woodlawn Avenue, Chicago, Illinois 60637. The subscription includes the complete Thesaurus in a plastic spiral binder (but punched for optional three-hole binding) and semi-annual updates that indicate changes and new headings. New editions are planned for biennial publication.

Useful also as a cataloging tool, the ATLA Religion Index Thesaurus includes not only important religious, theological, and biblical terms, but many terms representative of the broad disciplines that interact with religion: archaeology, art, ethnology, history, psychology, and sociology, to name but a few. Many personal names, corporate names, and geographical names are included.

The Religion Index Thesaurus was produced using Xerox's 9700 laser-beam system directly from an edited computer tape. Technical improvements in the past two years are apparent in the improved print quality of the new edition.

BIBLIOGRAPHIC SYSTEMS COMMITTEE REPORT

Current LC Subject Headings in the Field of Religion. As announced in the ATLA Newsletter, v. 30:3, p. 33, the Bibliographic Systems Committee is compiling new and revised headings in the field of religion. These headings are supplied by Warren Kissinger who clips them from the Weekly Lists distributed to subject catalogers at the Library of Congress. The initial list was prepared at the end of October and contained headings from June-Oct. 1982. Over 35 libraries (and Otto Harrassowitz in Germany) requested copies of this list. An updated list will be available at the ATLA Conference in Richmond. It is the intention of the Bibliographic Systems Committee to distribute these lists on a quarterly basis. Distribution details will be announced at the annual conference and in the August issue of the ATLA Newsletter. Those libraries replying to the informal poll requested in the last issue of the Newsletter have been unanimously in favor of distribution of the lists to institutional members.

The Committee has also distributed about 20 copies of "Pattern Subdivisions for Christian Denominations" to libraries who did not receive a copy at the annual conference last year. We are grateful to Warren Kissinger who also supplied this document for our use.

In the most recent Cat. Serv. Bull. (19), LC introduced a new feature, "Subject headings of current interest." Those of a theological nature as well as new headings and significant changes approved by LC since the last issue of the ATLA Newsletter appear below.

CC:DA AT MIDWINTER ALA

Among the topics discussed at the midwinter meeting of the ALA Committee on Cataloging: Description and Access were qualifiers to unique serial identifiers, music cataloging problems, glossary changes, and guidelines for the cataloging of microcomputer programs. LC has proposed that the qualifier for serials and series uniform titles be the place of publication unless: (1) the title is "generic"; (2) the title proper includes an initialism of a corporate body; or (3) if a similar title has a similar place of publication. For these exceptions, the qualifier would be the corporate body. At the present time, LC has considerably more complex rules for creating uniform titles for series/serials. (AACR 2 25.5B in Cat. Serv. Bull. 14, p. 49-53). CC:DA has appointed a task force to study the impact of the new proposals. Any suggestions from ATLA libraries will be reported by Elvire Hilgert, our non-voting representative, at the ALA conference in Los Angeles the week after the ATLA Conference.

THE FUTURE OF DEWEY

ATLA libraries using Dewey may wish to send comments to an ALA hearing at the 1983 conference in Los Angeles. Among topics to be considered are priorities for the 20th edition of Dewey, reaction to the Proposed Revision of the 780 Music schedule, and the implications of continuous revision of Dewey. The policy of continuous revision was approved at a meeting of the Dewey Decimal Classification Editorial Policy Committee at LC in November. At that meeting, John Comaromi, editor of the DDC, outlined a list of recommended revisions and phoenixes to implement this policy. The 200's were not mentioned. The Bibliographic Systems Committee would be happy to forward comments and suggestions of ATLA libraries who may wish to propose changes to the 200 schedule as well as respond to the announced topics of the hearing. Comments are being collected by Liz Bishoff, ALA Representative to the Decimal Classification Editorial Policy Committee, Ela Area Public Library, 135 S. Buesching Road, Lake Zurich, Illinois 60047. If there is substantial interest, ATLA could investigate the possibility of having a representative of our own on the DCEPC.

SERIES AND MUSIC ON MARC

LC has begun to input series authorities into the MARC format. These records are available in machine readable form from the Name Authority

tapes distributed in 1983. Unfortunately these series authorities will not appear in the Name Authority COM fiche product at this time. Retrospective conversion of all traced series established since AACR 2 was scheduled to be complete at the end of April. (Cf. RTSD Newsletter, v. 7:5-6, p. 49; v. 8:2, p. 13.)

The input of music records scheduled for late 1982 is behind schedule; and distribution of music records on MARC is "awaiting preparation of the appropriate software."

ATTEND ALA BY TELECONFERENCE

The good news is that highlights of the ALA conference will be available for a reasonable price (\$35 for non-members, \$30 for members) in about 80 cities across the United States in a special five-hour program on Tuesday, June 28. The morning segment will be a sample of speakers and exhibits at the conference, while the afternoon segment will be a bibliographic institute entitled "'Blood, Toil, Tears and Sweat': Rules and Formats." Among the panelists will be Lucia Rather and Henrietta Avram from LC, Peter Lewis from the British Library, Allan Veaner, Nancy John, and Joe Rosenthal from large university libraries. Judith Cannan will be moderator. Each local receiving site will have a telephone hookup so they can ask the speakers questions directly.

The bad news is that registration closed April 30. I hope some ATLA members were able to meet this deadline. The experiment is likely to be repeated, so we will try to spread the word on a more timely basis next spring.

DESCRIPTIVE CATALOGING: COPING WITH LC RULE INTERPRETATIONS

ATLA catalogers may not have been overjoyed to find 88 pages of Library of Congress rule interpretations in Cat. Serv. Bull. 18 (Fall 1982). LC has published rule interpretations in issues 11-18. In some cases rule interpretations have been revised in subsequent Bulletins. The index by rule number at the front of issue 18 identifies the list of rules which have been "interpreted" and gives the citation of the most current interpretation. Catalogers who have marked changes in their copies of AACR 2 may find some LCRI too lengthy to insert and multiple revisions messy. A couple of loose-leaf publications are available.

Scarecrow Press has published a compilation of the rule interpretations issued in Bulletins 11-16. The title is Library of Congress Rule Interpretations for AACR 2, 1978-1982. Cumulated Edition. The compiler is Sally Tseng. (\$16.50; ISBN 0-8108-1572-9; LCCN 82-10353)

Alan Boyd and colleagues at Oberlin College Library offer a basic cumulating from Cataloging Service Bulletins 11-16 with update sheets for Cat. Serv. Bull. 17-19. This publication is entitled Library of Congress Rule Interpretations for AACR 2 and is available for \$15.00 from Alan Boyd, Oberlin College Library, Oberlin, Ohio 44074.

AACR 2 REVISIONS

Cat. Serv. Bull. 18 contains not only rule interpretations, but numerous changes to AACR 2 approved by the Joint Steering Committee for Revision of AACR. These changes reflect both additions to and deletions from the text of AACR 2. These revisions have also been issued separately by the American Library Association under the title Anglo-American Cataloging Rules, Second Edition: Revisions (\$2.50; ISBN 0-8389-3277-0; LCCN 82-13719).

Fortunately many of these changes are interrelated. One cluster of changes concerns notes relating to items commercially reproduced. A new paragraph is added to rule 1.7A4. The general rule is that notes relating to the reproduction are given first, followed by notes relating to the original. Notes relating to the original are combined in one note, with details in the order of the areas to which they relate. Accordingly, all the examples in AACR 2 of a separate note in the series area: "Original issued in series: ..." have been deleted (e.g. 2.7B12, 3.7B12, 8.7B12). These changes solidify the principle that the item in hand is described in the body of the entry and the details of the original appear only in the note area, a principle that has sparked much controversy, especially with regard to the cataloging of microforms.

Several of the other deletions to the text of AACR 2 eliminate redundancies which appeared when rules in earlier chapters were expanded (e.g. 2.1B2 is now covered by 1.1B10; 2.1F2 is now covered by 1.1F2; 5.1B2 is now consolidated in 5.1B1).

A FUNCTIONAL APPROACH TO DENOMINATIONAL AND LITURGICAL WORKS

A couple of items in Cat. Serv. Bull. 18 will be of particular interest to theological librarians. LC explains the rationale for entry of denominational publications such as the Book of Discipline of the United Methodist Church and liturgical works like the Book of Common Prayer under category a) of the general rule for corporate entry (21.1B2). Liturgical works are also covered by 21.39, which is the section of the chapter dealing with special rules. Canon law is mentioned as belonging to category b) of rule 21.1B2. ATLA librarians may not have considered the Book of Common Prayer or the Missal as a presentation of procedures for celebrating a particular act of worship, but on the other hand, no harm is likely to come from placing these works in the category of works of an administrative nature.

LC REPLIES: AACR 2 NAME HEADINGS

Matthew Rzeczkowski, Dominican College Library, Washington, D.C., recently asked Ben Tucker at the Library of Congress to clarify LC's procedures in establishing personal headings for early 20th century authors. Mr. Tucker replied that at the present time LC checks MARC records and LC printed cards in their original catalog for possible

conflicts. However, NUC volumes are not checked. Furthermore, NUC records are not included among the "reference sources" checked at LC to determine the form of name most commonly found (e.g. 22.3B2 and 22.3B3). (See the ATLA Newsletter, v. 30:2, p. 34 for a list of English language reference sources used at LC for religion.)

Fr. Rzeczkowski also asked specific questions about dates added to personal names. Ben Tucker's replies are in capital letters.

a) If a personal name heading on a pre-MARC LC card has dates, will the AACR 2 form include dates? YES.

b) If the editors of NUC have added a date or dates to LC copy, will the AACR 2 form include these dates? NO.

c) If a non-LC record created before 1981 has dates, will the AACR 2 form include these dates? OCCASIONALLY, YES: BUT NOT NECESSARILY.

d) If the person has died since one of these records was printed, will the AACR 2 form include a death date? NO.

Ben Tucker also noted that some details of the present search procedure will change in the coming two or three years. "For example, a little later this year, MARC records only will be searched for possible conflict."

Joe Howard of the Library of Congress reported to ALA last summer that LC is adopting a policy called Total Online Searching for Catalogers' Activities (TOSCA). "LC catalogers will rely solely on the online MARC bibliographic and name authority files to establish headings. Headings will be established on the basis of the publication in hand and the MARC files." (Cf. RTSD Newsletter, v. 7:5-6, p. 49.)

It is clear from these comments that the bibliographic verification procedures at LC do not include a check of NUC records. In fact, LC catalogers do not know what is in NUC at all. When LC implements the policy of searching the online files only, it is possible that conflicts will arise with their own printed cards that will only be discovered by libraries interfiling MARC and non-MARC cards. This will put pressure on LC to get more records on MARC.

At the same time, libraries can claim "standard" cataloging with no searching of printed LC records. In many cases this will result in a simplification of searching and cataloging routines. NUC and the printed catalogs will receive only occasional use as interlibrary loan locations are also derived from online searches.

ATLA RELIGION INDEXES TO ISSUE
SPECIAL BIBLIOGRAPHY ON THE ECUMENICAL MOVEMENT

The American Theological Library Association's Religion Indexes have announced plans for a special bibliography, The Ecumenical Movement, to be published this spring. Pre-publication orders at \$40.00 per copy should be sent to the ATLA Indexes, 5600 South Woodlawn Avenue, Chicago, Illinois 60637.

The bibliography is expected to list over 4,000 books and articles from the Religion Database's computer-readable files, which include: Religion Index One: Periodicals, 1975- ; Index to Religious Periodical Literature, vols. 1-4, 1949-1959; Religion Index Two: Festschriften, 1960-1969; Religion Index Two: Multi-Author Works, 1970- ; and Research in Ministry, 1981- (an index to Doctor of Ministry projects and reports). The Religion Indexes' special bibliography series is produced directly from computer tape into a format that uses Xerox's 9700 laser-beam printer and are bound in a simple binder for rapid distribution.

Of the material about 2,000 articles will come from the periodical indexes, about 1500 from the multi-author indexes, and about 500 from Religion Index One's Book Review Index. The RIT material includes about 230 books with tables of contents. Although final statistics are not yet available, these are anticipated: World Council of Churches, 700 articles; interdenominational relations, 1800 articles; Catholic Church, 900 articles; Lutheran churches, 280 articles; Anglican Communion, 170 articles; Reformed or Presbyterian Churches, 130 articles; Orthodox and Eastern Churches, 430 articles; Methodist churches, 70 articles; Sacraments and Christian Union, 240 articles; preparations for the 1983 WCC Assembly, 35 articles; Faith and Order Movement, 100 articles. About 25 percent of the journal article citations will include abstracts. Over 190 citations are to documents.

The material is indexed by denomination, other corporate bodies, names of countries, personal names, congresses, other events, and concepts.

About 60 percent of the material indexed by the Religion Indexes is in English; the remainder is in western European languages, Greek, and Hebrew. Over half of the non-English material is in German. The Indexes began in 1949 as the Index to Religious Periodical Literature and currently index over 330 periodicals and about 350 multi-author books each year.

The ATLA Religion Database is available online through BRS of Latham, New York. The new bibliography on the ecumenical movement will be the 20th bibliography produced in this machine-compiled series.

MARKET SURVEY AFFIRMS PRESERVATION PROJECT FEASIBILITY

Over \$400,000 annually can be anticipated from supporting libraries for a massive preservation program for religious monographs. This fact has emerged from the recently completed market survey conducted by the ATLA Task Force on the Preservation of Religious Monographs. The international survey was designed to test library interest in several approaches to the filming and marketing of theological books published between 1860 and 1929. Some 450 questionnaires were mailed and 182 were returned. This forty percent return rate is a solid response. The return rate among ATLA libraries was 60 percent. The Task Force now believes that the project can go forward confident that the financial base for this long-term enterprise has been found.

The Task Force shared the results of the survey with its Steering Committee May 13-14 in Princeton, New Jersey. During these meetings policy issues, structural models of organization, marketing options, and procedural issues for the project were discussed. The Task Force is now preparing a detailed plan for organizing and launching the project for presentation to the ATLA Board of Directors at its June 19 meeting in Richmond, Virginia.
