REPORT OF THE EXECUTIVE SECRETARY

The 1988 <u>Proceedings</u> are at the press. I'm betting that you receive them before you get this <u>Newsletter</u>. In any case, Betty O'Brien worked very hard to prepare the final copy with a laser printer at the United Theological Seminary. The font is a little different than last year, but very legible. I hope you like them. You'll find a number of substantive papers provided

By the way, if you see any mistakes in the names and addresses in the <u>Proceedings</u>, please inform me. I want to assure you we work very hard at keeping our lists up to date, but it is an unending task. Hardly a day goes by without our having to make some name or address adjustment. I'm sure you have noted that besides the membership directory in the back, there is a directory of officers in the front of the volume that gives ready access to names and addresses and conference dates. Telephone numbers can be exasperating too. Don't give up on us.

You should be seeing the audited financial statement either in this Newsletter or in the Proceedings. The Programs, both the Indexes and the Preservation Project, are holding their own. We are not out of the woods yet, but we have come a long way and can be grateful for the attention the Executive Committee of the joint boards are giving to them. The deep dip into the equity fund of the general account sent some shivers up my spine. We have to find ways to hold down deficit spending. Last year there were some emergencies that led to a number of called meetings that cost us, but which in the long run set up the adjustments that are now benefiting the whole operation. The Task Force on Strategic Planning is studying ways to reshape the whole organization. It is looking to propose consolidating many of the advances that have been made in the past few months. The office of the Executive Secretary is up for consideration too. I have alreay announced that I will not ask to renew my appointment when my present term expires in June of 1990. It is my sincere hope that this office and its services can be consolidated in one central office with the programs in Chicago, or wherever the operations are at that time. I think we are at a unique moment of our history wherein creative and positive moves can be made that we could only hope for just a few years ago.

In the meantime, I would like to do whatever I can to broaden our base of members and the enhanced financial base that new members will bring. We have not had a membership drive in several years now, and I think that I should make an effort in that direction. I hope to call on you for help. Please give some thought to persons and institutions that you feel should be members and are not. The ATLA is making a difference in theological librarianship and in theological research. We can be proud of its impact and unashamed to ask others to share in our vision. Write to me if you have some suggestions for new personal or institutional members.

The Duplicate Exchange Program is running smoothly. I recently had to remind some institutions that a list is expected at least every 18 months. The immediate response from most of them is clear indication of how vital that program is to many of our libraries.

Our annual conference will be in Columbus, Ohio, next June. It is not too early to begin to make plans. Our housing will be in a Holiday Inn at the Ohio Center. We have arranged with United Airlines to sponsor a reduced

rate. United has almost double the number of flights per day into Columbus of any other airline. In a recent issue of "Meetings and Conventions" I gleaned the following quotes about Columbus: "A fast growth city ... with few of the problems that plague older cities." "Columbus is the third largest research center in the world, surpassed only by Washington, D.C. and Moscow." "The meeting industry is a strong part of the city's expanding economy. According to one study, Columbus currently places 16th in the U.S. in terms of convention attendance." For you early birds, and it is never too early for us to plan, the United Airlines number to call is: 1-800-521-4041. Our account number is 400JQ. Generous discounts are provided. Inquire. Remember, the dates for the coming conference are June 18-23, 1989. The discounted airfares are available a few days before and a few after for those who may be combining other projects with meeting attendance.

At our conference last year, considerable interest was expressed in electronic networking. I attended a workshop on "The Church in a Digital World" at United Thoelogical Seminary in Dayton. Ever since then I have had almost daily online contact with people around the country through a utility called NWI. NWI stands for Networking & World Information, Inc. This company is interested in the ecumenical movement and sponsors Ecunet at half the going rate for online communication. Ecunet stands for Ecumenical Network and encourages communication within denominations and among them. An impressive list of denominations are active on Ecunet, including: Presbyterians, Disciples, United Church of Christ, Methodists, Baptists, Anglicans, Lutherans, United Church of Canada, etc. The Roman Catholics do not have an official representation, but there are many RC's that get on regularly, and there is an informal conference for them called, of all things, FISHNET. I have started a conference called "Ecunet Librarians" which already has 55 notes in it. I started it as a test run for a bulletin board for ATLA, but I have not taken any steps to move beyond where we are at the moment. All you need is a modem, access to tymnet, and a few pennies (\$). A number to call to inquire about getting on the network is: 1-800-624-5916. The address for a written inquiry is: NWI, 333 East River Drive, East Hartford, Connecticut 06108. (You can tell them Simeon sent you.) This network provides easy access to knowledgeable and dedicated people all across the continent and beyond. I have been keeping in touch with an alumnus in Honolulu. My bill for September was \$24.69. I had 43 accesses for a total of 199.4 minutes.

This is the season when we would normally be sending out our statistical forms for reporting. Because most of the institutions that would have any interest in the statistics are members of the ATS, I am presuming that we should not duplicate the work of the ATS office. All our institutions have received a first form and should shortly receive the one for the current year. All these statistics will be appearing in the ATS Fact Book. Our intent is not to duplicate efforts here. Should there be considerable alarm expressed over this decision, we will have time to garner the statistical reports in the Spring and still get them in the next Proceedings. Speak up!

REPORT FROM THE PROGRAM BOARDS

General comments. In late October ATLA personal members were sent the new Program Notes published by the Index and Preservation Boards. In that issue a new address for both the Index and Preservation Boards appeared in two places. Please disregard the 1520 Chicago Avenue, Evanston, IL address. Due to a number of problems Illinois Bell was facing in the lease of this property and others, it withdrew its lease offer to the ATLA. We began immediately to negotiate a lease agreement for office space at another Evanston, Illinois location. It is our hope to have a lease agreement completed by the end of November and to move by January 1, 1989. We will keep members and subscribers informed.

Index. RIT, 1976-80. Indexing for this project was completed during the third week of October and a first draft was created at that time. Editorial work on the drafts is scheduled for completion in late November, with photocomposition scheduled for early December. The project will be delivered to the printer by early January, with shipment to subscribers projected in March 1989. The schedule is ambitious but obtainable, given the fact that production is running only two weeks behind on this massive eighteen-month project.

The RIT-retro editor, Erica Treesh, has recommended that instead of printing two large volumes, we produce three smaller volumes. The reason for this recommendation is that the size and strength of the bindings for two large volumes may not hold up as well as the bindings on smaller volumes. So instead of two volumes, Religion Index Two: Multi-Author Works, 1976-80 will be published in three volumes. Volume 1 will contain the author/editor index and the indexes for the titles and series; volumes 2 and 3 will contain the subject index with an appropriate break in the alphabet to balance the size of the volumes. The prepublication price of \$495.00, which was to expire October 31, 1988, has been extended to December 31, 1988. Payment must accompany the order. After December 31, 1988, the price for the three-volume set will be \$565.00. If your library has not taken advantage of the savings provided by the prepublication offer, do so by contacting the Religion Indexes at 312-947-9417.

Richard R. Berg has resigned as Assistant Librarian of the United Theological Seminary in Dayton, Ohio, to become Director of Library Services at the Philip Schaff Library of Lancaster Theological Seminary in Lancaster, Pennsylvania. He took up his new suties on September 1, 1988. The Philip Schaff Library, built in 1968, houses a collection of nearly 140,000 volumes, with special strengths in biblical studies, theology, the Reformed Church in the United States, the Evangelical and Reformed Church, and its successor, the United Church of Christ. Mr. Berg is an ordained UCC minister. He had been at the United Theological Seminary since 1979, when he was appointed Periodicals and Learning Resources Librarian. He was named Assistant Librarian with primary responsibility for cataloging in 1982.

Jeffrey Brigham joined the staff of the Andover Newton Theological School in Newton Centre, Massachusetts, on September 12, as Technical Services Librarian. Mr. Brigham had previously served for eleven years on the library staff of Nyack College and Alliance Theological Seminary in Nyack, New York.

Thomas C. Clark assumed the position of Circulation Librarian in the Divinity School Library at Duke University in Durham, North Carolina, on October 3. A 1973 graduate of Duke with the B.A. degree in English, Mr. Clark comes to his new post from a position as Systems Analyst and Date Input Clerk in the Reserves and Media Section of the William R. Perkins Library, Duke's central library facility.

Norman Desmarais, Acquisitions Librarian at Providence College in Providence, Rhode Island, is the author of Acquisitions Systems for Libraries, recently released by the Meckler Publishing Company. The work appears as volume 11 in the "Essential Guide to the Library IBM PC" series. He has also recently published three articles: "Microsoft Bookshelf: A Personal Reference Library on Disk" in Laserdisk Professional; "The PC-Laser Library at Providence College" in CD-ROM Librarian; and "Experiments Increase Optical Storage Densities" in Optical Information Systems. Mr. Desmarais has written extensively and spoken frequently on the topic of optical discs and their application in education, business, and information science. He had served as Librarian of Austin Seminary since July 1, 1966, and earlier had been for four years Librarian of the Central Lutheran Theological Seminary in Fremont, Nebraska.

He had held this post since September 14, 1987, with responsibilities for the periodical collection and for the maintenance of the public catalog. On November 7, Dr. Wills took up new duties on a part-time basis as Archivist in the A. Webb Roberts Library at Southwestern Seminary.

CHURCH FEDERATION OF GREATER CHICAGO PUBLISHES DIRECTORY

The 1989-1990 edition of The Greater Chicago Religious Directory and Buyers' Guide has just been published by the Church Federation of Greater Chicago. This is the twentieth edition of this reference work, but twenty years have elapsed since the publication of the nineteenth edition for 1968-1969. This new edition was edited by the Reverend L. Dale Richesan.

The 755-page <u>Directory</u> divides Christian churches into two sections: Church Federation members, which includes twenty-three denominations and organizations; and other Christian groups, which consists of such diverse groups as the Roman Catholics, Assemblies of God, Mormons, and Jehovah Witnesses. The <u>Directory</u> also has sections devoted to ethnic churches and other religious centers such as Jewish synagogues, Buddhist and Hindu temples, and Islamic mosques, as well as an extensive list of religious and secular social service agencies.
