"Goodwill" as a Neglected Asset

I can't be the only one who finds the term "goodwill" a bit vague. It might connote several unrelated things (thrift stores?

"Peace on earth, good will ..."? something else?)

Other people, though, are apt to think of "goodwill" as an *accounting* term, having to do with "the value of a business over and above its net asset value." According to one glossary (http://www.finance-glossary.com/define.php5?t=1737), this kind of goodwill might include reputation, brand name, good customer relations, healthy morale, and other intangible but highly important contributors to an enterprise.

If this kind of goodwill is taken for granted, or ignored, or (yikes!) even presumed upon in our libraries, we'll soon see the results. For one thing, a shortage of goodwill is sure to have an effect on our other resources (try to picture a great library collection staffed by people with lousy morale); for another, when faced with hard choices, the way those choices are received will tell us a lot about whether we are in a goodwill surplus or a deficit.

An asset whose value is evident only when it's gone? Better to invest in its development than to let changing circumstances answer the question for us.

Annual Conference Travel Grant Program

We know that the impact of the U.S. economic downturn has affected many ATLA members. In addition to new conference programming specifically geared to address this topic, we will offer another practical response in the form of increased financial aid. Reports of decreased institutional professional development support have prompted us to modify and expand the popular Travel Grant program to assist more ATLA members. International Book Fair or FIL)
takes place annually from
the end of November to the
beginning of December. The
American Library Association,

in collaboration with the book fair, sponsors librarians to attend the fair through its ALA-FIL FREE Pass Program. Selected librarians receive three nights at a local hotel (six nights if you share with another sponsored librarian), three continental breakfasts at the hotel, registration fees to the fair, and \$100 to help with travel expenses.

Book publishers, bookstores, and distributors from around the world bring books and other media to sell at the fair. The majority of the exhibitors are from Latin America and Spain; however exhibitors from other countries such as Italy, Germany, Korea, India, France, Holland, Switzerland, United Kingdom, Canada, and the United States also attend.

Three days (usually the Monday-Wednesday of first full week) are open only to book-related professions such as librarians, editors, authors, and vendors. During these days, librarians have the opportunity to meet with publishers and booksellers to set up purchasing plans and/or purchase materials during the fair. This is also a time to network with fellow librarians and to attend professional development activities. During these three days, librarians may attend the Coloquio Internacional de Bibliotecarios (International Librarian's Colloquium) during which librarians share expertise on various topics with their international colleagues. The theme for 2008 was Información para el Cambio Social: el Papel de Las Bibliotecas (Information for Social Change: the Role of Libraries).

Every year, the fair invites a Guest of Honor (a place—a country, province, region, or city) to highlight. In 2008, it was Italy. In 2009, it will be Los Angeles. A variety of literary and cultural events take place during the fair, with a special emphasis given to the Guest of Honor.

The KALIPA Scholarship will provide financial assistance to a student of Korean heritage who is enrolled, or has been accepted into a master's or doctoral degree program in library and/or information science at a library school accredited by the American Library Association (ALA).

Elegibility Requirements

- Applicant must be attending or admitted into a Masters or Doctoral program in library school accredited by ALA.
- Applicant must be in library school by Fall 2009.
- Applicant may be either a full-time or part-time student.
- Applicant must be of Korean heritage.
- Applicant must join and continuously be an active member of KALIPA.
- Applicant must be a citizen or permanent resident of the U.S.
- Applications must be received by 3/31/09.

Andrew J. Sopko, PhD



Institution: Kenrick-Glennon Theological Seminary

Title: Director of the Library and Professor of Bibliography

Years as a theological librarian: 18

What have you enjoyed

about serving on the Local Host Committee for the 2009 ATLA Annual Conference? Brain-storming with other committee members about the many things we take for granted here in Saint Louis but which many conference participants would more than likely find of interest.

What would you like ATLA members to know about St. Louis?

That it has a surprisingly vibrant cultural life. While professional sports receive far too much attention here (as elsewhere in America today), some of our professional symphony, opera and theatre organizations can compete not just nationally but internationally. Right now, we have access to not only three home-grown opera companies but also travelling companies that bring operatic productions to town.

How did you become involved in the field? I had been teaching a rather heavy load of theology courses to enormous classes and I felt that there had to be a better way to do what I loved rather than facing academic "burn-out" at an early age. My current situation provides me with the best of both worlds: Administrative duties as a theological library director as well as a teaching load that does not overwhelm.

What do you love most about your profession?

As a layperson in the Orthodox Church, there were limited opportunities for me to find work in Orthodox institutions in the United States as these are few and far between. As a theological librarian, however, other doors were opened to me and I have enjoyed my time in both Protestant and Catholic institutions as "the honored guest". Furthermore, there could be no greater ecumenical experience in learning how "the other half" lives.

What has been the biggest change and/or challenge you've experienced while working in theological libraries? Technology, of course, as both curse and blessing. As someone who was involved in a library automation program from scratch, I can't imagine anything more challenging but now, I have learned to enjoy the fruits of those labors. Even so, I often wonder how anyone keeps up with all the technological changes with which librarians are bombarded. Luckily, I have an exceedingly talented staff person who does.

How does your institution benefit from its membership in ATLA?

Theological seminaries can be very insular places whose staff often don't know where to turn for advice and help. From my own personal experience, I know that ATLA's Member Services can be a great help in this respect. And where would our patrons be without the ATLA Religion Database®?

Would you recommend theological librarianship as a profession, and if yes, why?

Of course. Even so, I can't imagine someone doing it without some type of faith commitment in his or her life. While intellectual curiosity is a great motivator, I don't think it is enough to bring ultimate meaning and satisfaction within such a context.
