From the President Report on September's Virtual Town Hall Meeting

Thank you to the eight members who participated in the virtual town hall meeting on September 11 to discuss the proposed increase to Student and Individual membership dues. Also, thank you

to those who have offered feedback by e-mail or phone and in person. The Board will be discussing your questions, concerns, and suggestions during our meeting later this month. Most members have affirmed the need for an increase. There will be a proposal to increase individual and student dues on the January 2015 ballot, and your Board encourages you to vote yes on this increase.

During the town hall meeting, Executive Director Brenda Bailey-Hainer shared some information that may be of interest to all members. About a third of individual members are either Lifetime Members (paying no dues) or Student Members (paying dues at the lowest level). In addition, there are some institutional representatives that are not also Individual Members. Please note that individual membership has added benefits, including the opportunity to develop leadership skills by serving the Association on its committees, interest group steering committees, and Board of Directors. Brenda noted that approximately twothirds of the cost of member programs is covered by product revenue. While ATLA is developing new member programs in scholarly communications and reciprocal borrowing and enhancing ATLA's products, the value of our membership continues to increase. ATLA is also studying changing research habits in theology and religion and, at a future date, will make these findings available to members.

Overall, participants in the town hall meeting expressed appreciation for ATLA and are willing to pay increased dues for the benefits they receive.

Here is a summary of the feedback the Board has heard regarding the proposed dues increase:

- Student dues: Some members say the proposed \$35 is too high; others say \$35 is a fair amount.
- Lifetime membership dues: One lifetime member said lifetime members should pay dues. During the virtual town hall meeting most participants

said no, but that lifetime members should be encouraged to contribute to the Endowment Fund.

- The number of tiers/income levels in the member dues scale: Some members say there are too many levels; others say there are not enough or that there are too many at the lower end of the scale, but not enough at the higher end.
- At least one member encouraged the Board to discuss dues on a regular basis.
- Another member noted that there is a need for greater clarity regarding how to find one's correct tier/income level on the proposed scale (i.e., what counts as income?).

Participants in the town hall meeting also offered feedback on lifetime memberships, noting that other organizations require more than ten years of paying dues in exchange for free lifetime membership. This is an issue that the Bylaws Committee will pick up in the near future. During the meeting, we also discussed ways that ATLA could further support members (e.g., a scholarship fund for individuals whose institutions do not pay for association memberships). Brenda noted that the upcoming ATLA salary survey will include a question on whether one's institution covers the cost of professional memberships. We also briefly discussed how ATLA might retain student members who sometimes become members to attend annual conference at a reduced rate, but then do not secure jobs in theological libraries.

Overall, the Board is very impressed with the thoughtful feedback we have received to date. Again, thank you! Please keep it coming. <u>Your Board needs</u> to hear from you.

Preservation Survey Results Released by ATLA

The Institute of Museum and Library Services (IMLS) awarded the American Theological Library Association (ATLA) and its partners the Catholic Library Association (CLA) and the Association of Jewish Libraries (AJL) a National Leadership Grant for the project "In Good Faith: Collection Care, Preservation, and Access in

Small Theological and Religious Studies Libraries." A report on the project's main activity, a survey on preservation and collections care issues at small libraries and archives based at theological and religious studies organizations, has just been published and is <u>available to</u> <u>download</u>.

Key findings of the survey included:

- A lack of policies for preservation and digitization, although the number of organizations which include preservation in their mission statements and those with collection policies was high;
- The need to develop disaster plans, digital collection plans and policies, and environmental monitoring and control procedures;
- A need to conduct preservation needs assessment surveys of collections, policies, and buildings;
- A strong need to improve overall financial and staff support for preservation at institutions with budgets below \$100,000;
- Expanding capacity for collection processing, cataloging and finding aid development to increase discoverability of collections and their usage is also a strong need.

ATLA Executive Director Brenda Bailey-Hainer noted, "This collaborative effort reached a wide array of library and

archival institutions in theological and religious studies communities, and we were able to learn about preservation needs from many of the smaller organizations in the field. ATLA, CLA, and AJL will continue to work together to provide information, education, and support to help these organizations build preservation programs that address the identified needs." The Spring 2014 survey was targeted to organizations with staff sizes of less than five full time equivalent, and budgets under \$500,000. In addition to ATLA, CLA, and AJL members, the project partners reached out to other religious libraries and archives. The resulting 235

responses represented one of the largest surveys on preservation and digital practices in theological and religious organizations which has ever been completed. Responses were received from a wide variety of organizations, including those which are part of educational institutions, organizations affiliated with churches, synagogues, or other houses of worship, independent libraries and archives, and various other types of theological and religious based collecting organizations.

The partner organizations defined the target audiences as cultural heritage organizations which are part of a formal or established organization, have a library, archive, or other research collection which includes religious and/or theological materials, have religious and/ or theological historical or rare materials as part of the library, archive, or research collection, and have at least one contact person (volunteer or salaried, full-time or part-time) responsible for the care/ management of the research collection that could serve as the contact for the survey.

The partner organizations will be addressing the findings of the survey in communications with their membership, and will explore other collaborative preservation and digitization initiatives in the future.

IMLS National Leadership Grants for Libraries support projects that address challenges faced by the museum, library,

and/or archive fields and that have the potential to advance practice in those fields. IMLS offers grants to help make it possible for communities and individuals to thrive.

Expanded Affordability for Institutions in Eligible Developing Countries

ATLA announces the ATLA/EBSCO Developing Countries Initiative. As a not-for-profit association of theological libraries and librarians, ATLA understands the importance of supporting theological education throughout the world. Historically ATLA has worked to make its products affordable for libraries in eligible countries designated "developing" by the World Bank, along with other related criteria. Effective September 2014, ATLA and EBSCO have agreed to offer *ATLASerials*® (*ATLAS*®), an online full-text collection of 290+ major religion and theology journals, to eligible sites, without requiring a concurrent subscription to *ATLA Religion Database*®. In addition, ATLA member institutions can sponsor eligible sites that need assistance to gain access.

How do eligible sites sign up for access? How can ATLA member institutions sponsor eligible sites?

Interested sites, groups, and individuals are encouraged to contact Rick Rybak, ATLA Senior Business Development Representative, at <u>products@atla.com</u> or +1.312.775.9435 for personal assistance in pricing and setting up access, either to set up a direct purchasing arrangement or to inquire about sponsorship. Rick will be a liaison with EBSCO, and many ATLA members know him as a liaison with EBSCO on the *ATLAS for ALUM* grant program.

Note that access sponsorship is not limited to *ATLASerials*. Any institution may purchase any ATLA product on behalf of any accessing site around the world. For example, a library in an eligible developing country could sign a license agreement for ATLA's products as the "accessing site" and the bill-to address could be another institution as the sponsor, known as the "purchasing site." This arrangement is not limited to sites in developing countries and could also be used for any sponsoring relationship. For example, a seminary in the United States could sponsor access for another institution anywhere in the world. ATLA Partnering with SCELC on New York Times "Academic Pass" Offer

Through its relationship with SCELC, ATLA is able to participate in an inter-consortial offer that allows ATLA member libraries to provide an "academic pass" to the New York Times web edition. The "academic pass" access to the New York Times is identical to that provided by an individual subscription.

Subscriptions will run from January 5, 2015 - January 3, 2016. There is a limited time frame during which subscribers will be accepted for this subscription term - you must complete the application process with SCELC by December 5, 2014.

Through this offer, most ATLA member libraries are able to subscribe for about \$1.66 per FTE student enrollment plus faculty headcount. A SCELC transaction fee of 5% up to \$50 will also apply. For example, if an institution has 1,000 FTE, then its annual subscription cost would be \$1.66 x 1,000, or \$1,660 + \$50 (since 5% would be \$83) for a total of \$1,710.

To view the complete details of the offer, you will need to have registered on the <u>SCELC website</u>. If you decide to take advantage of this offer, your institution must be an ATLA member and also must become a SCELC Affiliate Member. There is no charge to become a SCELC Affiliate Member - <u>simply fill out the form</u>.

Section Editor for Bibliographic Essays - *Theological Librarianship*: an Online Journal of the American Theological Library Association

Theological Librarianship's Editorial Board is seeking a new Section Editor for Critical Bibliographic Essays, for appointment in March 2015.

About the position

The Journal's bylaws (2011) describe this position as follows:

Section Editor, Bibliographic Essays

The section editor for Bibliographic Essays is responsible for soliciting contributions and for managing the editorial process for Bibliographic Essays. The journal publishes Bibliographic Essays that survey and assess the literature on various topics related to the study of theology and religion, and thus facilitate theological education, research in religion, and informational reading.

A small stipend is paid to the editor with the publication of each issue.

Further information

The Bibliographic Essays Editor serves with four other members (section editors and a managing editor) on the journal's Editorial Board. For all Editorial Board members, the bulk of the work is a combination of responsibility for the individual sections and for the overall health of the journal.

TL is published semi-annually (in March and October). Typically the Editorial Board convenes about once a month online. Editorial Board members may be asked to participate in up to two in-person meetings per year. ATLA provides support for transportation and accommodations for these meetings.

- At some points in the year most of the Board's energy is absorbed with getting the upcoming issue ready for publication, while at other times there is more emphasis on long-term strategy, improving the health, and extending the reach of the journal, etc.
- A commitment of 3 years (renewable) to the position is strongly desired. All of *TL*'s editors are required to be Individual Members of ATLA.

- Basic experience in editing.
- Capacity to work collegially with authors and editors.

It is expected that this overlap will provide the appointee with ample opportunity to become familiarized with the routines and processes of securing content and working with the author(s) at each stage of publication.

From the Executive Director Shared Concerns: the 2014 BETH General Assembly

The 43rd BETH (Bibliothèques Européennes de Théologie) General Assembly was held in Wroclaw, Poland, September 6-10, at the Pontifical Faculty of Theology. The theme of the meeting was "Conserving and Protecting Library Collections for the Future: The Experience of Central and Eastern Europe".

Marcin Werla from the Digital Libraries Team

of Poznań Supercomputing and Networking Center (PSNC) spoke about the national digital library infrastructure created through Poland's PIONIER network. This impressive project brings together virtually over 2 million digital objects from 325 institutions throughout the country. FIDES (The Federation of the Church Libraries) is a consortium in Poland with over 80 members. Several members described various FIDES projects. Prof. István Pásztori-Kupán, a faculty member from the Protestant Theological Institute of Cluj in Romania, humorously described the lengths to which he will go to obtain access to materials needed for his research.

A portion of the meeting was devoted to discussion of online resources in theology and religious studies. Chris VendenBorre from Brepols talked about coverage and searching functionality in Index Religiosus. Some planned changes to *Index Theologicus (IxTheo*) were presented by Martin Faßnacht (University of Tübingen). Gregg Taylor, ATLA's Licensing Manager, provided updates on ATLA products and announced a change for *ATLAS*® subscribers in developing countries, an option that was well-received by BETH attendees.

The BETH General Assembly was sponsored by OCLC, De Gruyter, and Schult'z, each of whom gave a presentation. The Schult'z presentation was particularly intriguing. Their Technical Director, Prof. Luigi Pastorelli, focused on the development of voluntary standards for risk assessment in libraries.

No BETH meeting would be complete without visits to local libraries and churches. This year's event featured a bus trip to magnificent churches in Krzeszów and Swidnica as well as a tour of the Ossolineum Library in Wroclaw.

As always, it was a pleasure to attend and learn more about the activities of ATLA's European counterparts. It was especially good to see new participants from places like the Czech Republic and Croatia which are not usually represented at BETH. The array of presentations aptly illustrated that while there is great need among theological libraries in this part of Europe, libraries are still forging ahead with a number of initiatives. Just as in North America, collaboration between libraries brings greater success.

Two options for collaboration between ATLA and BETH are currently under discussion. One is the potential to build on the current ILATL OCLC group catalog to build a worldwide database of holdings from theological and religious studies libraries. The second is an effort to provide options for basic and continuing education for theological and religious studies librarians throughout the world, particularly in developing countries.
