## FATHER MICHAEL THORNTON TAKEN BY DEATH

Father Michael V. Thornton died unexpectedly from an apparent heart attack at Mary Immaculate Seminary in Northampton, Pennsylvania, on Friday, September 27. He had been hospitalized earlier in the month but had been released the day before his death. He had served as Librarian of the Seminary since 1972. He was 52 years old.

Born in Astoria, Queens, New York, Father Thornton was educated at Mary Immaculate Seminary, Fordham University, the State University of New York at Albany, and St. Joseph's College in Princeton, New Jersey. He was ordained on May 27, 1961.

A mass of Christian burial was celebrated on Monday, September 30, in the Mary Immaculate Seminary chapel; and a second mass of Christian burial was celebrated in the Lourdes Chapel at St. John's University in Queens, New York, on Tuesday, October 1. Father Thornton is survived by his mother, a brother, and two sisters.

## RELIGION INDEXES ANNOUNCEMENTS

At its October meeting the Index Board made a number of decisions that will affect the format of Religion Index One: Periodicals (RIO), beginning with volume 18, 1986. RIO's volume 18 format will reflect the following changes: 1) Journal title coverage will increase. 2) Abstracts will no longer be included in either the hard copy or database; author abstracts in the database through RIO, volume 17, 1985, will remain in the database.

3) The "Book Review Index" section at present in RIO will be removed; a new bi-monthly book review index entitled Index to Book Reviews in Religion will be published separately. (See information below.) 4) A biblical citation index will be added to RIO.

The price of RIO, vol. 18, 1986, will be \$265.00, plus postage and handling (\$6.00 domestic, \$7,00 foreign).

You will be able to assist the Index Board and staff in the choice of titles to be added to RIO by checking and rating the list of titles you will receive in the mail this month.

The Board also made the decision to begin the publication of Index to Book Reviews in Religion, beginning in January 1986. This new index will have the following format: Author/editor listing with citation to reviewer and journal in which the review appears (following the current format in RIO); alphabetical list of reviewers and titles with journal citation; book title index; series title index; annual classified index of book titles reviewed throughout the year; laser printed for 3-hole binder (binder included with subscription); published bi-monthly with annual case-bound cumulation. The subscription price is \$148.00. (Price includes postage and handling.) If a subscription is entered at the time of a renewed RIO, vol. 18, 1986 order, the subscription price for Index to Book Reviews in Religion will be \$125.00. Subscription invoices for RIO, vol. 18, will be mailed the first week in December.

Religion Index Two: Multi-Author Works (RIT). RIT, 1985, will have a biblical citation index added to it. The price of RIT, 1985, will be \$177.00 plus postage and handling (\$3.00 domestic, \$4.00 foreign). Libraries with two or more subscriptions to either RIO or RIT will pay \$165.00 for each additional copy of RIO, vol. 18, and \$100.00 for each additional copy of RIT, 1984.

## REPORT FROM THE EXECUTIVE SECRETARY

The move of the office of the Executive Secretary from Chicago to St. Meinrad has now been completed. The transition has been reasonably smooth though there continue to be unavoidable gaps of information. We keep narrowing these down. All the <u>Proceedings</u> for 1984 have been shipped to subscribers and members. Unpaid bills have been invoiced a second time. We have had good response from that.

We would like to give the impression that we are very professional about our use of computers. The fact is we struggle to get by. Our establishment of a mailing list was a minor victory. However, we are discovering that in our efforts to be complete we have gone beyond the limits of the labels and the word "library" has been dropped from some of the labels. This has been a problem for the library materials exchange program. I also failed to include a cover letter that reminds people of their responsibilities within the exchange. May I take a moment to remind those who are in the LME that they should put out a list at least once within an 18-month period. They are strongly encouraged to send their lists first-class. Those who have not yet used their labels should check them to make sure that "Library" appears some place on the label. Write it in by hand if necessary. Also please check that the zip codes are clear. In other instances we noticed that the zip code was either shortened or smeared.

Shortly we will be circulating to different institutions our revised statistical form for reports. We have waited this long in hopes that annual reports will have been completed so that the statistical analysis would be easier to fill out. We will appreciate your prompt attention when you receive the form.

We can assure, you that we are working hard at preparing the  $\frac{Proceedings}{Proceedings}$  of our conference last June. We have every hope of getting them out much sooner this year.

I have contacted Leon Pakala of ATS to inform him of the change of offices. I received a letter back assuring me of his continued interest and concern for the welfare of ATLA libraries. I look forward to continued opportunities to work with him in that direction. The association should be aware that there is a joint committee (i.e. ATS-ATLA) currently studying the area of collection development, and in general, following up the beginnings developed through Project 2000.

Our Canadian members should be alerted to the fact that the Canadian customs office does not look kindly on consultants coming from the States. We will be looking into this matter a little more closely to see if we can avoid the hassle at the border when a U.S. consultant is hired. More on this as we can get more information.

I understand European theological libraries struggle with many of the same problems that we do. They have an organization similar to ATLA. They are showing an increasing interest in automation and on-line searching. I understand that the Geac Corporation is providing a demonstration program for the Vatican library in the interest of automation there.

## PRESERVATION BOARD REPORT

The Preservation Board of the American Theological Library Association has several preservation projects under its direction.

The Serial Preservation Project is well established and one in which many libraries are already participating. Serials are microfilmed at the expense of the providing library, which in return receives a positive duplicate of that film. Other libraries may then order duplicates for the cost of film duplication, shipping, and handling. Libraries which are COMPORT members receive a special discount with their purchases. The ATLA maintains bibliographic control of the titles and publicizes their availability.

The Monograph Preservation Project has been in the planning stage for several years and is now becoming operational. More than 60 libraries and seminaries have made substantial funding subscriptions to the project. During the early summer of 1985, a preliminary first-year bibliography was distributed to the participating libraries. That draft was submitted to the Burke Library of Union Theological Seminary in New York for final check to be sure that the monographs listed were actually available for microfilming. We expect to receive Union's revised list this month. Each title will then be assigned a control/shipping number. In December we plan to send copies of the list to all of the participating libraries, and others which may be interested. Libraries will select the volumes which interest them according to the degree of their financial participation. They must return their selection lists in January so that the completed titles can be shipped to them. According to present plans, each title will be cataloged and cataloging-on-fiche will precede the title page on the microfiche. That information will be entered into the RLIN data base. We are also exploring the feasibility of tape-loading into other data bases such as OCLC and UTLAS.

Meanwhile, the contracts have been let for the primary microfilming and reformatting into microfiche. We expect to begin microfilming volumes in November and should have at least some of the fiche available by mid-Decem-By early January we should be in a full production schedule. filming some 100 to 125 books per week. If all goes as planned, by the end of January we expect to ship the first 500 titles, with the same number to be shipped approximately monthly thereafter. The goal is to have the first year titles completed and shipped to libraries by June 1986. At the annual ATLA meeting we hope to have on display the complete first year collection: During the Winter and Spring, we will be developing the second year list so that the libraries will have it too by June 1986. The Board is currently reviewing policies and procedures whereby other libraries may be encouraged to submit volumes for microfilming, and thereby receive a limited amount of "credit" toward the purchase of monographs from the collection. The goal is to encourage libraries to preserve their "worst case" titles by means of microfiche and thereby make them available to other libraries. The plan will also foster a wide spectrum of participants so that the rich theological diversity of our Association can be preserved. For the first year, the basic selection has been primarily in the biblical area. In future years we hope to have a balance of materials from the biblical, theological, historical, and pastoral/educational fields.

Other projects in the long range planning of the Board may include historical and denominational materials, special collections in theological libraries, and materials of local or geographical areas of interest. Suggestions would be welcomed by the Board.

On behalf of the Preservation Board, I would like to express my appreciation to the participating libraries, and especially to Dr. Charles Willard, for the role they have played and are playing in the success of the various preservation projects of the Association.

# UNITED THEOLOGICAL SEMINARY LIBRARY RECEIVES TWO SIGNIFICANT COLLECTIONS

United Theological Seminary Library, Dayton, Ohio, recently has been designated the recipient of collections from two prominent American church historians, Dr. Sidney E. Mead and Dr. Paul H. Eller.

Dr. Mead, whose teaching career included professorships at the University of Chicago, the University of Iowa, and Claremont School of Theology, has been characterized by his colleague, Dr. Martin E. Marty, as the "historian's historian." Probably best known for his study, The Nation With the Soul of a Church, Dr. Mead has assembled a collection which reflects his special interest in church history as it relates to the intellectual, social, and cultural history of America.

Dr. Eller, President Emeritus and Professor of Church History Emeritus of the former Evangelical Theological Seminary, Naperville, Illinois, has a collection which relates to the former Evangelical Church and the Church of the United Brethren of Christ. His library is being added to the denominational holdings of The Center for the Study of Evangelical United Brethren History at United Theological Seminary, a collection now numbering over 6,500 books and periodicals, in addition to archival holdings, housed in the Seminary library.

Books in Dr. Eller's collection include theological and historical works in German and English by prominent members of the Evangelical Church, numerous hymnals and Sunday School song books published by the Evangelical Church, the Church of the United Brethren in Christ and the Methodist Episcopal Church. These three denominations were involved in mergers which eventually formed the United Methodist Church.

United Theological Seminary is one of thirteen graduate professional schools of the United Methodist Church. Founded in 1871, the Seminary has a library of over 100,000 volumes. Elmer E. O'Brien is the Librarian.

# BIBLIOGRAPHIC SYSTEMS COMMITTEE REPORT

Current LC Subject Heading List in the Field of Religion. Volume 2, no. 4, for June 1985, of this list is being mailed as of November 1985. Since the last two issues have been over 50 pages long, the subscription price of the list will go up to \$10 for four issues with the next volume. On the subject of subjects, it was reported at the June meeting of the Bibliographic Systems Committee that we could look forward to some changes in the way the Library of Congress treats personal name subdivisions. Shakespeare will continue to be the pattern heading for literary authors. LC is going to work with one standard set of subdivisions for all other personal names, and take care of any specialized topics that might be attached to a name with the subdivisions "--Career in ...," "--Contributions in ...," "--Knowledge--," and "--Views on ..." For notes on the applications of these subdivisions, see LC Subject Manual, H1110, p. 3. As a result of this change, the name of Thomas Aquinas will no longer be printed in LCSH as the pattern heading for philosophers. The LC Subject Headings Weekly List no. 36 (Sept. 2, 1985) cancels the Thomas pattern and offers some interesting glimpses of the way LC will use the new pattern to cover him. Some examples:

Thomas, Aquinas, Saint, 1225?-1274. CANCEL

This name heading will no longer be printed.

--Aesthetics CANCEL

This is still a valid heading but is no longer printed in LCSH because it uses a freefloating subdivision.

--Angelology CANCEL

This heading has been replaced by the heading: Thomas, Aquinas, Saint, 1225?-1274--Contributions in Angelology.

There are four pages of deletions with similar notes. The main trend seems to be to place the old subheadings into the pattern "--Contributions in ..."

The PEOPLENET directory. Anyone who works with the acquisitions and cataloging of theological library material should be in the PEOPLENET directory. If you do not have the appropriate form, write to Clifford Wunderlich, Andover-Harvard Theological Library, 45 Francis Avenue, Cambridge, Massachusetts 02138. There is a copy of the form in every issue of the directory. This directory helps one to identify people who have skills to assist with particular library problems (such as cataloging Japanese theological works). Send your form in today. We would like to assemble a new edition before the next annual conference.

UKM records in the OCLC database. Those who work with OCLC records regularly have no doubt noticed the proliferation of UKM records in the database. These records are tape input from the National Library in Great Britain and have certain distinctive features. 1) These records bump memberinput records. 2) These records usually duplicate LC copy, making for yet more records to wade through when searching. 3) The cataloging on these records is not up to LC standards; in fact, these records are bumping member records which in many cases have significantly better cataloging. The libraries I have polled are treating these records as they do member-input copy. The Theological Users Group (TUG), which is ATLA's channel for input

into the OCLC Users Council, is considering a response to this situation which is making life more difficult for many cataloging and acquisitions personnel.

The authors, Gertrude Sovik and Charlotte Gronseth, have made extensive use of the China materials in the Luther Northwestern Seminary Library archives, in Saint Paul, Minnesota, and the Midwest China Center. This 320-page book, which contains over 50 photographs to illustrate the text, is available from Sovik-Gronseth, 4744 16th Avenue South, Minneapolis, Minnesota 55407, at a cost of \$15.00 a copy, plus a \$2.00 postage and handling charge.

## CORAL COMPLETES UNION LIST OF PERIODICALS

At the end of August 1985, The Council of Research and Academic Libraries (CORAL) in San Antonio, Texas, completed a two-year project to develop a union list of periodicals within OCLC's union list component. The new CORAL <u>Union List of Periodicals</u> consists of 17,532 titles and 39,500 separate holdings records. The work was funded by successive one-year LSCA Title III grants of \$61,000 and \$85,000, which were administered through the Texas State Library.

CORAL is a consortium of some 28 libraries in and around San Antonio. Its membership includes the San Antonio Public Library and a number of academic and special libraries. Twenty-seven CORAL libraries are participating in the new union list. The current president of the Council is James Maney, the Director of the Oblate School of Theology Library in San Antonio. CORAL patrons have inter-library borrowing privileges, and there is a delivery system that moves material among the CORAL libraries on a daily basis.

The San Antonio group is the second largest Texas consortium to develop an OCLC Union List, joining the Association for Higher Education from the Dallas-Fort Worth area, whose union list was completed earlier. Their holdings, as well as others from within Texas, are already being combined into a state-wide union list, sponsored by the Texas State Library.

# AUSTRALIAN AND NEW ZEALAND THEOLOGICAL LIBRARY ASSOCIATION FORMED

A meeting of 22 librarians and 11 other representatives of theological colleges and seminaries, at the 1985 Library Consultation of the Australian and New Zealand Association of Theological Schools at Luther Seminary, North Adelaide, South Australia, on August 26-27, produced the decision to form an association of theological librarians. It will be known as the Australian and New Zealand Theological Library Association. It will automatically include the 57 libraries of A.N.Z.A.T.S. schools and will provide for the involvement of libraries and/or individuals with similar interests in the field of theology and religious studies.

The new association is sponsored by A.N.Z.A.T.S. and is to be directly related to A.N.Z.A.T.S. in both its structure and its purpose. Where possible, conferences will be held in conjunction with the annual conference of A.N.Z.A.T.S. Relationships with the Library Association of Australia and the New Zealand Library Association are yet to be determined.

The decision to form the association follows a succession of A.N.Z.A.T.S. library consultations at which matters of mutual support, closer co-operation, and the development of standards have been discussed. The Adelaide consultation considered a further draft of the Guidelines for A.N.Z.A.T.S. libraries, which endeavoured to provide some quantitative guidelines for the provision of resources and services. It also gave lengthy consideration to the possible involvement of theological libraries in the Australian Bibliographic Network. Papers on A.B.N. were presented by Bill Thorn, Assistant Director-General, Reference Services, National Library of Australia, and Dr. Robert Withycombe, Warden of St. Mark's Library, Canberra, the first theological library to become a participant in A.B.N. The papers were backed up by a hands-on demonstration of A.B.N. enquiry mode by Chris. Harrison of the Department of Technical and Further Education.

For the first time, the consultation was extended to two days, to include a workshop on collection development. The workshop was conducted by Father Gary Gorman, lecturer in library studies at Ballarat College of Advanced Education. The aim was to provide participants with the background and resources for producing their own collection development policies.

Other features of the consultation were the key-note address on "Professionalism in Theological Librarianship," presented by Dr. Lawrence McIntosh of the Joint Theological Library, Ormond College, and a report on European theological libraries by Hans Arns of St. Patrick's College in Manly, New South Wales.

Tasks which lie ahead for the interim Executive Committee of A.N.Z.T.L.A. are the drawing up of a constitution for the new association, the inauguration of a regular bulletin, and planning the conference to be held in Canberra in August 1986. The committee charged with this responsibility consists of: a President, Trevor Zweck, Luther Seminary, North Adelaide, South Australia; a Secretary/Treasurer, Hans Arns, St. Patrick's College, Manly, New South Wales; and a representative of the state in which the next conference is to be held, Dr. Robert Withycombe, St. Mark's Library, Canberra, Australian Capital Territory.
