PRESIDENT'S MEMORANDUM

The midyear meeting of the ATLA Board of Directors will be held January 16-18, 1985, following the January 15-16 Program Committee meeting, with Drew University at Madison, New Jersey, serving as host. All committees, program boards and officers are reminded to prepare their midyear reports and forward them to the Executive Secretary by December 12, as previously requested. The above committees and officers, as well as any other members, are invited to send their items of agenda and/or recommendations for the Board of Directors addressed to me at Southern Baptist Theological Seminary, 2825 Lexington Road, Louisville, Kentucky 40280, or phone 1-800-626-5525 or (502)-897-4807. All members are asked to pray God's blessings and guidance for the meeting of the Board and the Program Committee.

Project 2000 is slated for special attention at the Board of Directors meeting. Several weeks ago, copies of the final printed report of the project were mailed to each President and Librarian of ATS and ATLA schools. Every member is urged to read and carefully study the report. The Board of Directors would be pleased to receive suggestions and recommendations from all members in response to the report, and especially as to ways that those ATLA and local libraries can be led to carefully examine the report, and develop specific projects and programs in response to it.

In a called meeting of the Board of Directors by conference telephone on November 2, 1984, approval was given for the purchase of an outstandingly excellent expanded IBM PC with letter-quality printer and associated software and accessories for the use of the ATLA Executive Secretary. It is expected that this equipment will greatly facilitate the work of the Association as regards membership lists, collection of dues, correspondence, production of <u>Proceedings</u>, and other statistical and word processing functions of the office.

The Ad Hoc Committee on Statistics, under the leadership of Dr. James A. Overbeck, has completed its assignment relative to the ATLA statistics gathering form, along with more careful and precise definitions, and a simplification of the process. By now all libraries should have received the form, with the request to complete and mail it to the ATLA Executive Secretary by December 21, 1984. It is hoped that the new personal computer and printer will enable the Executive Secretary quickly to compile, print and disseminate the spread sheet report of the statistics.

PRESIDENT'S MEMORANDUM - Continued

On November 5, 1984, it was the pleasure of your president to forward to the Lilly Endowment Fund the completed grant proposal in the amount of \$37,000 which the Ad Hoc Committee on Financial Management had prepared. The grant would fund a careful, professional review of the financial management of ATLA by the management consultant firm Peat, Marwick, Mitchell & Co. A final decision on the grant proposal should be forthcoming in March or April 1985.

All of us should be greatly inspired by the excellent support which the ATLA Preservation Board has received, and gratified at the progress made in launching the new Monograph Program, with forty-seven libraries subscribing a total of \$265.922, as reported at this time.

PETER N. VANDENBERGE, 1915-1984

The Reverend Peter N. VandenBerge, the Emeritus Director of Library Services for the Colgate Rochester Divinity School/Bexley Hall/Crozer Theological Seminary, in Rochester, New York, died on Wednesday, September 12, following several years of declining health.

Mr. VandenBerge was born December 16, 1915, in Kalamazoo, Michigan. He was a graduate of Hope College (A.B., 1937), of the University of Nebraska (A.M., 1938), of the New Brunswick Theological Seminary (B.D., 1943), and of Rutgers University (M.L.S., 1959).

Prior to coming to his post in Rochester, Mr. VandenBerge served as pastor to the First Reformed Church of Walden, New York, from 1943 to 1948, and of the Lincoln Park Community Church of Yonkers, New York, from 1948 to 1956. From 1957 to 1967 he was Librarian of the Gardner A. Sage Library at New Brunswick Theological Seminary in New Brunswick, New Jersey.

Mr. VandenBerge assumed his responsibilities at the Ambrose Swasey Library of the Colgate Rochester Divinity School at about the same time that the Rochester Center for Theological Studies was being created. The Rochester Center soon brought two other seminaries to the Colgate Rochester campus: Bexley Hall (an Episcopal seminary originally in Gambier, Ohio) in 1968 and Crozer Theological Seminary (a Baptist seminary from Chester, Pennsylvania) in 1972. It became Mr. VandenBerge's responsibility to direct the integration of these schools' libraries into the Ambrose Swasey Library. Every book (including those already in the Swasey Library) had to be recataloged and reclassified. During his tenure the library grew from 110,000 volumes to 210,000 volumes.

Mr. VandenBerge's services to the American Theological Library Association were many and varied - on the Board of Directors, on the Index Board, as Treasurer from 1964 until 1967, as Vice-president in 1971-72, and as President in 1972-73. He also continued to serve as an active churchman in his denomination, the Reformed Church in America, publishing two editions (1966 and 1978) of the Historical Directory of the Reformed Church in America.

Peter VandenBerge is survived by his wife, Julia, his daughter Mary Elizabeth and his mother, Mrs. Nicholas VandenBerge. Another daughter, Julie, preceded him in death. A Service of Thanksgiving for his life and ministry was held in the First Reformed Church in Rochester at 2:00 p.m. on Friday, September 14.

WILFRID LAURIER UNIVERSITY COMPLETES LIBRARY BUILDING

A ceremony on October 19 marked the opening of the final two floors of the Wilfrid Laurier University Library in Waterloo, Ontario, Canada. The completion and occupancy of the sixth and seventh floors also marked the completion of the library building for which planning had begun in 1962 and construction had begun in 1964. A long-term three-phase construction program was projected from the beginning.

The first unit was dedicated on September 18, 1965, and consisted of the present second (main) and third floors with the mechanical area on the lower level. It was designed to house 90,000 volumes and 450 readers. On May 1, 1970, construction was begun on the fourth and fifth floors, with the occupancy of these levels coming at the end of the 1970-71 academic year.

Construction of the third and final section of the library building, the just completed sixth and seventh floors, began in the summer of 1983. The new floors offer users additional stack and seating space, more microform readers and printers, expanded music listening facilities, and additional typing booths and photocopiers. The completed building has stack space for 425,000 volumes and seating space for 932 readers.

Erich R. W. Schultz became University Librarian at Wilfrid Laurier on July 1, 1960, and thus has had oversight over the entire history of the building program and the development of the library collection which has accompanied it.

INDEX BOARD REPORT

In a letter dated August 20, 1984, Dr. Ruth F. Fraser submitted to the Index Board her resignation as Editor of the Religion Indexes. The Board formally accepted the resignation in a meeting on September 19 and fixed February 1, 1985, as its official effective date. An accumulation of leave time due Dr. Fraser will mean, however, that her last active day in her position will be December 14. She officially began her service as Editor of the Indexes on February 1, 1983.

The Board has named Albert E. Hurd, the Executive Secretary of the ATLA, as Interim Manager of the Religion Indexes until a new Editor is appointed.

The Index Board wishes to express its own appreciation and that of the Association for Dr. Fraser's dedication to the Religion Indexes as well as for her generous use of her time, talent, and energy in the service of the products of the Board. We wish her an interesting and satisfying future and pray for God's richest blessings on all of her future endeavors.

Clifton G. Davis, Librarian of Bangor Theological Seminary in Bangor, Maine, has been appointed to represent the Seminary on the Editorial Board of Prism: A Theological Journal of the United Church of Christ.

Prior to assuming her new position, she was Acting Head of Technical Services at the Catholic Theological Union in Chicago.

Norman G. Wente, Chief Librarian at Luther Northwestern Theological Seminary in St. Paul, Minnesota, presented a paper entitled "HAL, the Automated Librarian; or How the Computer Has Taken Over the Library" at the meeting of the Lutheran Historical Conference which was held on the seminary campus November 1-3. The Conference is an association of Lutheran librarians, archivists, and church historians.

Cecil R. White, Librarian of Golden Gate Baptist Theological Seminary in Mill Valley, California, was awarded the Ph. D. degree in library and information sciences by North Texas State University in Denton on August 18, 1984. His major professor and supervisor of his dissertation was Dr. Doralyn J. Hickey. The title of the dissertation is "The Extensive Subject File: A Study of User Expectations in a Theological Library." The study was conducted in the Graduate Theological Union Library in Berkeley, California, and had its origin in two conferences on subject headings sponsored by the ATLA in the late 1970s. Dr. White has served as librarian at Golden Gate Seminary since 1980 and prior to that date was for ten years Assistant Librarian at Southwestern Baptist Theological Seminary in Fort Worth, Texas.

SUMMARY OF THE EVALUATIONS OF THE 1984 ATLA CONFERENCE, HOLLAND, MICHIGAN

A total of 85 evaluations forms were returned. Twenty-eight persons "agreed" and 51 persons "strongly agreed" that the Conference was beneficial and comments such as the following were made: "I thought that the Conference Program and facilities were excellent this year." "One of the better conferences ... the committee is to be commended." "I enjoyed the whole week."

The major paper and "Papers Sessions" were well received. Also, the workshops on Wednesday morning elicited very favourable responses. While improvement was noted over last year, many persons felt that some of the section and denominational meetings could be upgraded. Responses to the interest groups varied depending upon the topics and the individual expectations of the persons attending. While many appreciated the Wednesday afternoon trips, Saugatuck did not meet some individuals' expectations.

With regard to chapel periods, some liked having the devotional periods at different times, while others didn't. A few found them "too denominational" and expressed surprise at an unusual choice of topic, but many felt that they were excellent, "a needed quiet time," and the message and music were inspiring.

Martha Aycock received many accolades for her "efficient, effective, well run, first rate" business meetings. Some felt that they were a bit rushed and that more time was needed for adequate discussion.

The only negative comments about housing arrangements were made by a few people who seem to have had poor mattresses and no coat hangers in their rooms. The institutional meals were rated very highly, the banquet was thought to be superb, many appreciated the wide variety at meal times and the generous servings. A few persons did not expect the weather to be as hot in the more northerly regions and would have liked air conditioning in the meeting rooms and dormitories. Many liked the fact that the meeting rooms were close and convenient and some even offered ideas on better seating arrangements for participation. All but one agreed that the conference expenses were reasonable. As in Richmond, many attendees enjoyed the fruit and juices along with coffee and cookies at the breaks and thought the outdoor setting was "extremely pleasant." Interestingly enough, a few thought breaks should be longer, while a few felt time was wasted.

In response to "what did you like most?" an overwhelming number of replies indicated that seeing colleagues, getting together for fellowship, informal sharing of ideas and meeting people (especially for new members) as well as the "spirit of the librarians" were the most important. Comments were made about the fine blend of the academic and practical aspects of the program. Positive comments were made on individual papers and sessions, local arrangements, the beautiful campus, the pace of the conference, and the excellent planning which made it a stimulating week.

Under the "dislikes" individuals mentioned the lack of air conditioning, a long wait for the buses to Saugatuck, and the fact that many reports were handed out just prior to the session at which they were discussed. There were some individual opinions about the various sessions and the comments on the many business meetings (but also an awareness that they were

necessary), the seating arrangements, the individual conflict in deciding on which session to attend when there were competing interests. A few thought the schedule was too tight. Some new members would still like to become more involved, find out more about ATLA and the work of Committees and Sections. On the other hand, people disliked "leaving," "having to go to bed," and getting up for "a 7:00 a.m. flight."

When asked what individuals would have done to improve the Conference, a few new members requested more orientation and information on ATLA, past and future, and that they be asked to express their interests. Some people would like more opportunities for group sharing, more background information on the host seminary and its denomination, more presentation of the work of ATLA in the business sessions ("a few good fights"), more structure, less structure. Several people requested a list of registrants (there was one) and room numbers, and others would like to see the home institution, city, and state included on the name tags. Several people would like to see the program pay attention to the needs of smaller libraries, give more practical advice and less theory, and have smaller groups for better discussion. Other comments included a request for better location of displays, an organized "job listing," more time for browsing, and more free time to talk and visit informally. A few people also offered suggestions on workshop topics for future conferences, which the Program Committee has noted. Other suggestions for improvement ranged all the way from a facetious comment that "the psalms should be chanted backwards at midnight" to "nothing."

Readers will note that the same items appear under various headings but that depends on the likes and dislikes of the individual. It is apparent, however, that the 1984 program was well received and the campus and local arrangements were rated very highly. Remarks and suggestions are being noted by the Program Committee and will be discussed when planning for the 1985 conference.

OCLC INTEREST GROUP AT JUNE CONFERENCE FORMS TUG

It is independent of the ATLA but will continue to meet in conjunction with the annual ATLA conference. Two officers were elected for the 1984-85 year: William C. Miller of the Nazarene Theological Seminary as President, and Melinda Ann Reagor of Duke University as Secretary. John Shaloiko is OCLC's liaison officer for TUG and will attend the 1985 meeting of the group in Madison, New Jersey, in June. The exact date and location of that meeting will be announced later.

TUG"s purposes are to communicate members' needs and concerns to OCLC, to help members utilize more fully OCLC services and products, to provide a forum for solving problems related to OCLC use, and to share news and information of interest to TUG members. Proposed by-laws, a membership directory, and nominations for the officers for the 1985-86 year are being prepared so that the membership can act on these matters at the June meeting.

The first issue of the quarterly <u>TUG Newsletter</u> was mailed to TUG members in October. TUG members include those who expressed interest at the Holland conference as well as those who have since then responded to OCLC's log-on messages about the group. ASBURY SEMINARY LIBRARY RECEIVES NHPRC GRANT

The National Historical Publications and Records Commission at its meeting on October 25-26 funded a grant proposal for a records management and archives project written by the B. L. Fisher Library at Asbury Theological Seminary, Wilmore, Kentucky. This is the first grant proposal written by a seminary to be funded by this commission.

The grant is for a period of two years, beginning March 1, 1985, and will make possible the development of a fully integrated archival records management program. This project will preserve the historical records of Asbury Theological Seminary and establish a mechanism whereby future records are maintained, processed and made accessible for research. It will also allow for the processing of the current backlog of historical manuscript collections already in the possession of the B. L. Fisher Library.

The records management program developed during the grant project will be made available to other interested theological institutions.
