Simeon has served the ATLA faithfully and well and with unfailing grace and good humor - both as President and as Executive Secretary. We are greatly indebted to him, and we rejoice in the esteem and affection that he enjoys among ATLA members.

Planning is underway to relocate the office of Executive Secretary to the office complex of the ATLA Index and Preservation Programs in Evanston, Illinois. A committee composed of Mary Bischoff (Chair), James Dunkly, Al Hurd, and myself, has been at work on arrangements for locating the office there and on finding a person well qualified to carry on the work of Executive Secretary. We anticipate being able to announce an appointment at the June conference.

# NOTICE OF PROPOSED AMENDMENT OF THE ATLA CERTIFICATE OF INCORPORATION

This is official notice, as required by Article XI of the Certificate of Incorporation of ATLA, that in a general session of the annual meeting of ATLA scheduled for June 25-28, 1990, the Board of Directors will present for vote of the Full Members and authorized representatives of Institutional Members the following resolution:

RESOLVED, that the Certificate of Incorporation of this corporation be amended by (a) changing the Article thereof numbered "IX" so that, as amended, said Article shall read as follows:

Except as herein provided, the property, affairs, and business of the Corporation shall be managed by the Board of Directors.

and (b) adding the following Article XIII, following existing Article XII:

To the fullest extent permitted by the General Corporation Law of the State of Delaware as it now exists or may hereafter be amended, no director of the corporation shall be liable to the corporation or its Members for monetary damages arising from a breach of fiduciary duty owed to the corporation or its Members.

#### ANNOUNCEMENTS FROM THE INDEX AND PRESERVATION BOARDS

Fay Dickerson retires. Fay Dickerson, who has served the ATLA Religion Indexes for over twenty-four years in various capacities - Director, General Editor, and most recently as Editor of Religion Index One - retired on May 4. Fay's many contributions to the indexes and to the production of one of the most significant ongoing bibliographies in religion will long be remembered by her coworkers and users of the indexes. I am sure many of Fay's ATLA colleagues will want to express their appreciation to her at the ATLA Annual Conference.

New appointments. RIO Editor: Mr. Don Haymes has been appointed as the Editor of Religion Index One: Periodicals (RIO). Mr. Haymes is currently the Reference Librarian at the University of the South School of Theology in Sewanee, Tennessee. Previous to this position, Mr. Haymes was an acquisitions and general editor at Mercer University Press. Mr. Haymes will join the Religion Index staff on June 1, 1990. Director of Marketing: Janice Anderson, who has worked in the ATLA business office in a number of capacities since September 1989, has been appointed Director of Marketing, effective May 1,1990. This is a shared full-time appointment by the Index and Preservation Programs.

ATLA Serials Preservation Program. The ATLA Serials Preservation Program owes a large part of its success to the many donor libraries who have contributed serials and assumed the cost of producing the master negative. REcently the Preservation Program instituted an expanded donor policy whereby a group of libraries can cooperatively assume the costs of producing the master negative for serials in need of preservation microfilming. By special request, we are currently seeking libraries which would like to share the costs of filming the following three titles for which complete holdings are not now available on microfilm:

Catholic Biblical Quarterly (especially v. 1-10; incomplete set available from UMI)

# Attention Catalogers!

The ATLA Bibliographic Systems Section would like to strongly encourage ATLA catalogers to attend the all-day workshop on "Uniform Titles for Theological Materials" this summer in Evanston. This workshop is not designed for the mythical "uniform title specialist" buried at a desk in some overgrown research library (if that person exists at all), but for the typical ATLA cataloger who occasionally has to deal with uniform titles and wants to become familiar with the resources that will help him or her to properly construct uniform titles.

Our two workshop leaders, Judy Knop )from the ATLA Preservation Board) and Brian Helge (formerly at the Center for Research Libraries), both are experienced workshop leaders, having presented similar programs for ILLINET. And both of them have extensive experience cataloging theological materials at libraries. They have designed an informative program that includes handson assignments in the United Library's reference collection.

The workshop will be held on Monday, June 25 from 9 a.m. to 4 p.m. on the campus of Northwestern University; the cost is \$50. Registration information was mailed to all ATLA members. # Cataloging Standards: Accuracy or Productivity?

The June 1990 Bibliographic Systems Section meeting in Evanston (on Thursday afternoon, June 28) will feature a discussion on cataloging standards and philosophies, or, "Are We Bibliographic Slaves or Free Catalogers?" We have a panel of librarians representing different types of libraries for a practically oriented discussion about:

Use of LC/OCLC/RLIN copy: do you verify headings? description?

Call numbers? How many times does the record get proofread?

What level of staff does your copy cataloging: professional,
paraprofessional, or students?

What areas, if any, do you (or have your predecessors) intentionally deviate from LC practice: non-approved use of subdivisions? difference in choice of series title? variations from LC Name Authority form of corporate body names, uniform titles, etc.?

How often does your staff consult reference works such as LC's Subject Cataloging Manual, the CONSER Serials Editing Guide, etc.?

We hope to have an open discussion on how cataloging standards affect productivity, and on how standards vary dependent on the size of library, implementation of an online system, etc. Things aren't as simple as they once were, but we might get some helpful perspectives from each other.

# REFERENCE BOOK REVIEWS AND PROVOCATIVE REFERENCE QUESTIONS FROM THE PUBLIC SERVICES COMMITTEE

### Book Reviews

The Public Services Committee here shares brief impressions of reference works recently added to - or recently discovered in - the collections of its members' libraries. Newsletter readers are invited to submit contributions to Judy Clarence, Head of Reference, Graduate Theological Union Library, 2400 Ridge Road, Berkeley, California 94709.

While visiting a public library recently I spotted a title I knew would be important to add to our Reference Collection here at the GTU. Titled  $\underline{A}$  Christian writer's manual of style, by Bob Hudson and Shelley Townsend (Grand Rapids, Michigan: Zondervan Publishing House, 1988), this very handy paperback volume takes the writer from manuscript preparation to proofreading, with excellent chapters on punctuation, capitalization, abbreviations, Biblical citations — even a section on "Christian cliches" to avoid, and a table of proofreaders' marks. Just the tool for helping people decide whether to capitalize "devil" or "apostle John," how to abbreviate "Thessalonians," or how to formulate citations of scripture passages.

Another important title we've added recently is <u>Dictionary of the liturgy</u>, by Rev. Jovian P. Lang, OFM (New York: Catholic Book Publishing Co., 1989). This book defines such terms as "concelebration," "horologian," "postulancy" in clear, accessible, understandable language. Pronunciation is included, as are some rather pedestrian but not too distracting illustrations.

The Biographical dictionary of contemporary Catholic American writing, edited by Daniel J. Tynan (New York: Greenwood Press, 1989), contains 135 biographical and critical essays on a representative group of contemporary Catholic American poets, dramatists and fiction writers. The absence of Hispanic-American writers in the volume is explained in the preface as an effort not to duplicate material in Chicano literature: a reference guide (1985). Tynan's work is not all-inclusive, but gives good coverage of the writers represented, some of whom (like Paul Theroux, for example) I didn't know were Catholic. Excellent bibliographical information is given, as is thorough indexing. I wish Tynan had included a list of the authors covered, however - you have to page through to find out who's there.

## Reference Questions

A warden of a prison in Northern California called the GTU Library to inquire as to whether Rastafarians are vegetarian. One of his prisoners claimed his religion did not allow him to eat meat, and the warden suspected the prisoner was just trying to be obstreperous. For questions of that type we go first to Religious requirements and practices of certain selected groups: a handbook for chaplains, put out by - of all people - the U.S. Department of the Army, in 1978. But that volume does not describe Rastafarians, so I went to the stacks after checking the subject catalog ("Ras Tafari movement" is how it's listed) in search of The Rastafarians: sounds of cultural dissonance, by Leonard E. Barrett, Sr. (Boston: Beacon Press, 1988). Barrett cites the Rastafarian ten-point moral code, written by Sam

Brown. No. 2 states, "We are basically vegetarians, making scant use of certain animal flesh, outlawing the use of swine's flesh in any form, shell fishes, scaleless fishes, snails, etc." A bit ambiguous, but Barrett's commentary states, "The diet of the Rastafarians is very rigid; for example, meat as a whole is considered injurious to the body." I guess the warden will have to begin providing vegetarian alternatives.

# BIBLIOGRAPHY: PRIVACY AND CONFIDENTIALITY IN REFERENCE SERVICE

These selections include only the most pertinent of the articles of the last ten years. They focus on privacy and confidentiality in Reference activities. This necessarily excludes works about issues in particular departments such as acquisitions, cataloguing and circulation. It also eliminates most of the general essays on ethics in the profession because they are too broad.

The problem of privacy is dealt with by government legislation in many countries. The laws affect the libraries; many librarians respond in writing to government regulations and to library policies. In 1975 the American Library Association devised a code; individual libraries and librarians responded to the code and it was revised in 1981.

The comparative literature comes from the professions of law and medicine and their discussions of ethics in their libraries. Over the past decade, confidentiality and privacy are buried amongst the problems of precision and accuracy, responsibility and judgment. This is true of business and public libraries as well.

Theological librarians have not written about ethics in their libraries, nor have they discussed the issues of privacy and confidentiality.

Martha Aycock. At its meeting on February 6, 1990, the Alumni/ae Board of Directors of Union Theological Seminary in Richmond, Virginia, passed the following resolution:

"Whereas, Martha Aycock has served faithfully and effectively on the Union Theological Seminary library staff since 1953, becoming Acquisitions Librarian in 1961, Reference Librarian in 1967, and Associate Librarian in 1988, and, Whereas, she will retire in 1991 after thirty-eight years of assisting students, faculty, and alumni/ae in their theological studies, Be It Resolved that the Alumni/ae Board of Directors, meeting February 6, 1990, hereby designates the Alumni/ae Library Book Fund, now being raised, as the Martha Belding Aycock Alumni/ae Book Fund. And, further, that this designation be placed in each volume obtained from the proceeds of this endowment."

The aim of the alumni drive is to raise a fund of \$500,000 over the next three years; and Dr. John B. Trotti, Librarian at Union, reports that three-fifths of this amount has already been secured.

John D. Baker-Batsel has resigned his position as Director of the Graduate Theological Union Library in Berkeley, California, effective May 25, 1990, in order to return to the parish ministry. He will become minister to the United Methodist Churches in Braden and Mason, Tennessee, both near Memphis. Mr. Batsel has held his present post since September 1, 1977, and during his nearly thirteen years of service has been responsible for the planning and construction of the award-winning Flora Lamson Hewlett Library, and for the integration in this building of the book collections of the nine member institutions of the Graduate Theological Union.

Lynda Buch has resigned her position as Public Services Librarian at Ontario Bible College and Ontario Theological Seminary in Willowdale, Ontario, effective May 31, 1990. In June she will enter the BUILD program in Toronto, Ontario, which will include a year of specialized training and experience in urban ministry.

David William Faupel, Director of Library Services at the B.L. Fisher Library at Asbury Theological Seminary in Wilmore, Kentucky, was awarded the Ph. D. degree in theology by the University of Birmingham, England, on December 15, 1989. His dissertation title is <a href="The Everlasting Gospel">The Everlasting Gospel</a>: The Significance of Eschatology in the Development of Pentecostal Thought.

Leslie R. Galbraith resigned his position as Librarian and Associate Professor of Bibliography at Christian Theological Seminary in Indianapolis, Indiana, effective March 16, 1990. He had served in that position since 1972. Mr. Galbraith has not announced his plans for the future save for the fact that he expects to remain in the Indianapolis area.

Isaac Gerwitz has been appointed Rare Book and Manuscript Librarian at the Bridwell Library of Southern Methodist University in Dallas, Texas. Mr. Gerwitz has been associated with the New York Public Library since the beginning of his library career. From 1977 until 1984 he was engaged by the Judaica Division of the NYPL, providing at different times service in reference, book selection, and cataloging. He also helped formulate the conservation goals for the rare Judaica holdings of the Library. In 1986 he began duties as Librarian in the Rare Book Room, assisting in reference, reviewing rare book cataloging, and selecting 15th- and 16th-century books for purchase. Mr. Gerwitz received the B.A. degree from Yeshiva University in New York City in 1971, and the M.L.S. degree from the Columbia University School of Library Service in New York City in 1983. He is currently completing the Ph. D. degree in the Columbia University Graduate School of Arts and Sciences, specializing in the history of the Renaissance and the Reformation.

Herbert Giesbrecht plans to retire in the summer of 1990 as Librarian of the Mennonite Brethren Bible College in Winnipeg, Manitoba. He has served in this position since 1955 and was the first full-time librarian to hold the post. For fifteen of his years at the College, Mr. Giesbrecht has also taught courses in the English Department.

Lucille Hager retired as Director of Christ Seminary Library in Austin, Texas, on December 31, 1989, completing thirty-eight years of service to the church as a theological seminary librarian. A dinner honoring Miss Hager was given by the Lutheran Seminary Foundation of the Southwest on Sunday evening, February 11, 1990, at St. Martin's Lutheran Church in Austin. She will continue to work in the library on a part-time basis.

Valerie R. Hotchkiss took up her duties as Director/Librarian of the Stitt Library at Austin Presbyterian Theological Seminary in Austin, Texas, in July 1989. She holds the B.A. degree from the University of Cincinnati, the M.Phil. and M.A. degrees from Yale University, and the M.L.S. degree from Southern Connecticut State University in New Haven. She has also studied classical languages and German literature at the University of Tübingen, and is at present a candidate for the Ph.D. degree in medieval studies at Yale. Ms. Hotchkiss has previously held library positions at Yale University and the University of Bridgeport.

Norris A. Magnuson, Library Director and Professor of Church History at Bethel Theological Seminary in St. Paul, Minnesota, and William Travis, Professor of Church History at Bethel Seminary, have compiled American Evangelicalism: An Annotated Bibliography which will be published this month by the Locust Hill Press. The volume of nearly five hundred pages includes about 2,700 books, dissertation, and periodical entries. Dr. Magnuson's

earlier work, Salvation in the Slums: Evangelical Social Work, 1865-1920 (ATLA Monograph Series 1977), has recently been reprinted in paperback format by Baker Book House.

Richard H. Mintel, Associate Librarian of Trinity Lutheran Seminary in Columbus, Ohio, will exchange positions with Trevor Zweck, Librarian, of Luther Seminary in Adelaide, South Australia, later this year. Mr. Mintel will serve as Visiting Librarian at Luther Seminary from July 1990 through January 1991; and Mr. Zweck will be at Trinity Seminary from August 1990 through January 1991. The exchange is being made possible by the financial support of the two seminaries, the Lutheran World Federation, the Lutheran Brotherhood Insurance Company, and the Aid Association for Lutherans.

Hugh Rendall has been appointed Public Services Librarian at Ontario Bible College and Ontario Theological Seminary in Willowdale, Ontario, effective June 1, 1990. For the past four years he has served as Librarian of Central Baptist Seminary. He has also developed the Archives for the Fellowship of Evangelical Baptist Churches in Canada. Mr. Rendall holds the Bachelor of Arts degree from the University of Waterloo, the Bachelor of Theology degree from Central Baptist Seminary, and the Master of Library Science degree from the University of Toronto.

Janice Rod has been appointed Theology Catalog Librarian at the Alcuin Library, St. John's University in Collegeville, Minnesota. Ms. Rod received the Master of Divinity degree in 1981 and the Master of Theology degree in 1983 from Luther Northwestern Theological Seminary in St. Paul, Minnesota, and was recently awarded the Master of Arts degree by the University of Iowa School of Library and Information Science in Iowa City.

Ruthanne M. Strobel and Richard M. Huff were married in The Church of Our Saviour in Atlanta, Georgia, on Saturday, February 17. Mrs. Huff plans to remain in her position as Technical Services Librarian at Columbia Theological Seminary in Decatur, Georgia.

### BETHEL SEMINARY OCCUPIES NEW QUARTERS IN SAN DIEGO

Bethel Theological Seminary occupied its new building in San Diego, California, in late February 1990. The 24,000-square foot facility houses a chapel, classrooms, faculty offices, and a library designed to accommodate 100,000 volumes as well as offices, a workroom, the rare book room, a typing-computer room, and study carrels. Bethel Seminary's main campus is in St. Paul, Minnesota.

## RECENT AND PROPOSED LC RULE INTERPRETATIONS

The following LC Rule Interpretations were discussed at the CONSER Operations Meeting, 5-6 April 1990. All of these LCRI's affect the cataloging of serials; many of them affect the cataloging of materials in all formats.

AACR2 1.4D2 states: "Give the name of the publisher, distributor, etc. in the shortest form in which it can be understood and identified internationally." The recent RI simplifies the task of deciding what is the "right" shortest form. It implies that the form of the name in this area of the cataloging record is not important because it is not an access point. The RI states: "Shorten the name or not, whichever is more efficient and effective in the particular case - according to judgment. Do not, however, attempt to judge how well the name is known internationally."

AACR2 1.4D4 states: "If the name of the publisher, distributor, etc. appears in a recognizable form in the title and statement of responsibility area, give it in the publication, distribution, etc., area in the shortest form. If, in such a case, the publisher, distributor, etc., is a person, give the initials and the surname of the person." The RI implies that the cataloger may shorten the name or not; because it is not an access point, the <u>form</u> does not matter. As with RI 1.4D2, it will be LC's policy that "shortening or not" is the prerogative of the cataloger and not of the reviewer or reviser. The RI is: "Apply this rule or not, whichever is more efficient and effective, according to judgment."

The RI to AACR2 2.5C2 will be changed again. In the heat of cataloging simplification last year it stated: "Describe an illustrated printed monograph as 'ill.' in all cases unless the publication consists wholly or predominantly of one of the types listed in 2.5C2." It was recently changed to add: "unless there are maps present"; i.e., if there are maps present, "maps" should be added to the "ill." statement. The RI will be changed soon to include serials: "Describe an illustrated printed monograph or serial ..." The RI continues to state that this is LC's internal policy. Other libraries may continue to describe the various types of illustrations as specified in AACR2; LC will not revise such statements in records that LC uses that were originally created by other libraries.

The RI to 12.0Bl has been revised to add the numeric and/or alphabetic, chronological, or other designation area and the publication, distribution, etc., area to those areas which use "the whole publication as the prescribed source of information." A bracket in these areas should now signify that the information is cataloger-supplied and not found "in the whole publication." On existing cataloging records, brackets should be left alone unless the cataloger has in hand the piece used for cataloging. [In recent years, the RI on prescribed sources of information for serial records has been substantially revised, clarified, and simplified; those who catalog serials infrequently will benefit from reviewing it.]

LC began implementing RI 21.30L before it was published: "Trace all analyzed series established after August 31, 1989. For series established before September 1, 1989, do not change decisions calling for no tracing."

RI 24.2 is an attempt to eliminate the proliferation of authorized forms of corporate names: "In the absence of explicit evidence that a true name change has taken place, consider that different usages found in

publications are variants of one another, rather than true name changes whenever the difference is a minor one ..."

The "Note" in LCRI 12.0A will be changed to "loosen up" LC's definition of a serial by extending the source of a numeric or chronological designation to informal statements found in the text and to publication (but not copyright) dates: "The designation is taken from a prominent source or formal statement, since the designation is the means by which serial issues are identified and recorded upon receipt. If, however, there is no designation appearing prominently or in a formal statement, and if other indicationa are that the title is a serial, a designation may be taken from an informal statement (e.g., in the text of the preface). Do not consider for serial treatment a publication that carries only a copyright date even if it is issued regularly and intended to continue indefinitely. The copyright date does not constitute a chronological designation." RI 12.3Cl will be revised also to reflect this change.

It is being proposed to add to RI 12.1E1 the possibility of adding subtitles "whenever the cataloger determines that this information is useful for the identification of the serial" to the 245/title-field in serial records. Examples of subtitles that could be added are: "Eagles; newsletter of Americana at auction" and "Dance around the Bay: a directory of San Francisco Bay area dance & related resources." Not using subtitles in serial records is still preferred (one should never use a subtitle such as "an international journal"), but this change to the RI will allow for helpful subtitles to be included.

RI 12.5B2 will be added to give guidance in counting the number of volumes when a title has ceased publication. It instructs that volumes be counted as "bibliographic units as opposed to physical units." These examples will be given in the RI:

- a) 362: 1960-1984; 310: Annual; 515: Each edition issued in 2 vols.; 515: Vol. for 1981 not published; 300: 4 v
- b) 362: Vol. 1, no. 1 (Jan. 1986)-v. 2, no. 3 (Mar. 1987); 300: 2 v.
- c) 362: No. 1-22; 300: 22 v.
- d) 362: No. 1-12; 515: No. 8/9 issued in combined form; 300: 12 v.
- e) 362: Vol. 1-v. 142; 515: Vols. 89 and 92 not published; 300: 140 v.
- f) 362: Jan. 1987-May 1988; 300: 2 v.
- g) 362: Jan./Feb. 1985-Nov./Dec. 1985; 300: 1 v.

AACR2 21.1B4 provides for entry under a subordinate unit. Added to the RI which states "Do not apply this rule to serials" will be the instruction that "Application of this LCRI should in no way affect the transcription of a subordinate body in a statement of responsibility (see 12.1F1). Access may be given to the subordinate body according to 21.30E1."

# VANCOUVER SCHOOL OF THEOLOGY LIBRARY OPENS NEW STACK ADDITION

After several years of planning and fund raising, the Vancouver School of Theology in Vancouver, British Columbia, officially opened its \$825,000 stack extension last November. Originally designed to double the capacity of the existing book stacks, the final plan actually added seventy percent capacity in order to allow full wheelchair access. Study alcoves have been included, the circulation area has been enlarged and opened up and a periodicals display and browsing lounge area provided. Central to this area is a table made from a slab of the huge Douglas Fir tree which had to be felled to make the extension possible. For the Library staff, a major part of the expansion project was the physical move and assimilation of 30,000 volumes which for many years had been in storage in the top of the tower (no elevator access) of the nearby old Union College building. Elizabeth Hart is the Librarian.

# CHICAGO AREA THEOLOGICAL LIBRARY ASSOCIATION MEETS

On April 20, 1990, members of the Chicago Area Theological Library Association gathered in Chicago for a meeting hosted by the librarians of the Norman and Helen Asher Library at Spertus College of Judaica. Members were welcomes by out-going CATLA President Eileen Saner, Associated Mennonite Biblical Seminaries, and by Asher Library Director Michael Terry.

The guest speaker for the morning program was William C. Miller, Director of the Library, Nazarene Theological Seminary, Kansas City, Missouri. Dr. Miller presented an overview of the proposed ATLA reorganization plan. He concisely compared the current governance structure with the proposed structure; discussed the time frame in which the changes would be effected, if the reorganization is approved by the ATLA membership at the annual meeting in June; and answered questions.

Elvire Hilgert, retiring this year after a notable library career in reference and cataloging at Jesuit-Krauss-McCormick Library, Chicago, presented the afternoon program. In her talk, "Will It Play in Peoria?" Ms. Hilgert reflected on the relation of cataloging to reference work. She spoke in practical terms about the need for better subject access and about the prohibitive expense of enhancing cooperatively cataloged records to meet local needs. She also shared her vision of the ideal user environment, which would provide subject access to the point of redundancy, abstracts - even ILL information. Following her presentation, a resolution was made to thank and commend Ms. Hilgert for her long and distinguished service to theological librarianship.

In addition to the two presentations, CATLA members were able to enjoy the special facilities of Spertus College. Library tours were offered, as well as tours of the Spertus Museum of Judaica.

The Chicago Area Theological Library Association meets semi-annually, and it includes members from Illinois, Indiana, Iowa, Michigan, and Wisconsin. The Fall 1990 meeting will be at Marquette University in Milwaukee; the topic will be copyright law and its implications for theological libraries. CATLA officers for the next year are President, Alan Krieger, Hesburgh Library, University of Notre Dame; Vice President/President-elect, Norma Goertzen, Mellander Library, North Park College and Theological Seminary; Secretary, Susan Sponberg, ATLA Preservation Project; Treasurer, Eugene Fieg, The Seminary Library, Bethany/Northern Baptist Theological Seminaries.
