The Value of ATLA



There was a new report released last week by ACRL, The Value of Academic Libraries (http://www.acrl.ala.org/value/). The report presents multiple assessment perspectives for librarians to adapt for local use. The report "strives to help librarians understand, based on professional literature, the current answer to the question, 'How does the library advance the missions of the institution?'" (p.11)

Those of you who have been involved in an ATS accreditation recently have likely been steeped in a local conversation about assessment, accountability, and valuethat of your library and your school.

The ATLA Board of Directors has been wrapped in this conversation as well. By revising our Organizational Ends (http://www.atla.com/about.html#mission_and_ends), the board strove to (re)articulate the value ATLA brings when it is most effective. And our fundamental Organizational End (called the "Global End") is itself a statement about value:

ATLA exists so that:

Libraries and librarians are effective and valued partners in the academic study of religion, theology and ministry.

As we search for a new Executive Director, we are looking for a person who will continue the existing work and develop new initiatives to achieve that objective. ATLA strives to help its members not only demonstrate our contribution, but also articulate our value so that we can be understood as effective partners and recognized appropriately for it. Each October, Theological Libraries Month is just one mechanism for that demonstration and one outlet for that message. I wish you well in your local celebrations!

World Enough and Time

Time is the only evenly distributed asset in academic life. In research that I've been doing with seminary students, a theme that has gotten my attention is the sheer limitation of twenty-four hours per day, seven days per week. Students report, for instance, that they stop looking for information when they run out of time. In some cases, it is

the professor's deadline that pushes them to sit down at the computer and create sentences. Time with children limits time spent reading. No three bonus hours a day for seminarians.

I recently re-read an essay by theologian Bonnie McLemore-Miller, who lamented that time constantly presses her as a faculty member. She uses time to read, to think, to teach. She also needs time to be a parent and spouse. For all of our talk about working smarter, it is simply not possible to sleep faster (because that doesn't work) or listen to our spouse faster (because that really doesn't work).

Our profession seeks, in part, to save library users valuable time by connecting resources to students and faculty as quickly as possible. The time that one cataloger spends cataloging a book well saves time for dozens of users. Pointing students in the direction of high quality sources encourages them to spend time with authors and arguments that matter. And yet: no three bonus hours a day for theological librarians.

And now the preachy part: What would charting your use of professional time for two weeks tell you about yourself?

The American Library Association Publishing Committee provides a grant of up to \$5,000 for the preparation of print or electronic reading lists, indexes or other guides to library resources that promote reading or the use of library resources at any type of library.

Funded projects have ranged from popular, general-reader proposals such as "ReadMOre," a reading list for Missouri's state-wide reading program, to more specialized, scholarly proposals such as "Librarianship and Information Science in the Islamic World, 1966-1999: An Annotated Bibliography." Applications must be received by Nov. 5, 2010. Recipients will be notified by the end of Feb. 2011.
