#### **On Reading and Re-reading**

So if your reading pattern is in a rut, I encourage you to try something new. Unless, of course, what you really need is to get back to a known path and reconnect with a favorite text. In that case, go get in a rut and stick with it!

### **Changes at PTS**

Betsy Soans and Kate Skrebutenas of Princeton Theological Library's Interlibrary Loan Department sent out an alert about how the razing and rebuilding of Speer Library will affect their operations for the next 26-30 months: "At this point, we do not know the time it will take between request and receipt of an item from the storage facility. We will ask borrowing libraries to use our symbol, PTS, twice in a WorldCat ILL form. This will allow up to nine days for us to retrieve off-site material and then ship it to you. With most of our collection either on-site or in retrievable storage, we do not expect a sizable increase in the number of interlibrary requests from our patrons. We intend PTS to remain a faithful interlibrary loan partner. Please be patient with us as we learn to work in our changing environment."

## Genre/Form Project Update

In July 2008, the Library of Congress (LC) Acquisitions and Bibliographic Access (ABA) management team approved five new genre/form projects to be undertaken by the Policy and Standards Division (which was then called the Cataloging Policy and Support Office): cartography, law, literature, music, and religion. In addition, LC identified ATLA as the organization through which comments on the religion terms would be centralized.

ATLA is pleased to collaborate with the LC on the Religion Genre/Form Project which kicked off at the ATLA Annual Conference in June 2010. ATLA staff are coordinating the discussion and responses. They are seeking input from all catalogers interested in religion and are working closely with the Catholic Library Association and Association of Jewish Libraries.

He has also been an important supporter of the New York Area Theological Library Association (NYATLA), including service on its Steering Committee.

An avid musician and former member of the Executive Board

of the New York City Chapter of the American Guild of Organists, Seth is well known among theological librarians for his years of gifted leadership as conductor of the ATLA choir. As choir member James Dunkly observes, "Seth's own deep love of music, especially choral music from many traditions and periods, has for over a quarter of a century drawn dozens of others into offering anthems and hymns, psalmody and organ music and chant, at annual conference, where the whole group is invited into the focused reflection he elicits from the singers he leads."
