A LETTER FROM PRESIDENT DALY

Dear ATLA Members:

The transition from Paul Hamm's presidency has gone smoothly. I can saure you that Paul was most cooperative and did everything he could to make this transition with as little loss of continuity as possible.

I regret to inform you that Alva Caldwell has felt it necessary to resign as Recording Secretary. His resignation challenges us to rethink the role of Recording Secretary. The importance of minutes and proceedings are so vital to the work of the Association that I am asking the Board at the mid-winter meeting to make a special study of some alternative to the election of a Recording Secretary, who in normal circumstances is already another busy person. The demands of that work are very heavy, as you can well imagine. Professional services may be an alternative. At any rate, we are looking into other possibilities.

At the general session last summer a resolution was passed to be given to the White House Conference on Libraries and Information Service. I regret to say that that resolution was not available to me until only a short time ago. I have forwarded it to the White House Conference office. I am not sure what will be done with it there. Also, the Board on June 15th nominated possible delegates to the Conference. By the time we got to it, all official delegates had been chosen. John Trotti, however, served as an official observer on our behalf at the Conference.

The work on the program for the Denver conference in June has moved ahead well. Jerry Campbell has been most cooperative. Elsewhere in this Newsletter you will see the program that has been developed. We are particularly eager to have full participation in this joint meeting between the ATS and the ATLA. The Wednesday afternoon programs should be crucial. They address major problems and areas of concern to all of us.

A strong effort was made in planning this program to build on our strengths. We need to be informed of the work of our committees and boards. We have tried to structure them into the program so that more awareness and participation is offered to the membership. The workshops on Tuesday should make difficult choices. Many of us would want

AN UPDATE FROM PRESIDENT DALY ON THE DENVER CONFERENCE

The program is shaping up well.

On Tuesday we plan to offer four all-day workshops:

AACR 2 - and its impact on all aspects of library science;
COMCAT - a thorough discussion of the implications with some
hands-on demonstrations and guidelines for choices;
ARCHIVES IN THE LIBRARY - what to do until the archivist comes;
ATLA SERIALS PROJECT - background, proposal, current status; a
practicum for cooperative participants.

On Wednesday morning an hour-and-fifteen-minute slot has been provided for boards and committees to communicate with the membership.

Wednesday afternoon is the joint session with the Association of Theological Schools in the United States and Canada. John Dillenberger and John Trotti will be the principal speakers. After that assembly will break up in smaller groups to deal with the following topics:

- 1. Preserving disintegrating collections
- 2. National cooperative library work
- 3. Goals for small theological libraries
- 4. Interpretive services of theological libraries
- 5. Library networks and automation
- 6. Resourceing professional education
- 7. Budgeting library costs in a day of shrinking dollar values.

Thursday morning will be given to business sessions.

Thursday afternoon offers a choice of three mini-workshops:

- 1. Other ministries for theological librarians
- 2. Women studies and religion
- 3. Automated systems group.

People have been identified for all the above programs. Some topics are in much sharper focus than others at this stage. As time goes on more precise titles will be given and the areas more clearly defined. All in all, though, the conference is developing into a strong program.

JANNETTE E. NEWHALL 1898 - 1979

Jannette Elthina Newhall began life in Chester, New Hampshire, November 28, 1898, and died in Alexandria, Virginia, August 28, 1979. She will be remembered most for her years as Librarian and Professor of Research Methods at Boston University School of Theology from 1949 to 1964, where she not only had a distinguished career as a librarian but in classroom and office led literally hundreds of doctoral students through the mazes of preparing their dissertations.

Most of her life was spent in the pursuit of education as student, teacher, or librarian. She studied at Boston University where she ultimately received her Ph.D. in the field of philosophy in 1931. During the period of her education she also studied at Radcliffe and Columbia and Berlin. During much of her student life and in years to follow she was closely associated with her mentor Edgar Sheffield Brightman.

Her interest took her into wide paths of service. She was a founding member and one-time president of the American Theological Library Association. She contributed many articles to several philosophical journals. Before going to her position at Boston University in 1949, she had been Instructor in Philosophy of Religion at Wheaton College, Norton, Massachusetts; she had worked at City Library, Springfield, Massachusetts, and Newton Free Library in Newton, Massachusetts, and from 1939 to 1949 served at Andover-Harvard Theological Library, Harvard University, serving as Librarian during her last four years there.

Her interests and service were world-wide. In the spring semester of 1958 she taught at Ewha Women's University in Secul, Korea. After retirement in 1964 she went to Union Seminary in Manila, the Philippines, as Consulting Librarian and visiting Professor of the Philosophy of Religion. On her return trip she visited many seminaries in southeast Asia as consultant. In 1970 the Theological Education Fund of the World Council of Churches published her book, A Theological Library Manual, for seminaries in Africa, Asia, and Latin America.

Even though retired she refused to remain inactive. During the year 1968-69 she served as Acting Librarian of Mary Baldwin College in Staunton, Virginia, while the Librarian was away on sabbatical. She worked as consultant in several capacities in the Boston area where she maintained her residence until 1972 when she moved to the Hermitage Retirement Home in Alexandria, Virginia. Even then she remained true to her calling, for there she organized and ran a library for the home and worked in it until just a few weeks before her passing.

She will be remembered by hosts of students in the institutions where she served as brisk, thorough, loving and helping. Others will remember her for her close association with the cause of civil rights in the stormy days of Montgomery and Selma.

SOME "STANDARD" WORDS

The Fall 1979 issue of Cataloging Service Bulletin (No. 6) issued by the Processing Services of the Library of Congress provides a number of insights into the LC plans for implementing AACR 2 (i.e., Anglo-American Cataloguing Rules, Second Edition) in 1981. It also offers, for those who may not have acquired the information elsewhere, a detailed list of the "corrigenda" and "errata" for AACR 2. While some of the misprints are quire minor and fairly obvious, a few of them (e.g. the transposition of lines 2 and 8 in 1.1G2, and the omission of the proper text in 24.24B: "Enter armed forces that are controlled by governments below the national level as subheadings of the headings for such governments") are rather vital to the understanding of the rule. Subsequent printings of AACR 2 will, happily, have these adjustments included, along with some quite minor printing corrections. These latter corrections will benefit primarily those who are looking to the examples in AACR 2 as models of practice, especially in terms of spacing and punctuation.

A second feature of this Bulletin issue is its announcement of a more precise plan for using General Material Designations (GMD) for various material formats. Four categories are set forth as follows: (a) those materials for which LC will include a GMD in brackets following the title proper (filmstrip, kit, microform, motion picture, slide, sound recording, transparency, videorecording); (b) those materials not cataloged by LC but for which a GMD would be used if they were to be cataloged (chart, diorama, flash card, game, microscope slide, model, realia); (c) those which LC does not currently catalog and for which a GMD decision will only be made at such time as LC elects to catalog them (art original, picture, machine-readable data file, technical drawing); and (d) those for which LC does not intend to display a GMD even though they are cataloged (globe, map. manuscript, music, text). This decision generally follows the principle that the older and more "book like" (except for globe, of course) formats are adequately recognizable and need no GMD to identify them. The GMD's which definitely are to be used are clearly those in which the library user will, or may, require a machine to aid in the hearing or viewing of the material. Thus the function of the GMD as a sort of "distant early warning" to let users know that they will need additional equipment to profit from the material seems to be well served in this decision. The media librarians who want a thoroughly integrated and non-discriminatory catalog will, on the other hand, have to supply their own GMD's for the print materials if all items are to be treated equally.

The Bulletin then describes in a somewhat revised fashion the plans of LC to utilize AACR 2, and in particular the plans to pass over certain changes which seem to be authorized by the new rules. Three early decisions (to retain *Dept." instead of spelling out

"Department" in English-language heading forms, to use "House" instead of "House of Representatives" in "United States. Congress. House." entries, and to use "Great Britain" instead of "United Kingdom" in British governmental entries) are here reiterated, but their justification is somewhat altered. Now it is maintained, supported by the logic of choice of "conventional name," that the use of "House" and of "Great Britain" are within the spirit of AACR 2 and are thus "in accord with AACR 2, not merely compatible" (p.6). While the seasoned rule reviser may smile a bit at what seems to be rationalization for retaining earlier forms of headings, it is certainly healthier to have the reasons given as expressing the intent of the new rules rather than circumventing them. If the LC staff continues to approach the application of AACR 2 in this spirit, the results should be more in line with what the Joint Steering Committee and the various rule revision committees intended.

The next section of the Bulletin, however, specifies nineteen cases in which the provisions of AACR 2 will not be applied to name forms previously established by LC, though newly established forms will be developed according to the new rules. These categories are quite diverse and should be studied in detail by catalogers and administrators intending to implement AACR 2 either on or before January 2, 1981. One comment of interest to theological librarians is the example of a change which is to be made: Augustinus, Aurelius, Saint, Bp. of Hippo, is to become Augustine, Saint, Bishop of Hippo. Most of the retentions are, it should be noted, not ones which are likely to cause filing problems, and in many cases there may never be another material published which will occasion the use of the name as a heading in the catalog. Still, some of us who worked on the rules wonder why these could not be altered as new materials giving rise to such headings are entered into the post-1980 system.

A section on "automation changes" is interesting in that it reflects on changes to the MARC formats which AACR 2 may necessitate. These are clearly minimized in importance, and it is noted that LC will continue to place titles of honor and address (if used by the person in the person's works) after the forename (not before, as the British prefer) and that initial articles will continue to be deleted in "all parts of the record except for that portion of the bibliographic description that begins with the title proper and ends with the series area" (p.8).

The next-extensively detailed-section of the Bulletin offers "Rule Interpretations for AACR 2." It is not possible in a brief commentary to present the basic content of these very important pages; however, their impact on cataloging operations which intend to implement AACR 2 in 1981 (or before) will be major, as will the data presented in the subsequent section entitled "Revised Headings for 1981." It is doubtful that many of even the most seasoned (I almost said "hardened") catalogers will welcome the chore of working through the rule interpretations and lists of old and new heading forms. Cataloging revisers, nonetheless, are going to need to know this

information, as will those who enter records onto the various machine data bases. Further, the lists of old and new headings (which are expected to continue regularly in the Bulletins) will enable many libraries to anticipate some of the authority work needed to tool up for AACR 2.

In sum, the Library of Congress staff is to be commended for making this information available promptly and intelligibly. If libraries fail to take advantage of this service and use it wisely, they will be the poorer for their dereliction. NEW ANNUAL JOURNAL LAUNCHED

Horizons in Biblical Theology--An International Dialogue provides a forum for significant contributions which aim at overcoming the traditional separation between Old and New Testament interpretation. It offers proposals for the understanding of the essential connections between the two Testaments, advances the dialogue between representatives of the disciplines of Old and New Testament exegesis, and stimulates a theological encounter with Biblical texts and themes. This new periodical answers the calls for a contemporary Biblical Theology which have been issued over the past two decades by leading Old and New Testament scholars in several countries. It stresses, therefore, the international composition in its list of authors and it informs about the state of the dialogue in different parts of the world. It is designed to make contributions to a scholarly discussion of the task of a Biblical Theology, and it wants to assist the understanding of the Rible as a whole in the churches. Its essays are written by scholars knowledgeable in the methods of modern Biblical research, but they are put in non-technical language fully understandable to the interested clergy and to lay people.

The new journal will at first appear annually, but it is hoped that in the future issues can appear more frequently. PERIODICAL INDEXING BOARD REPORT

The ATLA Periodical Indexing Board has received formal notification that the National Endowment for the Humanities has awarded the Board a grant of \$97,922 to support publication of Religion Index Two: Multi-authored Works, 1970-75. The project is expected to take twenty-four months, ending December 30, 1981; and upon the completion and publication of this Index the Board will be providing coverage of multi-authored works from 1970 to the current year.

Later this year the Board plans to publish the index of Fest-schriften, covering the decade 1960-1969, prepared by Betty and Elmer O'Brien.

John A. Peltz resigned his position as Associate Editor and Acting Business Manager of the Index in September 1979. Jack has served with the Index in a number of capacities during the past decade. His association with the Index as an Editor began with his serving as Assistant Editor of volume 9 (1969-70) of the Index to Religious Periodical Literature and concluded with his service as Associate Editor of the Semi-Annual Edition (January-June 1979) of Religion Index One: Periodicals. Recently he had been carrying also the responsibilities that are assigned to the Business Manager's office. Jack has been associated with the Index office during a period of marked change. We have changed from a manual operation to a computer-assisted operation and from being the publisher of a single title to becoming a publisher offering a variety of services. He has contributed strongly to this development, as have many members of the Board and many full-time and part-time workers. Jack began his association with the indexing project as a graduate student working part-time for the Index. He has now come full circle because he is once again a full-time candidate for higher degrees and is continuing to serve the Index as a part-time indexer. The Periodical Indexing Board and the membership of the Association wish Jack well in his present studies.

NORMAN DESMARAIS REPORTS ON CATHOLIC PUBLICATIONS

The Catholic librarians met at the annual meeting of the American Theological Library Association, June 11-15, 1979, to discuss some of the problems they encountered with the publications of the United States Catholic Conference - National Conference of Catholic Bishops (USCC - NCCB). These included: no regular catalogs, partial fulfillment of orders, delays in mailing, and poor organization of the office. Norman Desmarais was delegated to approach the USCC - NCCB to clarify the issues and to seek solutions. Father Matt Rzeczkowski volunteered to assist. A July 9 letter brought immediate response and a meeting was set up for August 30.

Angela Ricciardelli assumed the directorship of the publications office on June 12 and has begun a revision of the entire office. The summer saw the introduction of automated equipment which eliminated a three-month backlog of orders. She is preparing an alphabetical catalog of all their publications to be mailed out this fall. This catalog will contain many annotations and will be updated every six months. It will also be updated every five weeks with a flyer promoting only new and current materials. This will replace the previous lists which had no consistent time period of mailing and which essentially served to remainder or to push over-stocked items. Since this will be the first completed catalog, errors and discrepancies are expected and will be corrected in future mailings. Ms. Ricciardelli would very much appreciate feedback and suggestions to improve their services. She also plans to attend meetings and conventions to promote their publications and to develop marketing.

Their most serious problem at present is the lack of adequate mailing records. The USCC - NGCB will try to get lists from associations like the ATLA and the Catholic Library Association. If you have orders with them, you may went to confirm them along with your address. Many publications issue from the various departments and offices of the USCC - NGCB. Some of these offices retain the rights to their publications and require that orders be placed directly to them. In the past, the publications office ignored orders sent to them for materials of other departments. Ms. Ricciardelli plans to keep a stock of these materials and to serve as a clearinghouse to broker all USCC - NCCB publications. She also plans to address the issue of consistency by making sure the names and titles on the covers of title pages agree and that the department or commission be designated the same way in all of its publications.

The USCC - NCCB formerly printed all the papal documents from the mid-1800's to the present. Many are now out-of-print and the publications office may reprint them. Plans also call for publishing the statements of the bishops and/or various committees in book form every five years. This may solve some of the cataloging and storage problems we face with loose paper brochures. The USCC - NCCB keeps a file copy of everything they publish. They welcomed our suggestion to establish regional depositories of their material and will save this for later action.
