ATLA Opens Search for New Executive Director

ATLA's Executive Director Search Committee, with the assistance of the national search firm of Tuft & Associates, has been working since early July to find Dennis Norlin's successor. The Search Committee, appointed by the ATLA Board, is comprised of: Carisse Berryhll, Abilene Christian University; Kelly Campbell, Golden Gate Baptist Theological Seminary; Pat Graham, Emory University (chair); Tammy Johnson, Columbia Theological Seminary; Andy Keck, Duke University; Chris Meinzer, Association of Theological Schools, and Laura Wood, Harvard University.

The Challenge of Transitions



As we come to the end of something we know and prepare for the beginning of something less familiar, we can struggle to find our way. The ending may seem premature or cause a sense of loss. The new beginning may seem difficult or signal that change--for better or

worse--is imminent. And in the meantime-which can be very mean!-how do we cope? How do we provide closure on the past? How do we keep things going as we prepare for the new?

Our academic calendars give us structure for times of transition. Students graduate and new ones arrive. The library, like the rest of the school, prepares accordingly. We process last term's books and reserves and as the new term approaches, we start the cycle anew.

But other transitions are less structured. They're irregular, infrequent, or unexpected. And since they present greater unknowns, we look to the things we can count on for stability.

ATLA is hiring a new executive director (ED). For many of us (myself included), we have never known ATLA without Dennis Norlin at the helm. And it is strange to imagine the changes a new ED might bring. But there are many important continuities to note, among them:

- the headquarters staff, led by interim ED Cameron Campbell, continue to develop and deliver the services and products we depend on;
- ATLA members in leadership roles continue their committee work on next year's conference and other important initiatives;
- individual and institutional members contribute to the work of the association through their daily work, their writing and presentations, and their collaborative activities, from ILL, to serials exchange, to ATLANTIS postings.

In these times of transition, knowing what we can count on to continue is important. It helps us know what to expect in the future. And ATLA's future is bright indeed.

Congratulations to the Theological Education Association of Mid-American Librarians (TEAM-A)! As your theme stated, "Where new things happen" describes exactly some of the innovative ideas and events you provided to our conference attendees.

The 2010 ATLA Annual

Conference held at the Louisville Marriott Downtown was well planned and organized, creating an excellent conference experience for all members in attendance. Once again, I was delighted to be a part of this international gathering for the premiere ecumenical library association. Our conference attracted a diverse group of librarians who hailed from around the world. TEAM-A did a great job utilizing social media as an additional form of conference communication, trying an alternative to our banquet while at the same time allowing us to continue tradition at a closing reception. Volunteers at the Local Host Table ably filled in all of the blanks that surfaced at the conference, providing a wealth of information to us all as they led various hosted excursions for our members' enjoyment. ATLA's annual conference attracted 350 members, exhibitors, and guests--which is an increase over last year's attendance.

For 2010, we had 39 first time attendees, 26 new members, and 4 international members; forrty-six members received travel grants. We experienced the attention to detail, the knowledge imparted, and the enthusiasm displayed by the highly regarded presenters, exhibitors, and staff that played a very important role in the execution of the annual conference. All of the interest groups, panels, papers, and roundtables were well attended. In fact some sessions were viewed as "mini plenaries" due to the high attendance by

June 17, 2010

The Business meeting was convened by Board President David Stewart at 1:00pm, Thursday, June 17, 2010.

Eileen Crawford presented the Secretary's report. Members of the Teller's Committee were Joan Blocher, Jill Brown (chair), and Betsy Grant. They received the election results via e-mail from Survey & Ballot Systems and verified that 315 valid ballots were received. The membership elected Andrew Keck, Saundra Lipton, Blake Walter, and John B. Weaver to the Board of Directors for the 2010-2013 term of office. The Secretary's report was accepted.

President Stewart introduced the new Board officers: Carrie Hackney (Secretary), Eileen Crawford (Vice President), and Laura Wood (President).

President Stewart recognized the outgoing Board members, Cheryl Adams, Duane Harbin, Jim Pakala, and Roberta Schaafsma and presented them with gifts.

Vice President Schaafsma briefly explained the six categories for membership outlined in the by-laws and proposed Pradeep Gamadia as a Board nominee for lifetime membership subject to a (2/3) vote from the membership. A motion to accept this nomination was made from the floor by Roger Loyd and seconded by Bill Hook. The motion was carried in a vote by a majority of ayes.

Organization Ends progress

President Stewart reported that the former Ends of the association had been written ten years ago when the Board first adopted the Policy Governance Model of governance. The Ends define the association and have been a focus of the Boards work this past couple of year as they have prepared for selecting a new Executive Director. The Board formed a Governance Committee and has sent two members to a Carver Policy Governance Workshop for the past three years.

Update on Executive Director Succession Planning

President Stewart outlined the work that had been accomplished to prepare for succession. A search firm has been hired and a timetable established to guide the work of the search firm and search committee. An appointment is expected by December 2010.

Board of Directors Meetings

The Board's deliberations included a discussion of the opportunities and challenges as the Board prepares to govern with a new Executive Director; a meeting with two representatives from Tuft Associates, the search firm that has been employed to conduct the Executive Director search; a meeting with the Directors on reporting, strategic planning, and transition issues during the months of the search process. Cameron Campbell was appointed as the Interim Director. The following reports were received: Policy Governance Committee on the Board member orientation, Oral History Project update, Policy Manual revision progress report, Endowment Committee. The Board engaged in a review of the conference with the Education and Annual Conference Committees. The January Board meeting was set for January 13-15, 2011 at ATLA Headquarters.

Report of the 12th Somewhat Annual Excursion of the ATLA Birding Passion Group

"I'd love to join . . . [the] group if you welcome the novice who can name few birds beyond the robin and red-winged blackbird and simply enjoys the sound of birds." So read one of the responses to my posting on ATLANTIS of our invitation to this year's ATLA birding excursion. This was a first: only seasoned birders had responded to previous years' invitations. "Of course," I wrote back, "we'd be more than happy to include you. Can you scrounge a pair of binoculars for the occasion?" By the end of April I'd received five such requests!

A few days before, I'd Googled "birding Louisville" and found the website for the Beckham Bird Club. I e-mailed the club's contact person, describing our group (which now numbered eight, double the attendance of our last excursion), the species we'd like to see, and the mornings we'd likely be free during the conference. I then asked if any local birders would be willing to pick us up at the hotel, take us on a guided tour of a Louisville-area birding hotspot, and then return us to the hotel. Sounds a bit presumptuous, doesn't it? But birders do this sort of thing all the time. Implicit in the request is "If you're ever in Calgary, I'd be glad to return the favor."

My contact, Carol Besse, put me in touch with Barbara Woerner; and a couple of e-mails later we'd arranged for her to pick us up on Friday 18 June at 5:30 a.m. and return us by about 10:30. That morning, after some brief introductions, we piled ourselves into Barbara's SUV and Armin Siedlecki's rental vehicle and drove about 30 minutes south to the Jefferson Memorial Forest. Carol met us in the parking lot. She, Barbara, and I managed to find enough spare binoculars to outfit

everyone. Then came a quick lesson in sighting in binoculars (getting the basic focus right). Next, Carol and Barbara showed the group how to bring their binoculars into position without taking their eyes off the target bird and how to describe the location of a spotted bird according to the hours on a clock face.

"Peter, Peter, Peter" called a small bird from one of the large deciduous trees bordering the parking lot. "Tufted Titmouse at ten o'clock!" someone called out, and all binoculars were up and aiming at the top left corner of the tree. The titmouse was the first of 45 species we saw or heard that morning.

Barbara then led us across the road to a small rocky creek and played a recording of the song of the Louisiana Waterthrush. Armin couldn't resist supplementing it with one from his I-Phone birding app. "There it is on the rocks in the creek bed just beyond that fallen branch!" called Barbara under her breath, "and listen to its call. Hear it? Sounds like two marbles being struck together." Once almost everybody had seen the bird we set off up a tree-lined road. . . .

"Hear that?" called Carol. It sounded like a robin with a sore throat. "Scarlet Tanager!" The bird came closer, but it was hidden among the dense foliage in the tree tops. Barbara played its song. "There it is on that bare branch!" And all of the experienced birders clustered around the novices to make sure they got a look at the black wings against the scarlet body. Actually, we didn't have to bother, because the newbies were already glued to it. A few hundred meters farther on, a Summer Tanager vocalized. "Sounds like there's more than

one; I see the female!" said someone, "and, look, there's a nest!" Barbara shouted. And sure enough, the drab green mother and pale red father were taking turns bringing food to a nestling whose head we could see poking up above the rim.

We then heard in the distance a slow, heavy drumming that petered out towards the end. "Pileated Woodpecker," I said; and a couple of minutes later a pair of these crow-sized woodpeckers alit on a dead tree and hopped their way up the trunk, their red crests and white zig-zag facial stripe contrasting with their black bodies. Always an impressive bird.

A Pine Warbler sang and, to my considerable relief, perched cooperatively on a bare branch. I'd been concerned that the beginning birders would simply find warblers, with their constant flitting, too frustrating a target. Next up was a Red-bellied Woodpecker that kept bringing billfuls of food to a nest hole in a dead stump. We made our way past the stump to the shore of a pond where Carol spotted a Green Heron poised on a dead branch overlooking the water. Meanwhile, a family of three robin-size Brown Thrashers was foraging on the road in front of us. Unfortunately, we didn't get to hear their goofy repetitious song. A Great Crested Flycatcher appeared briefly on the top of some nearby trees, but we managed only brief views of its brilliant yellow belly and erect crest.

"There's a good place for Wormeating Warbler just up the hill," said Barbara. This was my only chance for something approaching a "life bird": I've heard Worm-eating Warblers, but have yet to see one. As we

climbed the hill we began to hear a dry trill--"That's our bird," said Barbara. We emerged just above where the bird had been calling, and Barbara began playing a recording of its song to lure it closer. "I'm on it!" whispered Carol. "Me, too," said Eric and Karla, but the bird dropped down into the undergrowth before any of the rest of us could get even a glimpse of it. Oh well, maybe one day on the Texas coast in April. . . .

We made our way back to the parking lot, where most of us got to see a Yellow-throated Warbler that was singing on a high branch. At that point, three of our party decided to head back to take in the 10:30 conference session, so we took a quick group photo. Those of us who remained drove with Carol and Barbara to a different part of the forest that included some open grassy areas. Here we heard the bouncing-ping-pong-ball-like song of the Field Sparrow, saw a male Eastern Bluebird perched on a wire, and flushed a striking black and rust-colored Eastern Towhee that not only gave its characteristic "drink-your-tea" vocalization but said its name (the "towhee" part, that is).

But our main quarry here was the state's namesake bird: How could we say we'd birded the Louisville area without seeing a Kentucky Warbler? We made our way to a ravine, where we heard its rapid "pretty, pretty, pretty" in the distance. On came the recording. Something dived into a tangle of vines in front of us and then dropped out of sight. A second bird began calling across the ravine. Then nothing. I restrained myself from bursting into a chorus of "Kentucky Warbler, he shines in his own kind of light. . . ." And a good thing, too, because right then the bird burst out of the thicket-showing its yellow head and breast and black mask as it

made for a bare branch just above us. Everyone saw it. Then a cuckoo called: Blackbilled or Yellow-billed? We couldn't be sure; but birding wouldn't be birding without a little mystery.

Professional Development Committee



You have probably heard the one about the minister who was so heavenly-minded that he was no earthly good. Or the professor who knew everything about nineteenth-century narrow gauge Welsh railways but couldn't keep track of his house key. To make our way in the world, we need to attend

both to the big and the small.

As theological librarians, we may be most energized by the daily challenges of our jobs. We successfully locate a copy of a hard-to-find article for a faculty member. We notice that Michael Bratman's 1987 book on intention stands in the tradition of analytical philosophy, and so perhaps should not be classed to nestle near psychological studies of planning. We teach a student to navigate the Religion Database and she discovers how to search with more sophistication.

These are laudable achievements in our field, even if nobody wins a MacArthur Foundation genius award for them. At the same time, our profession also requires us to stretch beyond everyday tasks, the things that we learned in library school or taught ourselves to keep up with the latest app. Recently, Hugh Heclo's little book On Thinking Institutionally (Boulder Co: Paradigm, 2008) has caused a stir in the world of theological and higher education. Heclo contends that we should rise above our well-founded distrust of institutions so that we who work in them can make them work better. (This is a good book to read and discuss with colleagues.)

So, I commend you to develop yourself professionally, both in the specific technologies of twenty-first information science and in the micro-cultural literacy needed to take part in your school's big story of education, research, and service. Did you hear the one about the librarian who explained the role of the library in the school's mission so well that the board of trustees thought their library mattered?
